Your referral to Presidential dibraries also is nelptul and I thank you for that initiative..

Ferhaps it will help if I explain. There is a current book in which it is alleged that on AFI returning to Washington, at Andrews Air Force base, at Walter Reed and at the Mavy hospital in Bethesas there was hanky=panky with the corpse. A sort of shell game with the corpse, including cashets and ambulances, also is alleged. I believe that these and other similar allegations are without foundation, hurtful to many innocent persons and hurtful to truth. I therefore descire to obtain information pertaining to those events, the number of ambulances used, the number of caskets, when and why each was dispatched and by whom, things like these.

If there are lists of those who were on AF1 on the return from Dallas and of those who were observers when LBJ was sworn in, that also will be helpful.

I do not know whether any of the military personnel, General McHugh and enlisted men among them, filed any reports or memoranda, but they could be of value, if any.

I cannot identify all who were on the plane them.

I believe that all services, including the Coast Guard, contributed to the honor guard at the hospital.

As of now I do not desire a copy of the State Funeral Plan, but thanks for the information.
