The following information was obtained to date (7/2/64) from a file review with respect to obtaining data on four specific items of evidence listed as follows:

Item No. 116 - OSWALD's diary, obtained by search at PAINE residence.

Item No. 406 - Communist Party letter dated 7/31/63, directed to OSWALD.

Item No. 425 - Undesirable Discharge of OSWALD.

Item No. 444 (also same as D47), - Vaccination Certificate of OSWALD.

Latter three items obtained from Police Department search at 1026 N. Beckley Street, Dallas.

Serial 89-43-819. This is Dallas airtel to Bureau, 11/26/63, enclosing four rolls 35 mm film in 25 foot lengths and one roll 35 mm film which is a portion of a 100 foot length. Film made at Dallas Police Department 11/24-25/63 of papers and property of OSWALD, his wife, and Mrs. RUTH PAINE. Bureau was requested to process film and make three prints of each exposure. Dallas was to furnish one copy to Secret Service, one copy containing foreign language material was to be returned to Bureau for translation, and the third copy retained by Dallas for use of leads.

Serial 89-43-2560. This is Bureau letter to Dallas, 12/5/63, advising film developed, enlargements made, and that enlargements being forwarded Dallas under separate cover. The film was retained at Bureau pending further instructions.

Serial 100-10461-141. This is Dallas airtel to Bureau, 12/2/63, transmitting roll 35 mm film furnished Dallas Office by Dallas Police Department and is a positive copy of the film on which appears pictures of a voluminous material found by Dallas Police Department under search warrant. Laboratory was requested to furnish one set of photographs to New Orleans and three copies of each item to Dallas along with the film unless needed by Laboratory.

Serial 100-10461-1352. This is Dallas teletype to Bureau, 12/15/63, making reference to 451 items of personal effects of Subject which were delivered to Bureau 11/27/63. Bureau was requested to furnish photographs of all material to be used for lead purposes and otherwise. It was stated Dallas does not have photographs of the material as film and photographs were furnished Dallas Police Department when material was turned over to Dallas Office.

Serial 100-10461-1553a. This is Bureau airtel to Dallas, 12/18/63, enclosing two photographs of 13 items including Item 425 which is Undesirable Discharge of OSWALD. These photographs were previously requested for use of MARINA OSWALD in obtaining Social Security benefits. Both sets of photographs were furnished FORREST SORRELS, Secret Service, 12/23/63.

Serial 100-10461-1530. This is a memo from SA GEORGE T. BINNEY to SAC, Dallas, 12/19/63, revealing one set of photographs were furnished to FORREST SORRELS, U. S. Secret Service, Dallas, 12/19/63. These photographs were requested of Bureau 11/26/63.

Serial 100-10461-1930. Bureau airtel to Dallas, 12/23/63, referring to Dallas teletype of 12/15/63. Bureau advised it was assembling material from photographs of personal effects delivered to Bureau and from photographs taken by Dallas Police Department sent to Bureau by Dallas Office for developing. It was stated two copies of the latter photographs were forwarded Dallas and, according to Dallas teletype mentioned above, they were turned over to Dallas Police Department. Bureau advised by separate mail a complete set of photographs together with translations would be furnished. In addition, Bureau informed it had prepared one complete set of photographs made by Dallas Police Department which would be forwarded separately.

Serial 100-10461-1991. Bureau airtel to Dallas, 12/23/63, which enclosed a set of photographs of personal effects together with translations of the Russian documents.

Serial 100-10461-2028. Bureau letter to Dallas, 12/24/63, which makes reference to Dallas letter of 12/2/63. Bureau advised three complete sets of photographs of items received from Dallas 11/27/63 were being forwarded to Dallas. One set also is being forwarded New Orleans. In addition, Bureau furnished detailed list of items received which is a correct and actual account of the items and it has been checked

against film received from Dallas and against individual items. This list was to supersede that furnished by Dallas. In addition, the photographs to be forwarded were marked with a corresponding inventory number.

Serial 100-10461-2181. This is Bureau invoice dated 12/24/63 making referenced to Bureau letter of 12/24/63. This invoice pertains to three sets of photographs as well as three inventory lists.

Serial 100-10461-2214. Dallas teletype to Bureau, 1/3/64, pertaining to various photographs of documents in possession MARINA/OSWALD, needed to make claim with the Social Security Administration. One of these photographs was Item 425 which is Undesirable Discharge of OSWALD. It should be noted this item as well as others previously furnished to Secret Service. (Serial 100-10461-1553).

Serial 100-10461-2301. This is memo to SAC, Dallas, from SA WALLACE R. HEITMAN dated 1/4/64 indicating SA JAMES BOOKHOUT on 12/31/63 furnished to Assistant Chief CHARLES BATCHELOR, Dallas Police Department, a complete set of photographs of the items in the inventory of material which was obtained by the Dallas Police Department. It should be noted these photographs were supposed to be photographs of the first 455 items on the inventory list.

Serial 100-10461-2973. Bureau letter to Dallas, 1/23/64, (Lab letter), which enclosed three sets of 85 photographs. These photographs are of Items A1 through A85.

Serial 100-10461-2986. This is memo to SAC, Dallas, from SA JAMES W. BOOKHOUT dated 2/1/64 advising that on 1/30/64 85 photographs were delivered to Chief JESSE E. CURRY, Dallas Police Department. These are photographs of Items A1 through A85.

Serial 100-10461-6794. Memo to SAC, Dallas, from SA JAMES W. BOOKHOUT dated 6/15/64 informing that on 6/11/64 Captain J. W. FRITZ, Dallas Police Department, requested photographs of additional items which he stated his Department did not have. These items are B3 described as negatives; Item 117 (D43) which is described as notes, The Communist Party of the United States Has Betrayed Itself; Items 156, 157, and 159, which are described as three letters in Russian. Dallas Office has available for Captain FRITZ all of these items with the exception of B3 which has been requested of the Bureau. As of this date, none has been furnished to Captain FRITZ.

In addition to the above, it should be noted that on 11/25/63 a photocopy of the International Certificate of Vaccination for OSWALD was obtained from the Dallas Police Department and this item was sent to the Bureau by Dallas letter 11/25/63 (89-43-727).

Also on 11/25/63, the Dallas Police Department furnished a copy of the letter dated 7/31/63 from the Communist Party to OSWALD which is signed ARNOLD JOHNSON. This copy was furnished to the Bureau by Dallas letter 11/26/63 (Serial 89-43-718).
