On May 18, 1961, Mrs. MARIE PERNO, 1147 South
Wenomah Street, Oak Park, Illinois, advised SA
that she is the wife of JAMES PERNO and is the niece
of ANGELINE GIANCANA, the late wife of SAM GIANCANA. Mrs.
PERNO advised that she and her husband have been residing
in the GIANCANA residence since the death of GIANCANA's
wife in 1954.

She advised that SAM GIANCANA rarely comes to this residence and when he makes his appearances, they are very brief and unannounced. She stated that GIANCANA was not, at that time, in the Chicago area to her knowledge and was not aware of his whereabouts.

- b7She was asked to contact GIANCANA and to advise him that SA was desirous of interviewing him.
  - On May 19, 1961, ANTHONY V. CHAMPAGNE, Attorney,
    1 North La Salle Street, Chicago, Illinois, telephonically
    advised SAMME that his client, SAM GIANCANA, had contacted
    him and advised him to relate a message to SAMME to the
    effect that he, GIANCANA, did not desire to be interviewed
    on any matter. Hr. CHAMPAGNE said that he did not feel
    that it was within his purview to attempt to persuade
    GIANCANA to make himself available for an interview.
- at which time advised that GIANCANA would neither confirm nor deny that he was closely associated with GIANCANA and that GIANCANA utilized him as a chauffeur.
