Two negatives pleasures are in today's mail: a copy of Huie's sanctimonious horseshit and the Councillor approval of Sprague's computershit. To Dick's apt comment of the Sprague attitude, Howard, I would add one thing: a total incapacity to learn anything at all from countless such experiences, each some kind of disaster, and the ultimate, major one. I have complete agreement with that on which I do not comment. Advice to Howard on what to include in his book is good, save for two things, both of which I've discussed with him in the past. Dear Howard/Harold:

I have little to send you with this letter except comments on your correspondence

399 base-- Nichols: I received Nichols' 399-base photo from Harold, and will have it copied as he instructed. I agree with Harold that no differences appear between this and Harold's photo. I'll have to look at the photo more carefully, and may comment further later.

CC-buckshot: I disagree with Howard that this case provides a "good analogy" with JFK case. In fact I think it a poor analogy--no analogy at all, really. The reason is that the CC alleges that a bullet exited JFK's throat at a velocity of about 2000 fps. CC-buck does not have near that, even as initial velocity. It is likely that a bullet exiting at 2000 fps. will produce a wound visibly different from an entrance wound. It is equally likely that a CC-buck exiting will produce a wound very similar to wound of entrance, at least in that it will be small and round. Eyeball examination may not detect the important differences.

Document. Addendum: I'll send this later by separate mail. It is not too heavy.

Dum-dums: The "A" scratched into the nose of the so-called Walker bullet is probably an identification mark placed there by ~~the~~ a cop who received the bullet. ~~This is the~~ The bullet nose is the normal place for making such marks.
