## Panther Party Declared Not Object of U.S. Probe

The White House said yesterday that Justice Department attorneys are investigating some individual members of the militant Black Panther organization in San Francisco, but that the organization itself is not the object of the federal probe.

There were some reports of a widespread investigation of the Black Panther Party which is headquartered at Berkeley, Calif. but White House Press Secretary Ronald L. Ziegler said the investigation is only directed at individuals suspected of making threats on the President's life, crossing state lines to incite to riot and other such offenses. He said some of the individuals happened to be Black Panther members.

In San Francisco Tuesday, Black Panther chief of staff David Hilliard pleaded innocent to charges of threatening the life of President Nixon during an antiwar rally Nov. 15.

Hilliard, 27, in a speech before 100,000 persons at Golden Gate Park, said, "We will kill Mr. Nixon." The defense maintains the statement was mere rhetoric, "language of the ghetto."

Paul Halvonik, an attorney for the American Civil Liberties Union, said the ACLU was supporting Hilliard.

"The U.S. Supreme Court was held that political hyperbole, even when the talk is about the President's life, is protected by the First Amendment," Halvonik said.
