Claude Souvier, W, 32, 72 Dunstable Road, Westford, Mass.

Patn. D. McCallister and L. Bullock report receiving a Signal 1037 at the Woodstock Hotel, Room 1037, on 1:20 PM, 2-27-39.

An arrival call came from Tom Macomber, employed as call board at house office, and Alan Bentley, victim, and learned from Macomber that at about 12:45, he received a complaint of a disturbance on the 10th floor and was on his way to investigate the complaint when he was pushed aside by a subject running down the hallway and he observed that the subject was covered with blood and at the same time heard a man calling, "Help! Help! Murder, murder." Macomber then went in pursuit of the fleeing subject and caught him at the elevator by drawing his service revolver and calling to the subject to stop or he would shoot. The officers then learned that the accused had been identified as Claude Souvier, W, age 34.

The officers then examined the victim, Alan Bentley, who was bleeding from the head and chest and his ribs were hurting. Pat. Bullock then observed a bloody hospital mattress.

While waiting for the ambulance the officers questioned the victim who stated that he and a friend had come to the Woodstock Hotel for a few drinks and there they saw the accused and they began talking about law books and the victim recalled that he was staying at the Woodstock Hotel. He stated that the accused told him that he was staying in a hotel and had never seen the inside of the Woodstock Hotel and the victim then invited the accused to accompany him to the hotel. When arriving at the hotel they went to the victim's room and as the victim took off his coat and was hanging it up, the accused hit him over the head with a beer bottle for no reason at all then beat him about the head and body and told him to give him all his money and not to call the police. The victim stated he refused to give the accused his money and tried to call the police but the accused pulled the phone out of the wall. The victim stated he then ran into the hall and to the elevators and was knocking on the doors yelling for help. The victim told officers that he wanted the accused arrested and that he would make a statement about the attack. At about 1:30 the ambulance arrived and the victim was carried to County Hospital.

The officers then questioned Claude Souvier, accused, who stated he got the victim, Alan Bentley, to a bar in the hotel. Souvier got the beer which was in a room as he was not familiar with the French bar. He stated that he was low on funds and that the victim asked him up to his room for a few drinks. When asked why he accepted the invitation he stated he wanted to get food and drinks. When asked why he had hit the victim with a beer bottle and why he had beaten the beer bottle from, he stated he thought the beer bottle with him from the bar and that the victim told him to get the bottle at home while he got some glasses from the bar. He stated he was on the end of the hallway when the victim

came out the bathroom he was empty handed and he came over to the bed and sat down beside him and pushed him down on the bed and grabbed his private and tried to kiss him and he pushed the accused and hit him with the beer bottle because he got frightened. When asked why he pulled the phone out the wall he stated he was scared the victim would call the police. He stated the victim began yelling and screaming and he got scared and ran out the room and as he ran past a man in the hall who ordered him to stop. He stated he later learned that this man was the hotel house officer.

Alan Bouvier was placed under arrest and conveyed to the 1st District Station where he was questioned further and stated that he was a run-away from home and did not enlist for the draft when he turned 18 on 12-10-64 and that he had only two dollars which he had drunk up earlier that night and that he had someone else's drivers licence on his person in the name of Douglas Smith. He refused to make a written statement. He was then booked in this district with RSA:27(30).

The officers then proceeded to Charity Hospital to check on the victim and when arriving there learned that the victim had gone to the Touro Infirmary Hospital. The officers then spoke to Dr. J. R. Armstrong, Charity Hospital, who examined the victim, who told officers that the victim had a laceration of the forehead, back of the left ear, and of the scalp and possible broken ribs.

The officers then proceeded to the Touro Infirmary where they met Dr. David Aken who was examining the x-ray's of the victim and Dr. Aken told officers that the victim's ribs, #8 and #9, were broken.

The officers then spoke to the victim who suddenly became very uncooperative and indifferent. The officers asked the victim if he would allow them to get pictures of his face and he refused. The victim was then given the names of the investigating officers and how to contact them and asked him to contact these officers when he was able to make a written statement.

The victim's hotel room was photographed by B of I Tech. Sheen.

Brief Summary of Arrest, Additional Charges, Remarks, Etc.

Patn DmcCallum and L Bullock report receiving a signal 103F (A Fight) at the Roosevelt Hotel Room 1035. Upon arriving on the scene the officers were meet by the house officer who said that he had to run down the arrested sbject, which refuse to halt, The house officer (Dan Forestier) said that he had to pull his gun to make the arrested subject stop. The arrested subject stoped at the elevator. After talking with the house officer the officers then spoke with the victim, who stated that he had meet the arrested subject at a bar unbeknown to him at the time, Later learn to be Dixies Bar of muise, 701 Bourbon. The victim said that he meet the arrested subject through some frinds of his, and that they had few drink and that he then asked the subject up to his room for afew drinks. The victim saidthen he and the arrested subject enter the room, at which time the arrested subject hit him in the head with abeer bottle and kxi beat him severley about the head and body. The victim then ran out into the hall way yelling "help Help Murder".
