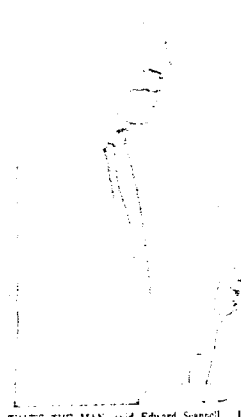

Oswald's Trouble-Filled N.O. Stay Recalled

By LEO MURAN — Brown-haired Lee Harvey Oswald, now accused of murdering President Kennedy, spent a trouble-filled summer in New Orleans this year. The leader of a Cuban anti-Castro group says Oswald tried to infiltrate his organization.

Only days later, Oswald and three Cubans — including the anti-Castro leader, Carlos Bringuier — scuffled after Oswald had been handed out "Fair Play for Cuba" literature. The scuffle got the late, 31-year-old Oswald a 30-day stay in Municipal Court.

And at home, a one-room apartment at 497 Magnolia, where he lived with his Russian wife, was in trouble with the landlord. His pro-Castro views were sharply challenged in a feud with Bringuier and Ed Bringer, executive vice-president of the Information Council of the Americas.

Oswald was born in New Orleans, shortly after his father had died. His mother, who had moved to Texas. According to Bringer, Oswald said he finished high school here. The English, Mrs. J. J. 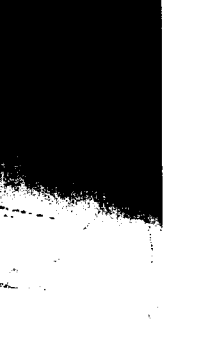
