On 11/3/75, victim furnished copy of extortion letter to interviewing agents. Letter reads as follows:

"MAE, you are thinking yourself in a circle of madness. CHARLES MANSON has been 28 years in Prison and all that B.S. you are running is only a reflection of what the news and books have programmed your soul's mind brain to.

You are looking for attention. It seems as if you are looking for your death wish in the Family.

/s/ SANDRA GOOD"

Victim also pointed out that she has received three telephone calls from unknown persons, one of which was threatening in nature. During the telephone call in question, unidentified caller stated "You had better start growing a vegetable garden or you won't be around long."

For the information of the Bureau, victim is a resident of Carmel Valley, California, who is self-employed as a public speaker, author, columnist, and occasionally heads up a local sensationalistic radio program. The dominant theme in all of the victim's public communications centers around her belief that Federal agencies, notably FBI and CIA, are engaged in a massive conspiracy. She believes that all parties to the conspiracy have been instrumental in carrying out the following events: The JOHN KENNEDY and ROBERT KENNEDY assassinations; MARTIN LUTHER KING assassination; PATRICIA HEARST kidnapping; MANSON Gang murders; and, formation of the SLA. She believes that the FBI and CIA have planted "agent provocators" to carry out the aforementioned activities.

The foregoing information was furnished to Assistant United States Attorney F. STEELE LANGFORD, who stated that the contents of the extortion letter did not amount to a threat. In view of the foregoing, no additional investigation will be conducted by the San Francisco Division. Victim was advised to change her telephone number to an unlisted number and to immediately contact the FBI upon receipt of any additional such communications.

If your Bureau has "No MATCH" that the Fingerprint: Hughes and your Identification Division are identical to fingerprints taken of a dead body April 5, 1968, then you answered every question in my letter.

Who was present when the fingerprints were taken from the FBI?

Who witnessed the taking of the prints?

Who made the comparisons in Washington, D.C.?

Who was present to confirm the prints?

What date was the Air Pilot license, exact date, that you compared it to?

These are simple answers.

The names of FBI agent Latona, James Hosty, and other FBI men will be part of US history as the JFK assassination unravels.

The Hughes story is larger, and is an FBI matter..because if was kidnapped, if he was kept drugged, then killed, or another man killed in his place, that is your division and you are passing the buck.

If that was Hughes, there would be no secrets.

If Oswald had killed JFK, there would be no secrets, and years of research.

Remember, you were appointed by Richard Nixon, who played around the law in his own hands. Did he put you there to hide, a la Watergate, or are you going to name those agents, your employees, who MADE THE INSTANT IDENTIFICATION?

They are not secret CIA agents. You can give them names, and stand by their names, when it turns out that body buried April 5, 1968 was NOT HOWARD HUGHES. Please answer my letters without going in circles.

Dear Ms. Brussell:

In reply to your letter of April 9th, a comparison made by officials of this Bureau indicates there is no doubt that the fingerprints turned over to the FBI are identical to those previously on file in our Identification Division of Howard Hughes. Further details regarding Mr. Hughes' death and the attending physician should be obtained from the hospital to which he was taken and the coroner responsible for certifying his death.

The FBI's scope of investigative authority does not extend beyond the confines of the United States and its possessions and at no time do we prosecute anyone. Prosecutive action for violations of Federal law is the responsibility of the United States Attorney.

Referenced communications set forth information relating to Mrs. May Magnin Brussell of Carmel, California. Due to the fact Mrs. Brussell has been in contact with James Garrison at New Orleans and has made public comments concerning the assassination investigation, Dallas and San Francisco are to immediately incorporate the information received concerning her into an appropriate letterhead memoranda suitable for dissemination both to the Department and U. S. Secret Service.

Copies of the memoranda are to be furnished to the New Orleans Office for dissemination to U. S. Secret Service locally and U. S. Secret Service at both Dallas and San Francisco are also to receive appropriate copies.

This matter is to be handled immediately, and replies are to be marked for the attention of the General Investigative Division.

NOTE:

On 9/15/67 at 6:45 p. m., a reservation agent at Delta Airlines, Dallas, received a call that a bomb was on board Delta Airlines, Flight 827. Flight 827 originated at Atlanta and was enroute to San Francisco via Dallas. A search of the aircraft failed to locate any bomb.

Mrs. May Magnin Brussell who was boarding this flight for San Francisco made comments at Love Field, Dallas, she had conducted research on the Kennedy assassination and had been in conference with DA Jim Garrison, New Orleans, for three days. San Francisco determined that Mrs. Brussell in the past had expressed great alarm over the fact that the United States is becoming fascist. She is the daughter of Rabbi Edgar F. Magnin of Los Angeles. It has been reported Mrs. Brussell has "left-wing" leanings and is not in good favor with her father. She supports Mark Lane's book, "Rush to Judgement" and takes the view Lee Harvey Oswald was not a communist. She pictures America as controlled by conspirators in the Government which view she has stated publicly. She is writing a book on the assassination and claims the Government is withholding information on the assassination and the press is suppressing news on the investigation being conducted by New Orleans DA James Garrison. Mrs. Brussell is described as an author and a playwright, and due to her thinking which she has expressed publicly, Dallas and San Francisco are to incorporate information into letterhead memoranda suitable for dissemination to the Department and U. S. Secret Service.

MAGNIN was out of town and not expected to return for several weeks. MAY MAGNIN BRUSSELL, MAGNIN's daughter, and her husband, "BILLY" BRUSSELL, were then living in Carmel, California, and had telephone number 624-9103, [REDACTED] advised.

On February 10, 1966, [REDACTED] determined from the Traffic Division, Los Angeles Police Department, that there was no record identifiable with MAY MAGNIN BRUSSELL.

On February 11, 1966, [REDACTED] was advised by [REDACTED], Identification Division, Los Angeles Sheriff's Office, and [REDACTED] Identification Division, Los Angeles Police Department, that their respective files contained no information identifiable with MAY MAGNIN BRUSSELL.

On February 11, 1966, [REDACTED] Retail Merchants Credit Association, Los Angeles, advised [REDACTED] that her files contained no record identifiable with MAY MAGNIN BRUSSELL.

Records of the Monterey County Sheriff's Office Substation, Monterey, California, which covers Carmel Valley, California, were reviewed on April 12, 1966, and no information could be identified with BRUSSELL.

Records of the Credit Bureau of the Monterey Peninsula, Monterey, California, which also covers Carmel Valley, reviewed April 12, 1966, [REDACTED], indicated that BRUSSELL was the wife of ALLEN W. BRUSSELL, that they formerly resided at 209 Loring, Los Angeles, California, where he was self-employed operating two men's clothing stores known as Brussell's of Beverly Hills and Los Angeles. These records contained nothing of an unfavorable nature. E. H. 11
