Dear Mae.

Your letter of the 11th was delayed reaching me because you sent it to the printed address on these second-hand envelopes I am using up. Our finances remain so precarious I must practice these petty economies. The envelope was used by a friend who operated that business at that address. He now operates another business, hence has no use for those envelopes. However, the letter did reach him promptly. He phoned me to tell me when he got it. I could not leave for it because my wife had a bad fall from which she is recovering well, but until two days ago could not walk without crutches, and my friend has been working away fromhome until quite late at night, as had his wife. His is a seasonal business, and this is his busy time.

The charing of the envelope cannot be explained as innocently, but if the paper was yellowed on one side as is this, that is because it also is something I am using up. It is outdated paper for an Ozalid copying machine. I was given an outline carton of it, either 10,000 or 20,000 sheets of it.

I thought thouse of most Thermofaxes had ended because those are impermanent copies. I would approximate copies of the envelope and the post office letter and any further reports they supply.

Your envelope was postmarked Salinas. I enclose it. I am under the impression that is not close to Carmel.

Too bed I didn't emclose a copy of Maplan's ax job on the Angela Davis case prepared for and distributed to Europe and Africe by the USIA.

In all of this you did not answer my question: do you have anything on the CIA connections of any of the members of the Texas Court of Inquiry? Javorski, for example, was on the board of one fund. Sarah Hughes had a similar post on another, both CIA fronts.

I am thinking of having an attorney at this end look into this. Then I am going to frame it. If you want a photo copy, I will send it.

Of course you wrote about the Nazis, Schmidt, Kaplan and lots of goodies to be photographed.

Met with Robert Blair Kaiser last week. Afte: taking his book apart, sentence by sentence, he is going to come to Carmel so I can show him where the conspiracy exists. He believes it but has no imagination or insight to restructure it. This could be a MAJOR BREAKTHROUGH FOR ALL OF US.L.A. people are very excited because of his contacts and the possibility of reaching him.

Looking forward to your book as soon as I discect "RFK Must Die". Keep up the good work. best regards
