Dear Mrs. Brussell,

Your letter is a good one. I took a different approach, including a couple of challenges in it, like debating Liebeler in front of their student body, called him the fox who got himself hired to guard the chicken house, and asked how much more we can expect impartiality from him now than when we paid him for just that.

If you come across anything on Masferrer, I'd appreciate it. I think he may yet become an important figure in all of this. It is strange the trouble the government went to to permit him to escape, how little interested they were in capturing him when the press had free access to him.

The fact you've had no answer to your letter is perhaps the best measure of its effectiveness. The answer I got was mixed evasion and nonsequatur, and my reply to it is unanswered.

Good luck on Marina. I agree with your description of her as a person~~x~~ but not of her function.

If your files go back to 1964 and you have the New York Times story on the leaked interpretation of the FBI's Reports, especially on the President's wounds, appearing on page 56 of the issue of 1/26/64, I'd appreciate a copy. I loaned this and several other clippings and they have not been returned.

Too many letters that require and warrant answer and too many public appearances that cannot be turned down because they offer the opportunity to inform so many people have put me far behind schedule on WHITEWASH III and a critique of Manchester's work I've agreed to do.
