I was a child of seven when the event occurred but I remember it surprisingly well. Even then, the whole thing seemed fishy. My father has always reacted strangely to it-I have wondered whether his position in the Government afforded him some special knowledge-though he has never really spoken about it. Our family has always been critical of the Warren report and its supporters. The Single-Bullet Theory has particularly stuck in our accumulated craws.


My research has brought me into contact with your work and Let me say I have a tremendous respect and admiration for you Mr. Weisberg and I am taking the liberty of writing to you based upon the efforts you have made and my respect for you.

You say you are in the videotape production business. I wonder if that can enable you to do something for me.

I understand that one of the PBS uses of the Zapruder film is the clearest. There are a couple of frames of it of which I'd like to have prints. These frames are about 20 after the fatal shot at 313, at about 335 or 336. The President is pivoting as he falls over. His back is a bit toward the camera and the back of his head is fairly clear for two frames. The back is there and there is no blood visible on it, the hair appears to be undisturbed and there is no blood visible on his shirt collar.

An entire series of myths have been invented to make it appear that the back of the head blew out. I would like prints of those frames to be punk these newer of the many deceptions of the people if you can provide them. If you can, please let me know the cost. Again thanks.
