## Porto Rican caught as Red spy by NBI seeks political asylum

A Porto Rican who admitted complicity in the Kennedy assassination plot in Dallas, Texas in 1963 sought political asylum here yesterday.

"I am afraid to go anywhere anyway. I am as good as dead now," Luis Castillo, the Porto Rican, told reporters in an interview at the NBI. Castillo, who entered

the country illegally last Feb. 2 under the name of a Filipino, Antonio Eloriga, was arrested in Polo, Bulacan last March 2.

Since his arrival here, he said he has been able to deliver messages to certain people and contact high-ranking Huk leaders, including Commander Sumulong and Pedro Taruc.

Castillo has been under intensive grilling by NBI and army investigators who have administered truth serums and placed him under hypnosis to make him tell the truth.

### Plotter-spy

In all his statements during these tests, he was noted to have revealed

his complicity in the Kennedy assassination and his present mission to size up the status of the Huk movement, here as a secret agent of the Cuban government.

The NBI, which is collaborating with Col. Agapito Heredia of the Intelligence Service, Armed Forces (ISAP) on the case, is still trying to check the Porto Rican's story.

## Normal

"Dr. Alexis Guevarra of the NBI psychiatry clinic has examined him and found him normal," NBI officer-in-charge Serafin Fausto told newspapermen yesterday.

Fausto made the statement by way of clearing up suspicions aired by reporters as to the sanity of Castillo.

Castillo, himself, said he could not remember what he said to the NBI and army doctors of the V. Luna General Hospital. This was when questioned by scribes at the NBI yesterday.

## In Dallas

NBI probers, however, said Castillo admitted having been in Dallas, Texas on the day of the Kennedy assassination and that he had been instructed "to wait for a man in an open car."

"I don't remember how I got into Dallas and how I got out," Castillo said guardedly, "but I am sure I did not carry a gun."

Castillo's truth serum statement before Major Ang of the VLGH last April 4 and 5 quoted the Porto Rican as saying that he went to a building with two windows in Dallas and

waited for the man in the open car to pass.

## Had gun, didn't

Before this, Castillo said he had been met by a man carrying a bowling bag from which he took out a disassembled rifle which he put together and gave to Castillo.

The man gave instructions to him to shoot the man in the open car and if things get to be too tough later, to run to the fourth floor of the building.

Castillo said he was not able to use his rifle at all. He heard that someone else called "Joe" was able to hit the "man," ahead of him.

The accomplice who gave him the rifle later took it back, disassembled it again and then ordered him to take a plane to Chicago.

## Woman in plot

Castillo said an American woman of German descent, Mrs. Dole, gave him his instructions in Dallas and was one of many who worked on him and placed him in a trance for the Kennedy job.

"I don't know how I got out of Dallas. When I woke up I was already in Cuba," Castillo said in a confused, jumbled-up remark.

## In Cuba

The 24-year-old spy told investigators that he was a private in the Segunda Organizacion Defensiva in Santiago, Cuba when he was chosen for training in espionage work.

He took this training in an espionage school, the Special Operations Group CID, under Col. Calma in a camp located about 15 miles from the Bay of Pigs.

Among the members of the school's faculty, according to Castillo, were Karnovsky, a communications expert, some Cubans and a handful of Americans.

He identified a certain James Myers as an American who attended to his needs as a civilian in Cuba and in the United States.

## In Chicago

Castillo said in September, 1965, he was told to contact Antonio Eloriaga, a Filipino visitor, in Chicago to prepare for his mission here.

He was brought by fishing trawler three miles off the shore of Florida and then given a diving gear to enable him to swim ashore.

Upon reaching the shore, he boarded a waiting truck where he was given identification papers and two plane tickets for Chicago.

Philippines as an overstaying visitor.

The plan was carried out successfully. Castillo stole a car in Chicago, drove it through California and on to New Mexico and Sta. Fe where he was arrested by state police and the FBI.

## Deported here

After a thorough investigation, during which the FBI and other US agencies failed to expose his masquerade, Castillo was deported to the Philippines, arriving here on Feb. 2.

He was met at the airport by a boy who guided him to a waiting car which took him to the Shellborna hotel.

## To Valenzuela

After resting for one day and a half in the hotel, he was taken by some friends to Valenzuela, Bulacan where he stayed until NBI agents caught up with him.

Castillo said during his brief stay here in the residence of Eloriaga's parents in Polo, Bulacan, he succeeded in contacting Commander Sumulong and Pedro Taruc, and visiting some people in O'ngango City.

## Aliases

The short stocky Porto Rican, is also known as Angelo Rodriguez, Razo Hernandez, Mario Rodriguez, Ignacio Gonzales, Gradajada aside from his alias as Antonio Reyes Eloriaga of Polo, Bulacan.

NBLOIC Fausto said if Castillo's story is true, the real Eloriaga is still in the United States carrying the identity of Castillo or one of his aliases.

Fausto said ten secret investigations are now in progress locally and abroad to tie up loose ends of Castillo's story, especially as it refers to the 15-man Kennedy assassination plot and the link between Cuban Reds and the local Huks.

## Probe abroad

Fausto said Castillo had deliberately asked for administration of the truth serum during the investigation, preferring it to the polygraph (lie detector) test.

Reporters who quizzed the confessed spy drew a blank when they asked whether he knew Oswald, President Kennedy's killer.

## FM too?

The now-talkative, now-reticent cloak-and-dagger man also clammed up when asked whether he came here to help carry out an assassination plot against President Marcos.

# NBI clamps news blackout on Castillo

President admits infiltration by communist agents in RP

(Special to The MANILA TIMES)

BACOLOD CITY, April 22 — President Marcos this afternoon said that government intelligence agencies are on the lookout for more communist suspects reported to have infiltrated the country lately.

The President made the disclosure in the light of the arrest of Luis Castillo, a Porto Rican, by the NBI. Castillo claimed to have been involved in the plot to assassinate President Kennedy.

### Reports

Marcos said Malacañang has been receiving reports of such infiltration but that he was not free to disclose them. He indicated that there was no breach in national security resulting from the incident. Castillo had reportedly made con-

tacts with local Huk communist leaders like Commander Sumulong.

President Marcos said government intelligence agencies were "on the ball" and were keenly watching the movements of these suspects. He added, however that the law being what it is, it takes some time to arrest these suspects like Castillo.

He said that no person could be arrested on mere suspicion. In a democratic country like the Philippines, certain legal processes have to be followed before any arrest may be made, he said.

### Blackout

The NBI clamped a news blackout on the Luis Castillo case even as it asked

for time to pursue its investigation of the Cuban-trained Porto Rican spy.

This developed as the US embassy burned the wires yesterday seeking verification from state-side authorities of the wild claims made by Castillo, particularly his alleged role in the Kennedy assassination in 1963 in Dallas, Texas.

The 24-year-old Cuban agent was held incommunicado yesterday at NBI headquarters upon the recommendation of NBI intelligence operatives.

### Periodic grilling

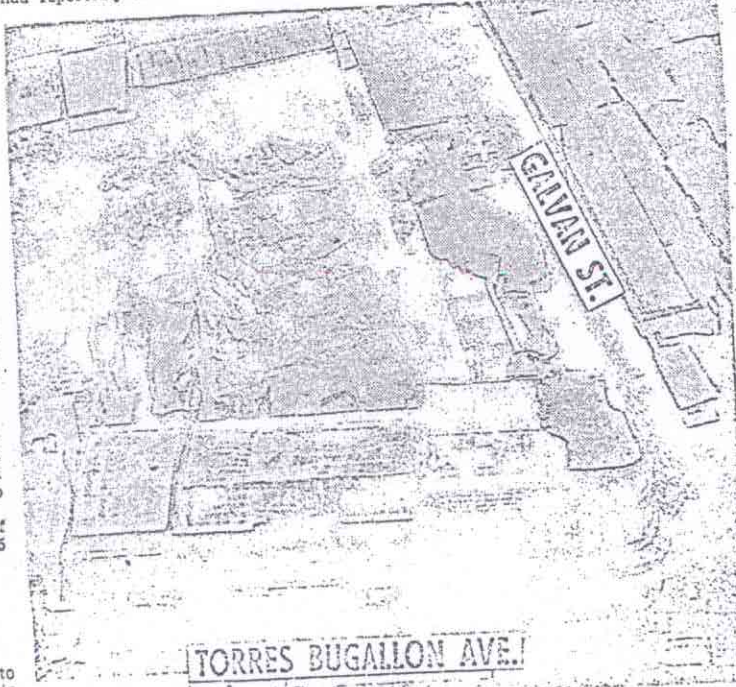

Kennedy slaying and local Huk broke out.

Fausto said leakage and premature publication of Castillo's arrest, followed by his encounter with the press and radio, disrupted the hypnotic trance investigations.

**Disturbed but sane**  
From a cooperative subject, Castillo has become disturbed and uncooperative and it may take some time again for him to regain his composure.

It was stressed, however, that the Porto Rican illegal entry, who arrived in the country last Feb. 2 posing as Antonio Reyes Eloriaga (a resident of Polo, Bulacan) remains normal and sane.

### Tighter security

Security measures have been tightened around the confessed espionage agent, particularly in the light of fears he had expressed yesterday about his own safety.

He has sought political asylum here and local authorities have begun studying his case to find out if his request can be granted.

### Kennedy plot

Castillo is being held by the NBI not only on account of his having entered the country fraudulently but also because of disturbing admissions he had made under the influence of truth serum administered to him (at his own request) by V. Luna General Hospital experts on April 4 and April 5.

While under the drug's influence, Castillo confessed to taking part in the Kennedy plot with 15 others. He said he was under a hypnotic trance during the assassination incident.

The truth serum also caused Castillo to bare details of his mission here to

contact top Huk leaders and to size up the status of the Huk movement.

### Fantastic, but...

The NBI said although Castillo's confession appears fantastic, some aspects of it cannot be ignored by local and American authorities.

Castillo's case was referred by the Intelligence Service Armed Forces (ISAF) to the NBI last February on suspicion that he was an illegal entry.

### As Filipino

He arrived Feb. 2 with a passport identifying him as Antonio Reyes Eloriaga, a returning Filipino resident, who had been expelled from America for overstaying and stealing a car.

Actually, according to his own confession, his coming here as "Eloriaga" was part of a plan laid by a Cuban espionage ring.

Having trained as a spy for some time in Cuba, Castillo was smuggled into the USA in September of 1965 with specific orders to contact Eloriaga in Chicago.

### Plan carried out

His orders were to assume the identity of Eloriaga and to have himself arrested and deported to the Philippines, a plan which was carried out without a hitch.

Castillo subsequently arrived here on Feb. 2 as Eloriaga and was brought home to his "parents" in Polo, Bulacan from which point he succeeded in contacting Huk Commander Sumulong and Commander Pedro Taruc.

### US quiz sought

US embassy spokesman told the UPI yesterday American authorities were investigating Castillo's confession.

The spokesman said it had no immediate comment on the NBI probe. He said

the embassy expected to have a statement tomorrow when the investigation is completed.

### Revamp urged

In the Senate, Sen. Lorenzo M. Sumulong urged yesterday a revamp of the intelligence agencies of the government to make them more resistant to pressure from an infiltration by foreign agents.

Sumulong, who drafted the measure requiring the registration of foreign agents, said that the reorganization should retain in the intelligence service only those who are above suspicion.

The senator said that it is possible that some foreign businessmen are foreign agents.

Foreign embassies in the Philippines could also harbor intelligence operatives in its staff, he said.

### Case cited

Sumulong cited as a case in point the report that a CIA agent working in the US embassy in New Delhi accompanied the daughter of the late Premier Josef Stalin when she defected to the West.

He said that he was in favor of cooperation with the intelligence agencies of foreign governments only to the extent of exchanging information on police problems and international criminals.

This is what is done by the Interpol, he said.

### Internal affairs

Sumulong said that he would object to the gathering of information by foreign agents on internal affairs of the Philippine government and its officials.

Clarifying certain provision of his measure, Sumulong said that its main purpose is to ferret out Philippine government officials

who serve as foreign agents or who are in cahoots with these agents.

He said that such government officials who lead a double life as agents of other foreign countries are liable, under his measure, to penalties which include disqualification from holding public office and imprisonment.

### Not in Dallas

DALLAS, April 22 (UPI) — Dallas law enforcement agents Friday said they had never heard of a man the Philippine National Bureau of Investigation (NBI) said admitted under truth serum that he took part in an assassination plot against President John F. Kennedy.

The NBI in Manila identified the man as Luis Anzel Castillo, 24, a Porto Rican native they say is a Cuban-trained communist.

### No word

Assistant District Atty. Bell Alexander said he had never heard of the man and Assistant Police Chief M. W. Stevenson said the Dallas police had no word on the incident and had also never heard of Castillo as far as he knew.

## New leads on spy

### NBI, US embassy widen quiz on Kennedy slay angle

The NBI and the US embassy gained valuable leads over the weekend in their joint effort to unravel the case of Luis Castillo, Cuban-trained spy.

The leads, according to unimpeachable sources, seem to confirm certain aspects of disclosures made by the 24-year-old Porto Rican under the influence of a truth serum given to him by VLGH exports last April 4.

Fausto munit

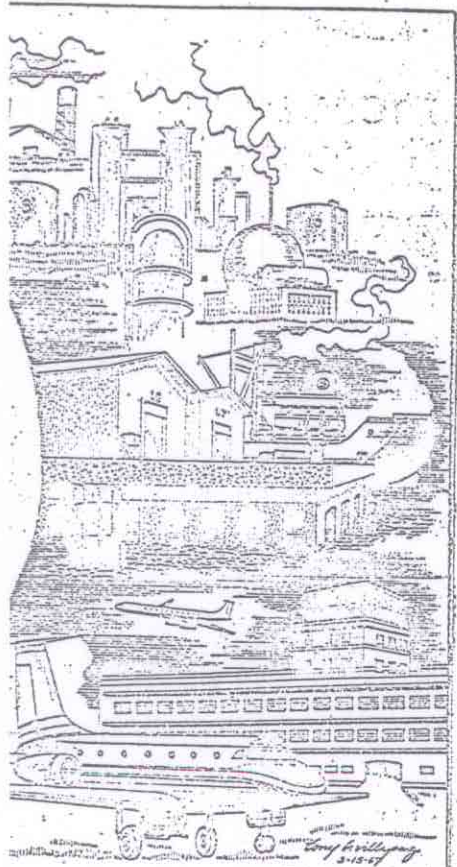

Fausto said the NBI started the search for Eloriaga abroad as early as February of this year when Castillo was exposed by the Intelligence Service Armed Forces (ISAF) as an imposter.

Castillo is still being held incommunicado in the NBI to give time for hypnosis experts to work on him again.

Huks  
 Castillo, who has confessed complicity in the Kennedy stay plot arrived here last Feb. 2 with a mission to contact local Huk leaders and to assess the current Huk movement.

The NBI said there is reason to believe that he has made contacts with some Huk commanders as he has disclosed in his truth serum confessions.

SAN JUAN, Puerto Rico, April 24 (AP)—Puerto Rican police are awaiting word from the Philippine National Bureau of Investigation (NBI) before launching local investigations related to the arrest of a young Porto Rican who reportedly said he took part in a plot against the life of President Kennedy.

The interim director of the Porto Rican Criminal Investigation Corps (CIC) Capt. Luis Maldonado Trinidad, disclosed Sunday that the Philippine agency

 The issues in the protest, Roxas said, required not only the revision and appreciation of hundreds of thousands of ballots but also the introduction of documentary and testimonial evidence in formal hearings.

As a means of preventing poll frauds in the future, Roxas said the withdrawal of the protest will enable the Manila fiscal's office to proceed with the investigation of criminal charges he filed against Lopez and six others for altering the certificate of canvass of Mt. Province.

The fiscal's office temporarily shelved the Roxas complaint on the ground that the electoral protest before the tribunal constituted a prejudicial question which should first be resolved before the criminal case could be prosecuted.

Criminal charges  
 Roxas indicated that he would press the fiscal's office to revive the criminal charges against Lopez and the following:

Rep. Floro Crisologo (N. Ilocos Sur), Gov. Alfredo Lamen of Mt. Province, former Rep. Ramon Mitra Sr., Provincial Fiscal Albert Caoili of Mt. Province, former Municipal Judge Hector Donato, and Leonardo Cadogan, Lamen's private secretary.

They were accused of tampering with the Mt. Province certificates of canvass to change the number of votes garnered by Lopez from 30,901 to 35,901.

Under a congressional canvass, Lopez obtained a margin of 26,724 votes over Roxas. During the canvass, Roxas tried to block the consideration of

## Castillo has records in US

EDGEWOOD, New Mexico, April 23—(UPI)—A justice of the peace said Saturday a man who is said to have confessed to taking part in the assassination of President Kennedy was nervous and couldn't recall his name when he appeared in court here last fall.

The Philippine National Bureau of Investigation was checking the story of Luis Castillo, 24, who allegedly made the confession. Castillo was allegedly trained as a Communist agent in Cuba.

"Hypnotic trance" Philippine authorities said he told them he was in Dallas under a "hypnotic trance" with orders to shoot "a man in an open car" when Kennedy was

killed.

Justice of the Peace Elmer Bassett said Castillo was brought before him last Oct. 22 by a state policeman, charged with driving without a proper auto registration.

"He was as nervous as a tom-cat in a creamery," Bassett said. "Maybe I shouldn't use those words, but he sure was nervous."

Bassett said Castillo also "had a hard time remembering what his name was. The reason I gave him a jail sentence was I figured when a fellow has a hard time remembering what his name is, there's something wrong with him."

Bassett sentenced Castillo to four days in jail.

## Surveyor digs neat moon hole

PASADENA, California, April 23—(AP)—America's scratching moon station—Surveyor 3—dug a neat, straight hole in the moon's surface early Saturday in what a scientist called "a very gratifying event."

"The soil was sliced out very neatly," said Ronald F. Scott, the principal investigator on the Surveyor soil sampling project.

#### Cohesive

"The soil does possess a certain cohesiveness," Scott told a news conference at the Jet Propulsion Laboratory. "There doesn't seem to be any hazard there for astronauts. But it might be rather soft to fall on."

The soil sampler, mounted on the side of Surveyor 3, was poised Saturday to complete digging a trench it started earlier. Scott said scientists planned to have it dig as deep as it can.
