

Dallas Police JFK Assassination records

4/21/92

Yesterday I received from Robert T. Johnson, Archives and Research Co-Ordinator of the Assassination Information Center in Dallas, three thin folders all identified as the intelligence unit's Ruby file. There was no explanation with these folders so I do not know whether they are supposed to be all the police have in the Ruby intelligence unit files or whether from their examination the AIC considered any record or records to have any special significance.

They do hold a record of Ruby's phone calls and a bit about those he called but most is run-of-the-mill checking on the insignificant and there is a fair amount of checking on reports and rumors that did not check out.

There is no consideration of personal privacy and there were no redactions in these copies.

There are a number of baseless reports of an Oswald-Ruby association. The one that earlier had considerable attention from the conspiracy theorists is that they had been seen together at the B & B restaurant, attributed to a waitress. The attached 1/28/64 investigative report quotes the owner as describing that waitress as "a chronic liar."

One that I think should have resulted in a further investigation, 2/10/64 by two detectives says that on 11/23/63 Ruby spoke to Officer Chaney at the scene of the crime. I did not see any report from of interview with Chaney in these folders. Marion Baker testified that Chaney had learned something of value at the TSBD on 11/23/63, as reported in Whitewash, but I am not aware of that having ever been carried forward by the local or federal authorities.

I have not received, if there is one, any list of the titles of the disclosed files. Nor, from anyone, any comment or evaluation of them or leads to be followed, if any.

Persuant to the request of Captain W. P. Gannaway, an investigation was made regarding information given to the Federal Bureau Of Investigation by SUBJECT, and the following facts were verified.

On the morning of November 21, 1963, SUBJECT was in the Allright Parking Garage, 1320 Commerce Street, with KAREN LYNN BENNETT, AKA LITTLE LYNN,

On the morning of November 21, 1963, SUBJECT and CONNIE TRAMMEL were in the Mercantile Securities Building where CONNIE TRAMMEL went to LAMAR HUNT'S office.

On the evening of November 21, 1963, SUBJECT was present and participated in the show at the Carousel Club.

On the morning of November 22, 1963, SUBJECT was in TONY ZOPPI'S Office at the Dallas Morning News.

On the afternoon of November 22, 1963, SUBJECT phoned ALICE NICHOLS and discussed closing his Club. SUBJECT called ALEXANDER P. GRUBER at WE 5 1082, Los Angeles, California, and BRECK WALL at SO 3 8022, Galveston, Texas, from the Carousel Club.

On the evening of November 22, 1963, SUBJECT purchased some sandwiches at Phil's Delicatessen and called Detective Simms who declined his offer to bring the sandwiches to the Homicide and Robbery Office. SUBJECT later went to the

City Hall Jail Office where he called HENRY WADE to the telephone to talk to an employee of Radio Station KLIF. SUBJECT later went to Station KLIF and took the sandwiches.

On November 23, 1963, SUBJECT talked to Officer CHANEY at the scene of the assassination and was later seen on the street by WES WISE and JIM UNDERWOOD. SUBJECT was in Sol's Turf Bar at 1515 Commerce Street on the afternoon of November 23, 1963, where he was showing photographs, passing out cards and making telephone calls. SUBJECT returned to Sol's Bar around midnight for a few minutes.

On the morning of November 24, 1963 SUBJECT ate breakfast at the Southland Hotel Coffee Shop at about 5:00 a. m.

SUBJECT sent a money order to KAREN LYNN BENNETT, AKA LITTLE LYNN, from the Western Union Building immediately prior to his entry into the City Hall on November 24, 1963.
