Dear Steve,

I'd heard your appearance on the Dolan show was good. Keep the others up.

I'd asked Hal to check with you on dates but I guess he's been too busy also. I get to SF for a TV show 2/3. Hal asked me to stay a week. This means until the night of 2/9 at the earliest. I suggested that if there is a trial 2/13 it should also be the latest. Then, L.A. Somewhere certain of the early part of the week beginning 2/11 and I may be able to get there a couple of days earlier if it is necessary. I leave this entirely up to you and Hal, as I have in the past. I usually do not know what I'll be doing until I get there.

If Tony Jackson at KTLA wants a show that will keep Liebler busy answering embarrassing questions, I can give it to him. If he wants proof that Liebler suppressed evidence, that, too. Is that ABC?

You are right not to talk of Bradley, but I think it would be good if you could do a Bohman show. His female companion is better than he. When Liebler would not confront me over the phone, I had to needle him to get him to announce it. But it is good exposure. I think, from the reaction I got last time, he might have me again.

I'm to phone the Tyne people from SF. I've something I'm working on that I'll tell you about when I'm there that should be a real shocker. If they want it, I'll save it for them. My reaction from that show continues, in every mail and with everyone I see.

So, you and Hal load me up as much as you can. I can do whatever you arrange. I leave all the arrangement to both of you, as in the past, and with both gratitude and respect for what you both have done.

Looking forward to it, very much.

I'll schedule a week in LA and leave earlier if we do not need it. So, you can figure now through the night of 2/17.
