Dear Dave:

This letter is to inform you of the creation of a new coordinating group to intensify efforts by existing organizations for a full and truthful accounting of the three major political assassinations of the 1960's: the murders of President John F. Kennedy, Senator Robert F. Kennedy, and Dr. Martin Luther King. **"Citizens For Truth Of The Kennedy Assassination +"** was created out of the call for action at the "Second Midwest Symposium on Political Assassinations", which took place during the first week of April, 1993. This committee needs your assistance in obtaining these goals.

The purpose of this organization is to form an umbrella group for all interested parties to collectively work together towards a final, and truthful, resolution of these unsatisfactorily resolved events.

In order to maximize our legislative and communicative impact, we are requesting that you join us in this effort by making available to the committee, in strictest confidence, any and all lists you have of companies, groups or individuals that might join us in these efforts.

Our first, and most immediate, goal is to exert organized lobbying pressure on the executive branch of government to comply with the time provisions of Senate Joint Resolution #3006, commonly called "The Assassination Materials Act of 1992", and constitute the mandated six person review board forthwith.

The primary aim of the committee is to coordinate efforts for the release of these files with current Congressional activities for the permanent formation of the Office of Independent Consul; an office with the full powers of subpoena and censure with adequate and continuing budgetary considerations.

In that way the mechanism for redressing governmental deficiencies in these cases will be in place by the time the files are finally released. This will also ease all future efforts to re-open each of these cases.

If we have one without the other, we will, in effect, have produced nothing more than another 30 years worth of reading material on the case.

The committee plans to establish the broadest base possible in reaching and educating the general public with it's work and will accomplish this through a variety of efforts, including: a speakers bureau, both here and abroad; a computer bulletin board (BBS); an 800 Number for information and resource access; sponsoring of radio shows and T.V. documentaries; demonstrations on the 30th anniversary date in both Washington, D.C. and Dallas, Texas; the establishment of both regional and local affiliate offices around the country; the continued coordinating of educational and lobbying efforts on the Executive and Legislative branches of government; and the fermentation of an outreach program to all progressive groups and organizations.

The committee is at a crucial stage of it's development at the present time. In order to realize the common sense goals set forth by the committee, we need your help in contacting as many volunteers, political activists and potential donors as possible. Towards those ends we are requesting that you join our efforts and make available to the committee your data base of membership, clientele and patrons.


Since the stated goals and aims of the committee are those of a collaborative nature and not one of competitive effort, we are asking for your further assistance by supplying the requested information at as nominal a charge as possible, or your help in doing mailings for our common goals.

Time is of the essence, for we must be at full power when major media attention is refocused on the J.F.K. case with the 30th anniversary of his death.


