MISCELLANEOUS INFORMATION CONCERNING**

Reference is made to my letter May 12, 1967, which described a request received by the New Orleans Office of the Federal Bureau of Investigation from a New Orleans police officer for copies of material he furnished in 1964. This material concerned David W. Ferrie, deceased, an alleged associate of Lee Harvey Oswald. This request was presumed to be in connection with the investigation of the assassination being conducted by New Orleans District Attorney Garrison.

This request was referred to the United States Attorney, Eastern District of Louisiana, at New Orleans, Louisiana. He stated he desired to review the material in question and consult the Department of Justice before furnishing an opinion.
