

Marina's Russian "Pal" in Dallas Had Worked For Lehman's

Most of the Smokey Bears who wear Louisiana State trooper uniforms are satisfied to pass out a few traffic tickets and drink a lot of coffee. They don't plan to assassinate anyone, nor file false affidavits. Nor work for the notorious ADL. Nor run a racket on the streets, but corrupt politicians.

But unfortunately unless an independent probe of the Louisiana State police is conducted for the purpose of firing the "bad guys," then the "good guys" are likely to suffer from the accusations against this controversial police force.

Here are a few facts and conjectures which together suggest that a fair-minded, independent probe is needed to clear the air. If there was any connection between police in the New Orleans area and the Martin Luther King assassination, this should be brought to light immediately instead of hidden from the public.

Sinister individuals who were involved in the Kathy Ainsworth slaying should also be examined, and if guilty of supporting the murder-for-hire program, should be removed from the public payroll and appropriately punished.

Here are the 71 facts and 11 conjectures from years of

research by The Councillor. Judge for yourself if the smoke hints of flame.

1. FACT: Prior to 1963, police in the New Orleans area had not been heavily infiltrated by the New Orleans ADL, and were opposed to Red activities.

2. FACT: At the invitation of the Louisiana Joint Legislative Committee on Un-American Activities, New Orleans police during the JFK years raided the Perdido Street headquarters of the Communist Front Southern Conference Education Fund. The raid was planned by Jack Rogers, who on the advice of consultants, did not tip federal agents in advance.

3. FACT: When the raid came off, Leftists had had no opportunity to hide tattle-tale material. Police recovered a bonanza of correspondence showing Martin Luther King's connections with New Orleans Reds.

4. FACT: The Perdido Street headquarters of this group was property historically owned or controlled by the Lehman Family.

9. FACT: Mrs. Stern's broth-

er-in-law, Alfred Kaufmann Stern, was indicted in New York as a Soviet espionage agent, and fled the U.S.

10. FACT: Mrs. Stern's son, Philip Stern, (with Adam Yarmolinsky) played a part in the gagging of Major General Edwin Walker after Walker tried to tell his troops in Europe the truth about Communism.

11. FACT: Mrs. Stern's grandfather, after moving from Europe to Baltimore, relocated in a house across the street from Abraham Lincoln's home in Illinois.

12. CONJECTURE: Some researchers believe—but cannot prove—that the grandfather played a supporting role in the assassination of Abraham Lincoln 111 years ago.

13. FACT: Mrs. Stern's New

Orleans broadcasting station, WDSU, provided publicity for the pre-assassination antics in New Orleans of Lee Harvey Oswald.

14. FACT: Based upon letters between key Reds, seized during the Perdido Street raids, and upon later information, The Councillor was able to successfully predict on Sept. 30, 1965, the assassination of Martin Luther King.

15. CONJECTURE: We interpreted various clues to mean that Martin Luther King eventually would be more valuable to the Reds as a dead martyr than as an undependable living smoothie.

16. CONJECTURE: There is probably an assassination apparatus in New Orleans which involves powerful persons and seems to have compromised police forces in the New Orleans area since about 1963.

17. FACT: The plot to kill JFK involved at least three persons living in the New Orleans area in 1962.

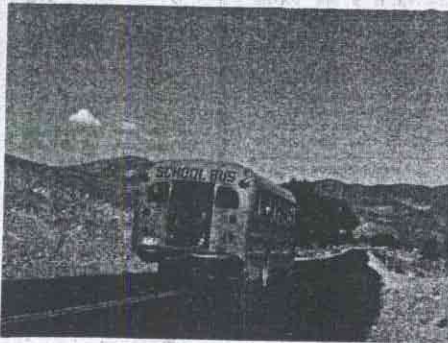

questioned by police officers who knew their identities and knew the ownership of the car. But they were seized with a great flourish and showmanship in the presence of cameras of CBS-TV.

73. FACT: Viewers throughout the United States saw this abduction but were told that it was an "arrest." They were told that both boys were charged with "possession of a stolen weapon!" The incident cast a shadow on the integrity of The Councilor.

74. FACT: There is no such charge in Louisiana. 77. FACT: Before they were jailed, the abductors were questioned extensively and co-operated completely because they thought a mistake had been made. One witness said that the mysterious Meridian, New Orleans agent XYZ, MENTIONED ABOVE IN PARAGRAPH 35, WAS NEARBY DURING THIS

STRANGE INQUISION.

Search Launched in Illinois For What Is Said To Be A Coin More Than 10,000 Years Old

KANSAS CITY — Friends of Ned Touchstone in Illinois and in the United States Congress are being asked to help solve a mystery.

At stake: Alleged evidence which suggests that an advanced civilization lived in what is now Illinois (or visited the area) at some very ancient time.

Investigation could establish:

- (a) That such evidence does exist.
- (b) That such evidence may have existed 100 years ago but has been lost, or
- (c) That the whole yarn is unadulterated bunk.

Last week Mr. Touchstone was studying the notes of a midwest congressman who has been dead three quarters of a century, when he ran across very strange claims. The man in question, Rep. Ignatius Donnelly, had correctly predicted the Russian Revolution, serial warfare, and 20th century financial trickery. Therefore his notes were being searched for clues of other correct predictions, or of special knowledge of Illuminist forces and their activities.

In those notes he found mention of a "copper coin" which allegedly was found 114 feet under ground at Lawn Ridge, Marshall County, Illinois. It was said to have come from an artesian boring which passed through strata of various clay and vegetable matter to a two foot layer of sand at the 112-114 feet level.

Congressman Donnelly suspected that the "coin" was the handwork of an advanced civilization of great antiquity, which had been — he conjectured — wiped out by a great catastrophe. Here are the "clues," in each instance being the statement of persons now deceased, and therefore unavailable for cross examination:

- (1) Information about the "coin" was supplied on Dec. 4, 1871 by a Mr. W. H. Wilmot of Lawn Ridge.
- (2) A famous geologist, Professor Alexander Winchell, claims to have seen the "coin."

In order to add more adventure to The Councilor and to attract new readers who do not yet know about strange phenomena in the political arena, this paper will probe a number of significant "mysteries." Most of them have an important bearing on other topics covered by The Councilor, but, frankly, our honest probes into these mysteries will be "bait" to attract and awaken sleepers that we don't yet reach.

We are honest in this effort. The Councilor is edited for people with inquiring minds and high I.Q., but even if we can't get all such persons to agree with us at present, we know that most of them will realize in our viewpoint once they have read the facts. Besides, America needs a brand-based honest newspaper.

He made this claim in his book, Sparks From A Geologist's Hammer, page 170.

(3) Three persons who said they saw the "coin" at the same time are said to have claimed possession of it. Unfortunately their names were not supplied by either Donnelly or Winchell.

(4) Apparently one of the three emerged as the single owner.

(5) This single owner allegedly sent the object to the Smithsonian Institute for examination and a Secretary Henry referred it to a Mr. William E. Dubois.

(6) This Mr. Dubois is said to have presented the result of his study of the "coin" to the American Philosophical Society.

(7) It was also said to have

been examined by a Professor J.P. Lesley.

Even with this much background Mr. Touchstone might have taken very lightly the Donnelly-Winchell claims except:

(a.) There have been additional discoveries in the 20th century, after both men died, which tend to support the amazing thesis of an ancient civilization.

(b.) Mr. Touchstone's examination of drawings of the so-called "coin" showing figures on them virtually identical to pre-historic carvings found in Australia and various other places around the Earth in very recent years. It is extremely unlikely that anyone living in the 1870s could have copied drawings thousands of miles away which were not known to exist at the time.

(c.) The copper in the object was described as "milled" and the figures on it were placed there by acid etching. Both processes are unknown to aboriginal inhabitants of Illinois who occupied the area in historic times, or even in the centuries immediately prior to recorded history.

(d.) There have been reports of other strange objects found at great depths in Whiteside County (50 miles away); Stark County, Ohio; San Joaquin Valley, California; Petite Anse Island, Louisiana; and near Memphis, Tennessee.

With these clues, it should not be difficult to find more mention of the "coin." Perhaps it is hidden in the recesses of some museum by a curator who

With him is Eleanor Roosevelt who stooged for him in getting American tractors, narcotics and war goods sent to Fidel Castro to "ransom" the Bay of Pigs prisoners. Georges Von Mohrenskold Remains A Big Mystery in Dallas Events

EARLY RESEARCH BY COUNCILOR SUPPLEMENTED NOW BY FRANK CAPELL

Editor's Note: In 1964, 1965 and 1966 The Councilor turned up considerable information on a mystery man who "befriended" Marina Oswald just before the assassination of John Kennedy. Oswald was apparently moved to Dallas as a patsy to be blamed for the shooting, as—reasoned The Councilor—it was fair to take a look at the friends surrounding the Russian, Marina, to see what sort of people they were. Von Mohrenskold was identified as "George De Mohrenskold" by the Warren Commission.

The mystery man had lived in Shreveport for awhile and we were able to pick up some of his trail here.

In January, Frank A. Capell, who with Ned Touchstone and a few other investigative writers are at the pinnacle of the profession, has added considerably to the amount of knowledge which pertains here of Von Mohrenskold's activities. The article below, by Capell, credits Hugh C. McDonald for some of the research.

The Councilor believes, from its 12 years of research, that the late Senator Herbert Lehman of New York (a) helped transform the old pro-Rad OSS into the CIA, (b) helped sabotage the Bay of Pigs operation and (c)—with Eleanor Roosevelt—rescued the captives, and (d) was probably the man who made the decision that JFK should be converted into a martyr.

There is nothing in the Capell article which conflicts with our interpretation. The name that we have for the master marksman at Dallas was "Santini" or "Santandini."

A recent session of the Senate intelligence committee produced the revelation that President Johnson had become convinced that the KENNEDY (JFK) assassination was a plot and that the CIA was involved. Cartha D. DeLoach, a top aide to the late FBI Director J. Edgar Hoover, testified that former White House aide Marvin Watson "called me and told me President Johnson called him and said he was now convinced there was a plot in the assassination." This adds another name to the list of persons unconvicted by the Warren Commission cover-up with its "lone assassin" determination. In fact, no one with the capacity for logical thinking could believe the assassination of President John F. Kennedy was anything else but a well planned conspiracy. A new book has revealed it to be just that and has detailed the story in a paid-assassin's own words.

"Appointment in Dallas," subtitled "The Final Solution to the Assassination of JFK," is the name of a paperback recently published by the Hugh McDonald Publishing Corp., 380 Madison Ave., New York, N.Y. 10017, and distributed by Zebra Books, which is controlled by Kensington Publishing Corp. of the same address. The book was written by Hugh C. McDonald (as told to Geoffrey Bocca) whose impeccable credentials make it impossible to consider the book just another one alleging the solution of the conspiracy in the murder of John F. Kennedy. McDonald was Chief of Detectives in Los Angeles County for 26 years.

McDonald's knowledge of the story of the JFK assassination came as a result of his selection by the Republican National Committee to head the security for presidential candidate, Sen. Barry Goldwater. It was in this capacity that he retained the services of Herman Edward Kimsey who had been a CIA official for a number of years and with whom McDonald had previously had contact. His concern for Goldwater's safety caused Kimsey, during a visit to Dallas, to relate to McDonald the story of the Kennedy assassination which he had been told by the person who claimed to have been the assassin. Kimsey identified the man as an individual McDonald had seen briefly when he had been in

Kimsey's office in CIA headquarters. According to McDonald, he had dropped in to visit Kimsey at the CIA while he was attending the FBI Academy in Washington and, while there, saw this man when he stormed into the room to complain about everything going wrong in the Bay of Pigs invasion in which he had been hired (presumably by Kimsey acting for the CIA) to play a part. At the time Kimsey described the man as a "top assassin" who "works for a lot of people."

Bay of Pigs Fiasco

This encounter took place shortly after the Bay of Pigs (planned) fiasco in April, 1961 and made an impression on McDonald because of the cold viciousness of the man who made killing his profession. It was in Oct. of 1964 that his involvement in the plot to kill Kennedy was revealed in an incredible story which Kimsey said he would deny if McDonald told it to anyone. However, he told McDonald where to get his notes and files... "if anything should happen to me!" but after Kimsey's death the FBI and CIA seized his papers and McDonald was left with the story of a dead man and none of the corroborating notes he was promised. This seemed like the end of the line. However, opportunities presented themselves for McDonald to check into the matter further and finally, after the assassination of Kennedy, he had to prove or disprove Kimsey's story, a transcript of which was safely locked away in a safe deposit box.

McDonald finally located and met with the assassin, whose name he never discovered but whom he called "Saul." In a

A Strange Set Of Priorities

London hotel in June of 1972 the story of the assassination of President Kennedy was told by the man who killed him and it agreed with that told by Kimsey.

Professional killers do not have offices from which they conduct their business affairs but those wishing to avail themselves of their services find ways of contacting them and thus,

There was early talk by federal spokesmen that Oswald had been photographed in the Mexican capital by secret CIA cameras, but this clearly is not Lee Oswald or even an Oswald look-alike.

Saul was apprised of the fact that an individual was trying to get in touch with him. This man would not reveal his identity until he had a chance to observe him and from this Saul inferred that they had met before. The assassin let it be known that he could be contacted in Haiti and in the middle of May 1963 he went to Haiti and followed instructions to stay for three days within a certain geographical area. He stayed at the Hotel Iboele and at four o'clock in the afternoon of the second day he received a telephone call. He thought this was peculiar since there was almost no telephone in service at the hotel; one could reach the Pan American office but not much more.

Saul was told to meet the contact man at 7:30 that night at a private residence. It turned out that they had met before. During the training period for the Bay of Pigs invasion in Guatemala, a certain man had appeared occasionally at the camp site. It was whispered around that he was one of the American agents and he seemed primarily involved in a type of industrial sabotage. Saul, who was taking part in the invasion preparations, met this individual five or six times in Guatemala; as usual, names were not handed about so he gave him the name "Troil." Even the

professional killer was shocked at the enormity of the assignment offered him that night in Haiti to kill the president of the United States. He needed time to think about it and demanded \$2,000 from the contact man to pay his expenses while he made his decision.

He thought about the man with whom he was dealing; he had been considered to be a CIA agent when he appeared in Guatemala. He thought about the house in which they had met in Haiti; it had an official atmosphere. The group the man was fronting for must be powerful and important, with unlimited finances. He accepted the assignment and named his price, \$25,000 in advance and \$25,000 when the deed was accomplished. From a suitcase full of money the man counted out a portion to hand Saul the advance payment. At that meeting the plan had not as yet been completely firmed up; the go-between was himself waiting for orders and when they came they were relayed to the assassin.

The Patsy

There was to be a patsy who would shoot at the president but not hit him; at the same instant the killer would shoot and would

hit him. Secret Service men would shoot at the presumed killer who would be visible from a window in a building across the street from where the real killer would be. The assassin would also shoot at the patsy and kill him and the killing would be credited to the Secret Service men and thus the story would end. The man who killed the president would be killed by those whose job was to protect him. The real killer would walk away, unnoticed and unarmed, to collect the rest of the \$50,000.

The patsy was to be a young friend of the contact man, an emotionally unstable person who had recently returned from the Soviet Union. "Troika" got him involved in the plot by telling him he worked for the Government and that the Government was very worried about the president's disregard for his own safety. Lee Harvey Oswald, the patsy, would shoot at him merely to scare him into realizing he must be more cautious. The contact man said he would have Oswald go to Mexico City so that Saul might see the man who was to be his second victim. As promised, he arranged for Oswald to spend several days in Mexico City where he visited the Cuban Consul and the Soviet Consul and Saul carefully observed him. The killer remained in Mexico until two days before the assassination and then went to Dallas to get himself in readiness. All went according to plan except that the Secret Service men did not shoot at Oswald. This necessitated the implementation of the backup plan—a hit-man to kill Oswald after he was taken into custody. This was Jack Ruby who also conveniently died while in a jail cell, but not before he, too, spoke of conspiracy.

In one of the many volumes which contain the hearings of the President's Commission on the Assassination of President Kennedy is a picture identified only Exhibit #237. Hugh McDonald says this is a picture of Saul which Saul himself identified as having been taken at the Russian Embassy in Mexico City. Copies of this photograph were used by McDonald in his search for the assassin when he recognized the man in the photograph as being the man he met in Kinsey's office, the man who told Kinsey he had killed President Kennedy.

De Mohrenschildt

Thus, the Warren Commission Report reveals the face of the president's killer as it also reveals through testimony the possible identity of the contact man. This man, together with his wife, was a close friend of Lee Harvey Oswald and his Russian born wife, Marina. This man had appeared in Guatemala at the staging area for the Bay of Pigs invasion within 48 hours of the invasion. This man had been in Haiti at approximately the same time as the assassin claims to have met his contact

there. This man, whose entire background raises many questions, is George S. De Mohrenschildt. De Mohrenschildt's testimony and that of many persons who knew him reveals the following information.

George S. De Mohrenschildt was born April 17, 1911 in Moez, Russia, the son of Sergis Alexander Von Mohrenschildt and Alexandra Zopalsky. His mother was of Russian-Polish-Hungarian descent and his father of Russian-Swedish-German descent. His father was an important official of the Czarist government, a landowner and marshal of nobility, but was a liberal and outspoken opponent of the anti-Semitism which was prevalent at the time. He was arrested by the Bolsheviks in Minsk where he lived at the time but was released through the intervention of a Jewish Communist whom he had helped earlier. He was appointed by the Soviet government as adviser to the Minister of Agriculture, dividing up estates, a program of which he approved. He later fell into the bad graces of the Soviets and escaped to Poland, where he owned 5,000 acres of land, and became a professor and director of a high school in Wilno until 1930. When the Russians went into Poland, he moved to Germany where he died during World War II during an air raid.

George De Mohrenschildt lived in Wilno, Poland, until he graduated from high school; he volunteered for the Polish Army and was sent to the military academy in Grudziadz. He remained there 1½ years, attaining only the rank of sergeant which he never rose above. He then went to school in Belgium and received a masters degree from the Institut Supérieur de Commerce a Anvers. Two years later, he obtained a Ph.D. in International Commerce from the University of Liege.

De Mohrenschildt came to the United States in May, 1938, bringing a considerable amount of money with him. He had a brother, Dimitri, living on Park Avenue in New York City. George went to work selling perfumes for Chevalier Grade and then materials for Shumaker & Co. He became a close friend of Pierre Fraiss who was chief of export of Shumaker & Co. Fraiss was connected with French Intelligence and George later worked with him on behalf of French Intelligence, going around the United States gathering information on pro-Germans. He also arranged for preventing oil companies from selling to Germany and Italy. De Mohrenschildt spent his first summer in the United States at Belport, Long Island, N.Y. where he became a friend of Mr. and Mrs. Jack Bouvier, Jacqueline Kennedy Onassis' mother and father. In fact he became a close friend of the whole family.

While working for French Intelligence agent Fraiss, De Mohrenschildt met Lilia Pardo Larin through a Brazilian friend, a very wealthy man known as the King of Banans in Brazil, by the name of Dr. Palo Machado. George and Lilia started out for Mexico, making a stop at Corpus Christi and then going to Aransas Pass where they may have made some photographs and sketches of the Coast Guard Station. On the way back from the Pass they were stopped by FBI agents and their car searched. They finally arrived in



The picture at left purports to show Lee Harvey Oswald just before he went to Russia and the one at right was supposedly taken just after he returned. Their eyes appear to be the same, but there appears to be a discrepancy in hair texture, the shape and set of the ears, the shape and size of the nose, and in the general shape of the head. The difference in head shape, and in some of the distortions could be caused by type of lens, camera angle, and a possible loss in weight.

Mexico where they stayed nine months before De Mohrenschildt was expelled as being persona non grata. He returned to New York and then went to Palm Beach, Fla., where he met Dorothy Pierson who became his first wife on June 15, 1943. After one year of marriage they were divorced. Their daughter Alexandra was born Dec. 25, 1943.

The peripatetic De Mohrenschildt then went back to Texas where he obtained a masters degree in petroleum geology with a minor in petroleum engineering in the fall of 1945. He then worked for a year in Venezuela, returning to the United States to become assistant to the chairman of Rangely Field Engineering Co., operated by a group of 8 to 10 oil companies (Rangely, Colorado). He stayed there approximately three years and while there, met and married his second wife, Phyllis Washington. He met her

in New York and she went to Colorado to live with him before they were married. She was the adopted daughter of Walter Washington, who was with the State Department. This marriage also ended in divorce.

Wife number 3 was Wynne Sharples who graduated from Columbia University Medical College and was a member of a wealthy and socially prominent family. They were married in Chestnut Hill, a suburb of Philadelphia, on April 7, 1951. De Mohrenschildt went into partnership with his wife's uncle, Col. Edward J. Walz, in the Waldem Oil Co. in 1956. The couple had two children both afflicted with cystic fibrosis, a tragedy which encouraged them to form the National Foundation of Cystic Fibrosis in Dallas with Jacqueline Kennedy as honorary chairman. De Mohrenschildt and his third wife were divorced after five years of marriage and she later married Dr. Robert

Denton, a professor at the University of Pennsylvania.

Mrs. Bogoiavlensky

De Mohrenschildt really began moving around then. He took a job in Haiti in 1956; visited and did work in Nigeria, Topolana, Ghana, France, Mexico, and Cuba. In early 1957 he went to Yugoslavia for the International Co-Operation Administration with a man named George Mitchell. His salary was paid by the State Department and his expenses by the Communist Yugoslav government. De Mohrenschildt had met Jeanne LeGon in Dallas and she went to Yugoslavia also. She was married and not yet divorced. They were married in the summer of 1959. Jeanne's former husband, Robert LeGon, had changed his name which was originally Bogoiavlensky. They met in China where Jeanne's father was a director of the Far Eastern Railroad in China (Manchuria). They came to the United States in 1938, the same year De Mohrenschildt arrived on our shores. Their daughter, Jeanne Elmor LeGon, changed her name to Christiana Bogoiavlensky and married Ragnar Kearton.

In 1960 De Mohrenschildt and fourth wife, Jeanne, began a walking trip through Mexico, Guatemala, El Salvador, Honduras, Nicaragua, Costa Rica and Panama. The trip took about a year and they returned to the United States in the fall of 1961. They covered about 5,000 miles on the trip and then went to Haiti to visit an old friend of De Mohrenschildt's father, Michael Breitman, who had been a wealthy man in Russia and was in the oil business. They stayed in Haiti for two months and returned to the United States

 directly from Haiti to Louisiana where friends met them and drove them to Houston and then to Dallas. The friends were George Kitchel and Jim Savage, both connected with the Kerr-McGee Oil Co. In Dallas they took an apartment at 6628 Dickens Avenue and because they were running short of money Mrs. De Mohrenschildt took a job in the millinery department of Sanger-Harris, a large department store in Dallas.

While in Dallas, the De Mohrenschildts were part of the Russian community there, many of whom expressed low opinions of them in Warren Commission testimony. Paul Raigordsky, a wealthy anti-Communist Russian-American, reported De Mohrenschildt to the FBI when he heard about his trip through Central America. He said De Mohrenschildt's reputation for truth, character, integrity and morals is bad. Mrs. Igor Vladimir Voshinin, who had known De Mohrenschildt since 1955, referred to the De Mohrenschildts as "fighting or aggressive atheists." She testified that George told her that his activities in Haiti and other trips back and forth were connected with the State Department and that the De Mohrenschildts had visited the Soviet Consulate in New York City before going to Mexico on their trip.

George Bouhe and Max Clark were friends of Oswald and of George De Mohrenschildt and had a close relationship with the FBI. Clark was an ex-Colonel in the Air Force and an attorney; his wife was Russian. Samuel B. Ballen, an officer in several corporations, testified before the Warren Commission that "George De Mohrenschildt, a close friend of mine, told me that he and his wife had met an extremely interesting couple who had worked their way from Russia here to Dallas and Fort Worth, and that among other problems, that this fellow was in pretty desperate financial straits and needed a job, and would I be willing to see him and try to find employment for him." Mr. Ballen fixed the date of this request and his interview with Lee Harvey Oswald as either the latter part of 1962 or the very early part of 1963. Mr. Ballen also testified that Rags and Chris Bogoiavlensky - Kearton (the daughter of Mrs. De Mohrenschildt and LeGon) stayed with him after the Kennedy assassination and told him that the De Mohrenschildts were publicly stating in Haiti that the FBI was responsible for the assassination of Kennedy and that Oswald was a patsy. They reportedly made these statements at a reception for members of the Foreign Diplomatic Corps in Port-au-Prince.

Denounced By Son-in-Law

Gary Taylor, who had been married to De Mohrenschildt's daughter Alexandra, was questioned by the Warren Commission

about the relationship between Lee Oswald and George De Mohrenschildt and stated: "Uh - it's difficult to assess their relationship because there probably was more to it that I ever saw...I certainly think that they must have been closer than they appeared or the De Mohrenschildts wouldn't have been so active in seeing that they got along well." Asked "Do you have any opinion as to whether George De Mohrenschildt exercised any influence over Oswald," Mr. Taylor answered: "Yes, there seemed to be a great deal of influence there." Gary Taylor was asked if there was anything he wanted to say that might help the commission in its investigation and stated: "Well, the only thing that occurred to me was that - uh - and I guess it was from the beginning - that if there was any assistance or plotters in the assassination that it was, in my opinion, most probably the De Mohrenschildts." He based his opinion on their desire to return to Russia and live, their travel behind the iron curtain and their walking trip through Central America and said he was sure their presence at the Bay of Pigs training area was for the purpose of spying.

De Mohrenschildt's political orientation is evident from his own statements in the Warren Commission report. He testified he gets along well with Communists. "I see some good characteristics in Communism." He saw no good characteristics in the John Birch Society, however, and testified: "I don't like that movement. Personally I dislike it very much." His wife expressed the same sentiments. The plot, as revealed in "Appointment in Dallas," was to have Oswald believe that he was working for the Government through the inducements of his "friend." The Warren Commission report states: "Oswald had no friends or close associates in Texas when he returned there in June of 1962, and he did not establish any close friendships or associations, although it appears that he came to respect George De Mohrenschildt." Discussing De Mohrenschildt, the report states: "Extensive investigation has been conducted into the background of both De Mohrenschildts ... By happenstance they were in Guatemala City at the time of the Bay of Pigs invasion...Upon arriving in Panama they journeyed to Haiti where De Mohrenschildt even-

NEW ORLEANS, La. — Many students of the JFK assassination believe that there were two persons playing the Oswald role, with possibly one of the real Oswald and the other a look-alike. tually became involved in a Government-oriented business venture... Although the Warren Commission report contains the FBI and other intelligence reports on hundreds of people, many not even remotely connected with Lee Harvey Oswald or the assassination, most investigation reports on the De Mohrenschildts are missing. This would lend credence to the possibility that he was working for the Government.

Hugh McDonald was asked why he did not go to CIA officials with his story instead of writing a book and answered: "I knew them and respected them but something was wrong. If I took the story to them it would be like bringing coal to Newcastle." He went on to say that it was obvious that they knew the assassin since they had taken a picture of him. It is also obvious that they must have had a file on him since he was

employed by them during the Bay of Pigs operation. He would also have to be known to the CIA to be able to burst into a private office at their headquarters as he did into Kimsey's; he would have to be known to them to even get in the building. Lee Harvey Oswald's mother stated after the assassination that her son was connected with the CIA; this seemed ridiculous then but not so now that the activities of this secret agency are being investigated. Mrs. Oswald still insists that her son had some intelligence community connections she can prove, according to Dave Marston, personal aide to Sen. Richard Schweiker (R. Pa.) who heads a subcommittee exploring the probability of an intelligence agency cover-up during the Warren Commission investigation. There is a distinct possibility that, even if Oswald was not working for the CIA, someone was giving him the impression that he was. De Mohrenschildt also was working for the Government or giving the impression that he was.

Did the CIA and other intelligence agencies mislead the Warren Commission or did the Warren Commission deliberately mislead the American public?

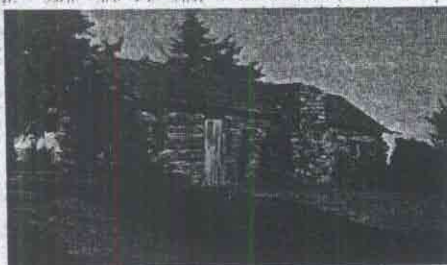

Big Brother Computers Are Prying Into Your Secrets

This column is reproduced exactly as it appeared in a *Councilor* printed and distributed August 3, 1970—nearly 5½ years ago. The reason we reproduce it today is to show that the seeds boldly planted by this newspaper do sometimes grow up and bear fruit.

Copies of the column were distributed to 7,000 Leftists and self-styled "liberals" in key positions in the U.S. Our tactic was to remind them that Big Brother government not only persecuted patriots in 1970, but that it could also keep tab on the sex lives and personal lives of Leftists and "liberals." We also reminded them of a fact that some of them were beginning to suspect: That Leftists could be liquidated when they would be more valuable as martyrs than as living firebrands.

We knew that there were not enough loyal patriots and independents in Congress to end the infamous Coincels operation or the computer banks. We knew that it would be necessary to broaden the base of the attack.

We leave it to our readers to judge whether this campaign started by *The Councilor* in 1965 and prodded thus in 1970 was worth the postage and printing costs. You can breathe just a bit easier for our having made this effort.

We hesitate to use the inexact terms "liberal" and "conservative" in this column because they are so nebulous.

But in a general way a certain segment of America's people classify themselves as "conservatives" and another segment uses the "liberal" term. In most issues these two segments are opposed to each other.

But we know of three areas in which thinking "liberals" and thinking "conservatives" speak with one heart:

(1) The sacrifice of young men in a foreign war that our government does not intend to win.

(2) The use of political assassination to liquidate those who are no longer "useful" to the revolution (as in the case of Martin Luther King and perhaps the Kennedys).

(3) The compilation of data banks by the federal government, and the free exchange of information of this type between federal, state and local governments.

This Column is concerned at the moment with Point (3). We find that certain large universities—Princeton comes to mind—have faculty members who are working with federal and state agencies to build "data banks" that would make Joe Stalin blush.

Politicians at every level are cooperating in this sad invasion of privacy—often in direct conflict with federal and state laws that have not been repealed.

With today's computers, it is possible to feed information about one person, gathered from a hundred different sources, into central computers at Washington (or at Princeton). The social dreamers and planners who are building these data banks have ambitious plans that are suggestive of George Orwell's 1984.

The data bank plan calls for keying all of this information to

having a contact in the data bank system.

(2) Driving records, records of divorces, legal separations, certain marital squabbles will be added to the "information files."

(3) School records (including opinions of teachers and administrators) will be fed into the data bank, along with records of sex questionnaires, and very delicate information gathered by schools and agencies who claim when they gather it that it is "completely confidential."

(4) Add to this the results of profile tests—such as the Iowa Test—given to children in public schools which show such things as prevailing political thinking within a home, number of firearms in the house, and whether the children love their father more than their mother.

(5) In some states identification photos are taken when applying for an S.S. coded driver's license. Military I.D. photos exist by the millions. All of this can be called out of the computer by simply punching the S.S. number for an index of the master file of photographs.

(6) The Data Bank dreamers hope also to get nude photographs of both males and females under color of "medical studies" but to date they have had only limited success in this field. But give them time. They can think of a lot of excuses.

(7) They also want key insurance and medical records for their data banks, along with information about hobbies, human weaknesses and political connections. Letters written to "advice" columns in the newspapers, tips from twisted clergymen and perhaps from a few renegade psychiatrists and marriage counselors are additional targets of the data bank planners.

Social Security numbers. They are already so successful that persons who do not have a Social Security account are forced to get one in order to perform the simplest tasks.

For instance, most states now require the driver to give a Social Security number in order to get a driver's license. No S.S. number; no drive. This is clearly a violation of the United States Constitution and many state constitutions, but we know of nobody who has challenged the unjust practice.

A Louisiana resident who for religious reasons—or other reasons—refuses to apply for a Social Security number will soon be a pedestrian.

Students enrolling in certain tax-supported colleges are informed that they cannot get dormitory rooms unless they take S.S. numbers.

Banks—most of them—key their savings accounts to S.S. numbers. Hundreds of federal, state and local agencies do the same.

Unless someone acts rather quickly, here are some of the probabilities before 1984:

(1) All tax and business records will be available to central computers, coded to a person's S.S. number. A business competitor can get a complete financial profile of the most delicate business information simply by

person with questionable motives can "tap" the data bank. They can learn more about a man's wife than he knows himself, acquire copies of her x-ray photographs, mug shots, and in a few instances, nude medical photos. They can learn more about a woman's husband than she knows herself. They can quickly learn intimate details of previous marriages and divorces. They can learn how to best get your last dollar. Or, if they don't like your politics they can get information to blackmail you or to get your notes at the bank called, or get a list of your customers to donate or sell to your competitor in business.

We recall that one great American (Gen. Edwin Walker) was sent to a federal "mental health" center on the basis of information in newspaper clippings that proved to be false when examined by trial juries.

Think how much more "Big Brother" can do to get you locked up at the Funny Farm if they know more about you than you know about yourself.

It's time that both "liberals" and "conservatives" join to destroy this computerized nightmare. Just for beginners, Congress and state legislatures should immediately provide penitentiary sentences for any federal or state employee who uses a Social Security number to code any information EXCEPT the Social Security account files. With that done, we can think of the next step. But if we can't prohibit this terrifying misuse of S.S. numbers IMMEDIATELY, the future is bleak for those who love privacy. Even those with no sin, no shame and no financial problems; if there be such in America.

Story on Civil War Origin Traced To Another Source

PARIS—For 13 years The Councilor has printed stories showing that the Rothschild Family probably created the U.S. Civil War to serve their own ends.

Among the exciting and brain-challenging stories we have run on this subject were:

(1) Correspondence of Solomon de Rothschild to his family in Europe during a check-out of family flunkies in the U.S. on the eve of the Civil War.

(2) Candlestick Johnny — The Councilor's original research into the strange activities of Louisiana's Senator John Slidell, before, after and during the Civil War. (5) Jackknife Benny — The Councilor's original research into the strange activities of Louisiana's Senator Judah Benjamin, who was a law partner of Slidell.

He appears to have been a Rothschild agent.

Did The Councilor just "dream up" such a theory of the origins of the Civil War? Or did others share the view?

Before any member of the staff of The Councilor was born, Conrad Seim printed in *La Vieille France* (March 1921) statements he said he obtained from Bismarck.

Bismarck, a German statesman (1815-1898) was pro-Christian during much of his lifetime. (See *Treitschke, Deutsche Geschichte im XIX Jahrh.*, 5:364).

Bismarck was quoted as saying, in part:

"The division of the United States into federations of equal force was decided long before the Civil War by the High Financial Power of Europe. These bankers were afraid that the United States, if they remained in one block and as one nation, would attain economical and financial independence, which would upset their financial domination over the world.

"The voice of the Rothschilds predominated. They foresaw tremendous booty if they could substitute two feeble democracies, indebted to the (Kharzar*) financiers, to the vigorous republic, confident and self-providing.

"Therefore they started their emissaries in order to exploit the question of slavery and thus to dig an abyss between the two

parts of the Republic. Lincoln never suspected these underground machinations. He was anti-slavery and he was elected as such. But his character prevented him from being the man of one party. When he had affairs in his hands, he perceived that these sinister financiers of Europe, the Rothschilds, wished to make him the executor of their designs.

"They made the rupture between the North and the South imminent! The masters of finance in Europe made this rupture definitive in order to exploit it to the utmost. Lincoln's personality surprised them: They thought to easily dupe the candidate woodcutter. But Lincoln read their plots and soon understood that the South was not the worst foe, but the (Kharzar*) financiers. He did not

confide his apprehensions; he watched the gestures of the Hidden Hand; he did not wish to expose publicly the questions which would disconcert the ignorant masses.

"He decided to eliminate the international bankers, by establishing a system of loans, allowing the states to borrow directly from the people without intermediary. He did not study financial questions, but his robust good sense revealed to him that the source of any wealth resides in the work and economy of the nation.

"He opposed emissions through the international financiers. He obtained from Congress the right to borrow from the people by selling to it the "bonds" of the states. The local banks were only too glad to help such a system. And the government and the nation escaped the plots of foreign

financiers.

"They understood at once that the United States would escape their grip. The death of Lincoln was resolved upon. Nothing is easier than to find a fanatic to strike.

"The death of Lincoln was a disaster for Christendom. There was no man in the United States great enough to wear his boots..."

A Prediction

In the next paragraph of this "Bismarck Statement" was an amazing prediction. Whether Bismarck made it prior to his death in 1898, or whether it was a forgery, it nonetheless appeared in print 55 years ago. The prediction:

"I fear that the (Kharzar*) banks with their craftiness and tortuous tricks will entirely control the exuberant riches of America and will use it to systematically corrupt modern civilization. The (Kharzars*) will not hesitate to plunge the whole of Christendom into wars and chaos..."

(Editor's Note: For the sake of clarity, we have substituted the word "Kharzar" for the incorrectly translated terms "Jew" or "Jewish." Our reason is that we have learned from actual experience that beginning students confuse these latter terms with the Hebrews — an Old Testament people who have little, if any, blood relationship to the modern Kharzars. The Kharzars rejected Christianity and Mohammedism almost a thousand years after Christ's crucifixion and adopted a mercantile form of the old Babylonian Talmud as their code. The longest recorded genealogy of any of these people goes back no further than 1300, and it is questionable. They are a Turko-Finnish people, but with other adulterations of their bloodstream ranging from the Nordic conquerors of the Eastern Russia to the Nether Asiatics. They call themselves "Ashkenazis" as opposed to the Semitic-looking Talmudists who call themselves "Sephardics." Infiltration of denominational headquarters has prostituted a great deal of Christian literature into a denial of Bible history, and the false equation of Kharzars with Hebrews. We do not wish to contribute to this mockery of the scriptures and therefore try to use more exact terms.)

On Trail of Red Head Man

Word Clues Suggest Ancient Crossings of the Atlantic

MERIDA, Yucatan — Previously in this series we have pointed out that some of the words in the Pre-Columbian languages of Central America were the same as words in the ancient Greek, and had the same meanings.

It is possible that the Greeks were among the European nations which had contact with Central America long before Columbus.

At first we dismissed as fanciful the theory that the Maya took their name from the Greek goddess Maia, wife of Pan.

(1) At Panuco, or Panca, the Spaniards found upon their earliest visits to Mexico superb temples and images of Pan. The place name means literally "city of Pan."

(2) The ancient capital of the Maya was called "Mayapan." Could this be a combination of the two Greek names?

(3) Brasseur de Bourbourg claimed evidences that Pan was adored in all parts of Central America and Mexico.

(4) Diego de Landa in 1562 commented upon this subject. Some of this information is found in "Relacion de las Cosas de Yucatan," published in Paris, 1864.

(5) According to Professor John T. Short, the word "pan" or "pani" in the Nahuatl language of pre-Columbian Mexico means "equality to that which is above."

(6) Short claimed also that the term "Pentecost" meant "progenitor of all beings."

Certainly the worship of Pan—if he was one of the Maya's gods as well as one of the Greek gods—was not an all-consuming religion of the North American ancients. There were many other gods and idols among them.

So You Really Believe That Censors Aren't Active?

HOUSTON—Just because you can see an X-rated movie or buy pornography at the corner drugstore, don't think the censor is dead.

He's alive and thriving. He works double-time for the little gang of imposters who are trying to erase America's traditions, glory, good will, honor, integrity and search for Truth.

Songs are being rewritten.

History—already badly warped by lazy PhDs looking for a quick textbook buck—has been bent to an unrecognizable configuration. Books have been taken from public libraries and school libraries.

Literature has been expunged of facts and traditions. Even school mascots have been ousted if they don't fit into the politically acceptable pattern.

You may naively believe that

such censorship and revisionism are evident only in the Soviet Union and Castro's Cuba or in the boondocks of our "new ally"—Red China. Think again. It's going on around you.

In Virginia — for instance — the state song is "Carry Me Back To Old Virginia." It has been a traditional song of good will and its only mention of black people was a kindly use of the word "darkie."

Several schools using the "Rebel" emblem as mascot have been ordered to quit using such a tradition.

Although the Magna Carta was basic to the system of law adopted for the United States and in 49 of the 50 states, it is

extremely difficult to find an un-expurgated copy of the Magna Carta today. It is mentioned in textbooks and history books, but key provisions are never cited out of deference to ADL types.

The United States Constitution is omitted from many school texts today. Perhaps it is because pupils will notice that the first, fourth, fifth and fourteenth amendments are regularly violated by the federal government itself. Perhaps it is because the fourteenth amendment guarantees that white people will have the same rights to jobs, promotions, grants and privileges as colored people — a guarantee that is violated before their eyes. Perhaps it is because the Constitution originally outlawed any such tax system as the federal income tax, or that in the beginning the Constitution counted colored slaves as being equivalent to 3/5ths of a free white person, for purposes of the census.

Remember the little book which we read in Grammar School entitled "Little Black Sambo"? It referred to a youngster and tigers in India. But for some idiotic reason or another, this innocent little fable has been expunged from literature in many parts of the country.

Remember the sweet old song, "Moonlight Bay"? It's been rewritten to erase the reference to "darkies singing."

The censor slipped up a few weeks ago, however, when the post office issued a series of bicentennial stamps depicting the flags of 50 states. The Georgia flag and the Mississippi flag each reproduce the Confederate Stars & Bars as part of their official emblem. If the censor had chopped these two offenders, there would have been a very touchy problem, because the Hawaii state flag reproduces the Union Jack used by soldiers of George III.

How about Huckleberry Finn? It's been censored to rename Mark Twain's "Nigger Jim" as "Big Jim."

It is forbidden for daily newspapers to print stories which discuss the stupidity or other lack of qualification of some of the colored school teachers in tax-supported public schools. There's no federal law on the subject, but the ax falls on any daily which dares to report criticism of black teachers — even if it gives equal space to those who glorify such black teachers.

Example: The Shreveport Journal recently dared to report the views of eight school principals who complained that many of their black teachers — hired under federal court orders — had flunked the subjects that they were hired to teach. The principals reported — honestly — that pupils in such classes often knew more about the subject than their teachers and that this is one of the reasons that students are being graduated with inadequate education.

After the Journal dared mention the forbidden subject — although it gave even more space to the "other side," — it was attacked by civil rights leaders and professional black agitators. They held public meetings to plan a boycott of advertisers in the paper which

dared tell a part of the truth! One colored lawyer — on the public payroll as president of a tax-supported university — threatened to get a federal judge to issue a gag rule against the Journal. Here we have a man sworn to uphold the law and presumably trained in the law, willfully agitating to bring about a violation of the First Amendment!

Speaking of censorship, do you remember what happened to John Schmidt when he ran for president four years ago on the American Party ticket? The networks knew that if they gave proper and fair treatment to Mr. Schmidt and the American Party, that the party would grow as a realistic alternate to the Demopublican Party. So they almost completely ignored Schmidt and the American Party! Most Americans never even knew that they had an alternative.

Another form of censorship is demonstrated by magazines and networks in their hatred for the late Senator Joseph McCarthy. They continually deride the long-dead patriot and imply that Senator McCarthy was an untruthful man. But they never repeat any of the senator's truthful predictions and truthful revelations, so the public has no way of fairly judging what the man had to say.

This is the most vicious of all forms of censorship because it is a "secondary censorship." Its purpose is not necessarily to

create hatred of McCarthy, because he is no longer a threat to the interlopers. But by smearing the memory of Senator McCarthy over and over and over, they are getting the message across to other congressmen and senators. The message: "You, too, could die a mysterious death and your name would become synonymous with falsehood and hysteria if we chose to make it such — so that your children and your grandchildren would suffer in the generations to come."

The name of Jesus Christ is not to be mentioned in a friendly

fashion in the public schools today. That is forbidden. But it is okay to make false claims in behalf of Martin Luther King or Malcolm X, because their liquidations converted them to martyr symbolism for the very assassins who did them in.

Before you read this issue of The Councillor, had you ever heard that James Earl Ray had a contact number in New Orleans? Had you been permitted to read that the number was allegedly that of a controversial part of the Louisiana State police which since 1967 has operated as a philosophic extension of the New

Declaration of Independence is Obsolete to 124 Congressmen

PHILADELPHIA — A delegation of 10 congressmen, representing 92 House members and 32 senators, signed a "Declaration of INTERdependence" during ceremonies at Independence Hall here, brushing off shouts of "traitor" and "Tory" from 200 citizens on the streets outside.

The document, a parody of the language in the Declaration of Independence, signed 200 years ago in the same room, calls for "...one global community, dependent on one body of resources, bound together by ties of common humanity and associated in a common adventure on the planet Earth."

The declaration of INTERdependence is promoted by the World Affairs Council and other groups favoring global government. A formal call for interdependence is planned for July 4, 1976, the anniversary of the signing of the Declaration of Independence.

The INTERdependence Declaration asserts that "to establish a new world order of compassion, justice and security, it is essential that mankind free itself from the limitations of national prejudice ... that all people are part of one global community."

Author of the preamble was Dr. Henry Steele Commager, a well-known, left-leaning historian.

News of the incident has been minimized in the nation's press. Stories did not appear in either the "Washington Post" or the "New York Times." The Philadelphia "Inquirer" gave it front-page story and photo space in reaction to the citizen protests led by evangelist Dr. Carl McIntire, who told the crowd through a bullhorn:

"The next in order will be a Declaration of Dependence — surrender."

When former Sen. Joseph Clark began to read the names of the INTERdependence signers in Congress, an elderly woman rose in the balcony to protest. "You are traitors," she shouted.

"Take her away, take her away, Clark screamed, and a gang of National Park Rangers removed her. "This is a Communist state," said the woman, Catherine Brown, 82 of Cherry Hill, N.J. "We don't have Patrick Henry any more." "Those who oppose change will not be able to change our determination to move forward," Clark said as the woman was taken away.

Promoters of one-world government are using bicentennial events as part of the continuing campaign to condition public opinion. The Atlantic Union Committee and other groups have publicly called for the U.S. to surrender national sovereignty to a "Federal Atlantic Union" during the past 20 years. They call it an essential "first step" toward world government (NATIONAL SPOTLIGHT, Sept. 24, 1975).

This is of the greatest importance to the American people. It reveals that here are men willing to surrender the integrity of the nation's independence and sovereignty.

People are raising questions concerning the loyalty of these men to their oath of office. To

swear to maintain and defend the Constitution of the United States as all have done and then sign a document that calls for the incorporation of the United States in some form of world superstate involves a conflict. The entire list is as follows:
