

SUBJECT: Assassination of President Kennedy

Reference is made to your memorandum dated December 30, 1963, concerning color photographs allegedly in possession of Mr. Robert Earl Croft, 709 Clarkson, Denver, Colorado.

Mr. Croft has been contacted and states that [he is in Denver on a two-year mission for the Church of Jesus Christ, Latter Day Saints.] He works out of the Western State Mission, located at 709 Clarkson, in Denver, telephone No. 623-4542, but he lives at 474 S. Lafayette, telephone 777-9328.

Mr. Croft stated that the Federal Bureau of Investigation had possession of the pictures for about two weeks, and upon their return to him just two days ago, he mailed them to his permanent home in Powell, Wyoming. He readily agreed, however, to write to his family and have the photographs returned to Denver. Upon their arrival here he will notify us, at which time we will review them and then report further to you regarding their content.

SUBJECT: Assassination of President Kennedy

Further reference is made to your request to review some color photographs held by Mr. Robert Earl Croft, covering the Presidential Motorcade in Dallas, Texas, on November 22, 1963.

Mr. Croft turned over the color transparencies today and we have reviewed the entire roll of film. Only three of the photographs are of the Presidential Motorcade, all the other pictures in the group covering subjects completely unrelated to the November 22 incident.

It is my opinion that these photographs have no value to us. Two pictures show the Presidential limousine, and the other covers only the advance motorcycles. The two of the Presidential limousine clearly show the occupants, but do not show agents in the follow-up car nor do they portray any unusual activity which appears to be related to the attack.


