WHO IS TRYING TO KILL H RES 9? and will continue to try (11/6/77)
and Kill

The one man most visibly trying to kill H RES 9 is Washington Post reporter GEORGE LARDNER whose stories on the Select Committee on Assassinations have been something less than favorable to the necessary reconstitution of this vital committee.....

This blocking action is similar to the spectacular obstruction of the first legal investigation of the assassination of JFK, ten years ago:

On the morning of Feb 22, 1967 Dave Ferrie, the standby getaway pilot for the Dealey Plaza assassina, was found dead in his bed....

.... Ferrie died of a berry aneurism, the rupture of a blood vessel at the base of the brain which caused a hemorrhage
(Boston Herald, Feb 23, 1967)

.... He was last seen alive at 4AM that day by Washington Post reporter George Lardner who had interviewed him between midnight and four o'clock. The Coroner first put the time of death at prior to midnight but after conferring with Lardner he said Ferrie must have died shortly after Lardner took his leave....
(Plot of Politics, by James & Wardlaw)

.... one of the mysteries we don't understand is the inconsistent elements regarding the time Ferrie died. Dr Chetta reported the death to have preceded 4AM because of the rigor mortis state of the corpse (a former CIA agent stated under certain conditions) he was willing to testify on the following points:
.... 4) in my opinion, the probable murder of David Ferrie.....
(The Kennedy Conspiracy by Paris Flammonde)

Who Killed JFK? Who Killed MLK? Who killed Dave Ferrie and a hundred others connected with the conspiracy and its coverup? ... finding these and many other answers is the work of the House Select Committee on Assassinations whose life is assured by H RES 9. Thank Heaven it passed.....

.... Who Killed Dave Ferrie?

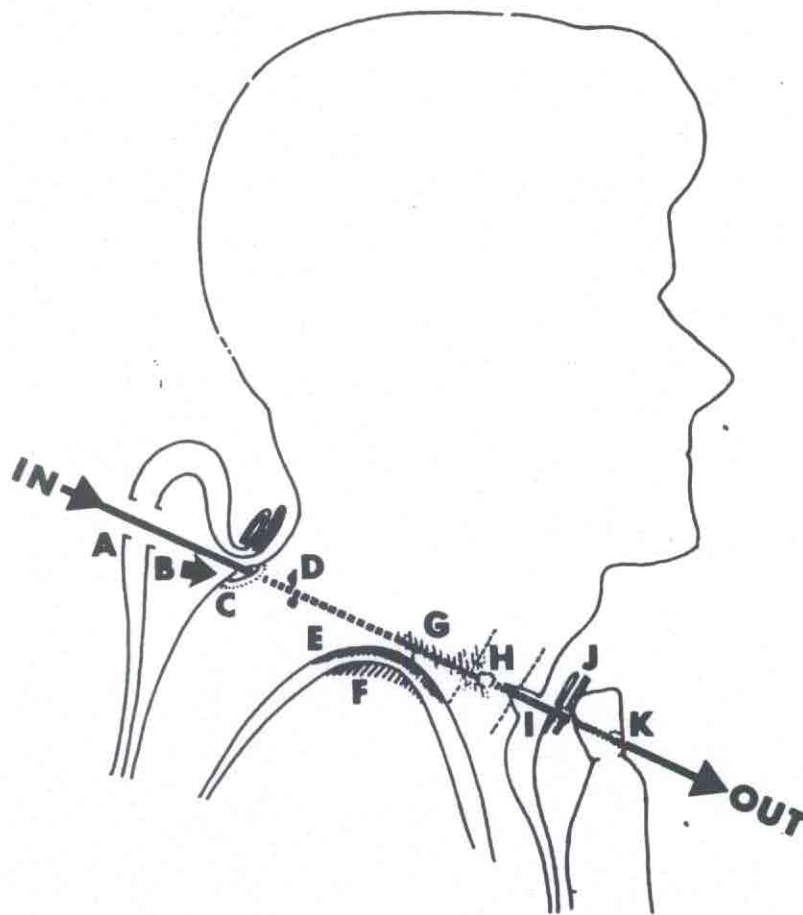

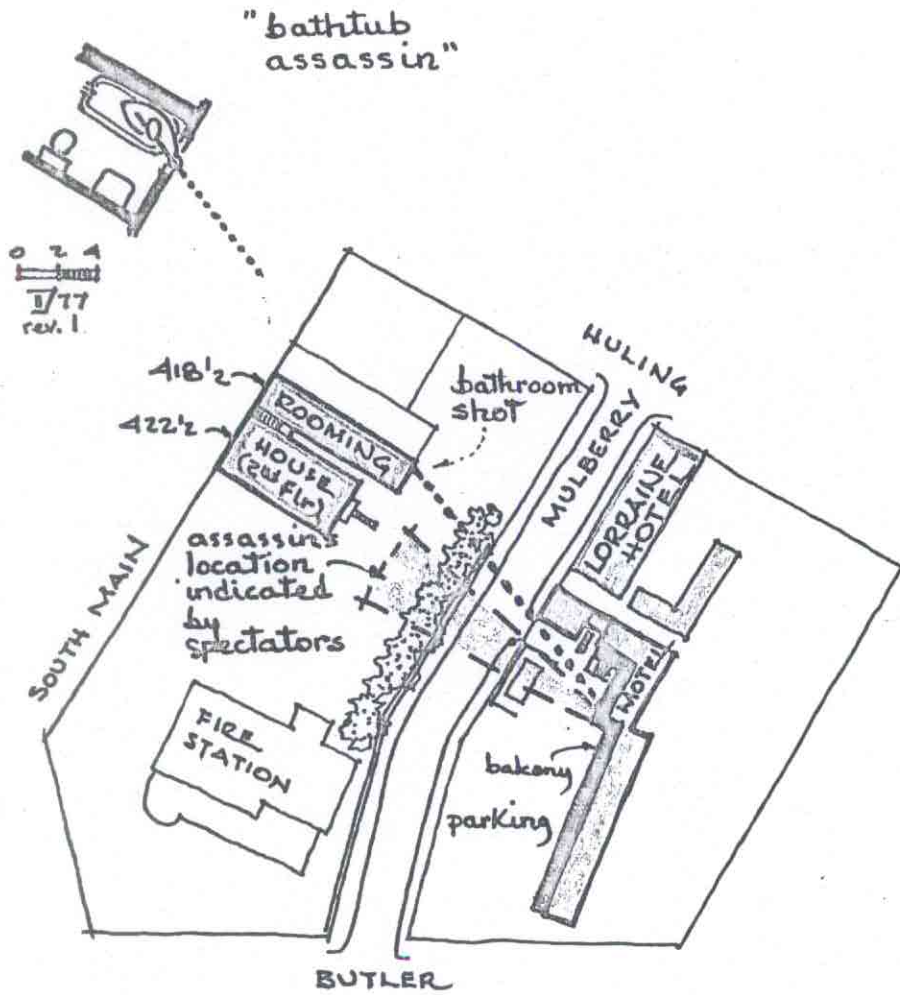
