Mrs. Linda Jackson is the present manager of the apartment  
house where Jack Ruby lived.

Mrs. Jackson presented records indicating that Jack Ruby  
moved into Apartment 105 at 4727 Honor on January 3, 1959  
and moved from this location on July 1, 1961. These  
records further indicate that Mrs. Eva Grant, sister of  
Jack Ruby also lived in this apartment. At the time Ruby  
rented the apartment, he gave personal references as  
Stanley Kaufman, a local attorney and Alice Nichols of  
DAI-3887.

Mrs. Jackson states that she does not know Jack Ruby nor  
has she ever seen him and the tenant records in her office  
do not reflect any unusual circumstances occurring during  
the time Ruby was a tenant.

Pursuant to the instructions of CAPTAIN W.P. GANNAWAY a background investigation was conducted on SUBJECT and the following is submitted.

Confidential informant T-1 states that SUBJECT was born 18 April 1921 in NEW HAVEN, CONNECTICUT, the son of DAVID JACOBSON. SUBJECT'S father now lives at 104 SHERMAN, NEW HAVEN, CONNECTICUT. SUBJECT is married to RUTH NEUMAN JACOBSON, daughter of OSCAR NEUMAN of 12 W.72nd ST., NEW YORK CITY.

T-1 states that SUBJECT has been a DALLAS resident since 1949 and now lives at 6121 PRESTONHAVEN. SUBJECT formerly lived at 3608 N. FITZHUGH. He maintains an office at 3707 GASTON AVE. and specializes in Dermatology.

Source further stated that SUBJECT was in the U.S. AIR FORCE from 1942 until 1945. Type of discharge is not known.

The indices of the TEXAS STATE BOARD OF MEDICAL EXAMINERS failed to reveal any derogatory information on SUBJECT. These indices revealed the following information on SUBJECT. SUBJECT was born in NEW HAVEN, CONN. 4-18-1921. SUBJECT attendd the UNIVERSITY OF IOWA SCHOOL OF MEDICINE from September 24, 1945 until June 10 1949 at which time he received his B.A. and B.S. degrees.

SUBJECT completed his internship at the UNIVERSITY OF PENNSYLVANIA HOSPITAL in 1951. He practiced medicine with DR. D.M. PILLSBURY and DR. HAROLD DANA at 3400 SPRUCE in PHILADELPHIA, PENNSYLVANIA. During this period, SUBJECT resided at 2220 SPRUCE ST. in PHILADELPHIA.

On 1 February 1954, SUBJECT was granted a license to practice medicine in the State of ARIZONA, license # 2586. SUBJECT did not practice medicine in that state after receiving his license.

On 22 June 1954, SUBJECT was granted a license to practice medicine in the State of TEXAS, license # C-4165.

Confidential informant T-2 states that SUBJECT is a Dermatologist and received his medical training at the UNIVERSITY OF IOWA. SUBJECT was a navigator-bombardier in the U.S. AIR FORCE from 1942-1945. T-2 further stated that SUBJECT applied for \$ 100,000.00 in life insurance in 1959 from MUTUAL BENEFIT LIFE INSURANCE CO. At that time, SUBJECT had \$ 45,000.00 life insurance in force. SUBJECT is a member of the PRESTON HOLLOW COUNTRY CLUB and SHEARITH ISRAEL SYNAGOGUE. T-2 states that SUBJECT earns in excess of \$ 50,000.00 annually. SUBJECT has made two (2) trips to EUROPE.

The indices of the Records Bureau of this Department failed to reveal an arrest record on SUBJECT. This search of indices was made by Clerk Pat Wise. These indices did reveal that SUBJECT was issued a traffic ticket 4-9-1962 for Running a Stop Sign at NORTEHAVEN and N. CENTRAL EXP. SUBJECT was driving a 1958 Renault, 1962 TEXAS license IR 6122. SUBJECT was fined \$ 5.00 for this violation. SUBJECT gave his home address as 6121 PRESTONHAVEN.

The indices of the Identification Bureau of this Department failed to reveal a criminal record on SUBJECT. The search of indices was made by Clerk Vickery.

The indices of the Identification Bureau of the DALLAS COUNTY SHERIFF'S OFFICE failed to reveal a criminal record on SUBJECT. The search of indices was made through Deputy Kitchings.

The indices of the Driver's License Division of the TEXAS DEPARTMENT OF PUBLIC SAFETY revealed that SUBJECT

is holder of TEXAS Operator's License # 2933548. SUBJECT was described as being a w-m, dob: 4-18-21, 6'2, 220#, brown hair, brown eyes, home address: 6121 PRESTONHAVEN, DALLAS.

The indices of the local F.B.I. office failed to reveal any information on SUBJECT. The search of indices was made through Agent BOB BARRETT .

Sir:

I contacted a confidential informant who stated:

That this doctor has been interviewed by the FBI and a private investigator hired by Mr. Belli.

That the doctor has known Jack Leon Ruby since 1956 socially and professionally. Ruby has visited his home on several occasions, and the doctor has visited Ruby at the Vegas and the Carousel Clubs. They have attended a synagogue together. The doctor states that he is a friend of Jack Ruby's. He states that Ruby does not drink and is religious on Holidays and Special Occasions.

The doctor describes Ruby as flamboyant and excitable with no stable emotions. He stated that Ruby has a great deal of nervous energy and a good attitude toward everything. That Ruby had not discussed politics with him, and the doctor knows no one associated with Ruby. The doctor is on the staff of a children's hospital, and Ruby furnishes an orchestra to entertain the children each year and charges only enough to cover the expenses.

The doctor does not know Lee Harvey Oswald, and Ruby has never mentioned his name. He stated that he has never seen Ruby with a foreigner and has never seen him flash large amounts of money.

The doctor stated that Ruby called him about 4 or 5 P.M. November 22, 1963 and asked what time services would be held for President Kennedy at the synagogue. The doctor said that Ruby did not have his usual "breezy" attitude and normal tone of voice. He seemed upset.

The doctor is a professor of psychiatry at some medical school.
