The doctors told us that it is not as serious as it was before but they hospitalized him immediately this time when the trouble started again. We have not heard another word since that call. Buck is spending all day, every day, doing nothing but sitting by the telephone. Buck thinks they are going to release him completely from the Army, but I don't know...
