Dear Gary,

Glad to get your 10/10 from Dallas. What you say of Mary is, if you recall, pretty much what I wrote you after I met her and Arch at Budds. I do not know how much I'll have time for and still get this in tonight's outgoing mail. You'll find a day's reading when you get back to Mpls. I've been accumulating many things for you and will mail them in time, now that I know your projected plans. If I didn't tell you earlier, Moo has promised me the transcripts. I also tell you some of what he promised could have been here by now.

The real reason for haste is to assure you it is fine to give Mary the WDCU footage. However, be certain to caution her that as a condition of getting it I "swore away my life", as Planer put it. This boiled down to no use at all. It is merely for our knowledge. She should not permit copies to be made by anyone. If it turns out there is someone who she thinks should have a copy, we can get her a better one from the negatives Patsy made and I would like to pass on it. Truth is I invited Mary here to rummage through my files. There is little she cannot have and just about nothing she cannot see.

My chief concern in mentioning the west-coast nastiness was that she not get taken in by Lidton. Glad that is not the case. "The old critics", on the west coast and in Texas, means Maggie, Ray, perhaps Bill and Penn. None of this concerns me for I am satisfied about my personal behavior with all of them, of which you have seen a small sample, and am without apprehensions about my "professional" conduct. Maybe Willian also? Same comment.

If I am surprised that Lidton has finally gotten something really significant - and I am - I am also worried about how he'll use it. I know what he told me. I also know the ease with which much of this kind of material can be misused, and I regard him as one more likely to having had my own experience with him along that line.
