ALLEGED ASSOCIATE OF SUBJECT.

ON NOV. TWENTYEIGHT, SIXTYTHREE, TOM PETTIT, WFO CORRESPONDENT,  
INFORMED DALLAS OFFICE HE HAD RECEIVED LENGTHY INTERVIEW WITH AL  
BOGARD, SALESMAN, DOWNTOWN LINCOLN MERCURY, DALLAS, REGARDING  
GIVING LEE HARVEY OSWALD TEST DRIVE OF NEW CORVET CAR PRIOR TO  
ASSASSINATION. BOGARD INFORMED PETTIT THAT JACK LAWRENCE, FORMER  
SALESMAN, HAD CONSIDERABLE INFORMATION THIS REGARD.

DALLAS FILES SHOW JACK LAWRENCE, DOWNTOWN LINCOLN MERCURY,  
PHONED DALLAS OFFICE, ELEVEN AM., NOV. TWENTYTHREE, SIXTYTHREE,  
AND ADVISED LEE HARVEY OSWALD HAD BEEN AFFORDED TEST DRIVE BY  
BOGARD. BOGARD HAS BEEN INTERVIEWED BY DALLAS OFFICE.

ON DEC. FIVE, SIXTYTHREE, FRANK PIZZO, ASSISTANT SALES MANAGER, DOWNTOWN LINCOLN MERCURY, STATED JACK LAWRENCE HIRED OCTOBER TWENTYTWO, SIXTYTHREE, AND FIRED NOV. TWENTYTHREE, SIXTYTHREE, AFTER FORMER SALESMAN HAD TOLD HIM LAWRENCE HAD BCD FROM ONE OF MILITARY SERVICES BECAUSE HAD TRIED TO HELP CASTRO WHEN CASTRO BEGAN FIGHTING IN CUBA.

ROBERT D. TETER, FORMER SALESMAN, ON DEC. SEVEN, SIXTYTHREE, STATED HE WENT DRINKING WITH LAWRENCE AND WAZZ ON DETAILS, BUT REMEMBERED LAWRENCE TELLING HIM THIS.

IN APPLICATION FOR BOND AT DOWNTOWN LINCOLN MERCURY, LAWRENCE STATES FULL NAME JACK ALAN CARROLL LAWRENCE, YMCA, DALLAS, BORN SEPTEMBER FOURTEEN, THIRTYEIGHT, HOME ADDRESS ONE FOUR FOUR TENTH AVENUE, SOUTH CHARLESTON, WEST VIRGINIA, AND PREVIOUS EMPLOYMENTS ST. PETERSBURG, FLORIDA, AND CHARLESTON, WEST VIRGINIA.

RECORDS, DALLAS, YMCA, SHOW LAWRENCE RESIDES THERE OCT. TWELVE THROUGH NOV. THIRTY, SIXTYTHREE, LEAVING FORWARDING ADDRESS ONE FOUR FOUR TENTH AVENUE, SOUTH CHARLESTON, WEST VIRGINIA, PHONE RIVERSIDE FOUR DASH ZERO EIGHT FIVE SEVEN.
