CHARACTER

My name is Sergio Molina, 8238 So. Shore Drive, Chicago, Illinois 60617, (312) 375-8792. Information about myself that led me into putting this information together. I am sure that you will be able to see my qualifications in pursuing this matter. I really do not know how to best inform you of all details of the assassination, itself, I only wanted to present the tactic and only the tactic. My theory information is only a parallel to what the Warren Commission had in their files, but I covered most of all the information that has not been covered by the Warren Commission and the U.S. Select Committee Panel of Assassinations.

I have four (4) years of completed military training (West Point Candidate).

Nine (9) years in technical studies in engineering working in time, space and planning building, and industrial design.

I worked in automotive patternmaking engineering blueprint reading in design for patternmaking of detailed parts.

I checked and doubled checked all theory and tactic information, I am confident you will not find any questionable doubts about its effectiveness.

The time I have put in my investigation has been restrained because I know what the outcome might do to not only the public, but to our Government Security. I must state that at the time after the assassination, I believe Earl Warren had to hold this country together this information would have had devastating results, so I feel Warren did do the right thing even though I do not approve of such actions.

The information I gathered took me a little over two years in research updating and backtracking of each important eyewitness account to what they heard, where they were at the assassination time. What disturbed me, I made sure I did not become over confident in my conclusions, because I realized I came up with a possible perfect crime theory. I have tried to be realistic about who might have invented the Electronic Assassin tactic, all I can take credit for is the putting together a workable assassination plot that might have come from a Central Intelligence source in similarity. The way the tactic works only a government agency would find it useful with the training of a small group to carry out an assassination without a flaw.

Two years ago, I accidentally stumbled on the idea. The information I have sent to you probably would take a few days to understand the tactic as being unique. I was hoping to improve this theory in video form. My expenses have not gone over two hundred dollars to pay for copies and materials.

I believe the conclusion has to be presented to the right person because of the sensitivity of the matter.

My conclusion in theory points to a group or persons connected to carrying out the assassination, all eyewitnesses become obsolete right from the start to finish. One must see the electronic assassin tactic as a circle that cannot be broken from the outside. The circle probably consisted of five (5) to ten (10) men with the knowledge in tactics in assassinations.

One more important observation the length of time of Oswalds' employment was one (1) month. One (1) month to layout preselected route (building & streets) slowdown points known to Secret Service including the knowledge of slowdown along the route next to depository because of turns. By leading Presidential motorcade to Oswald, Oswald also was a target for a setup as for Kennedy it was a high-tech ambush.

The only chance of stopping the assassination was the bubble top that would have canceled the attempt, if the shots of mechanism were discharged with the bubbletop on this would have indicated the limousine was surely booby-trapped, the bullets would have ricocheted all over like inside an armored tank, proving my theory correct.

The symbols in the key helps describe bullet characteristics and purpose in the assassination, the key is meant to be read forwards or backwards in checking time, location of bullet in the investigation. At first I went over the Warren commissions report out of curiosity, like everyone else I kept thinking rifle, sniper location, and motive for the assassination. In attime span of many years off and on I would check all sources that might be of interest in the assassination to develop a theory as to where the shots came from.

On March 14 1983 I made a discovery unconsciously because I was not really thinking of anything in particular the discovery took time to sink into my mind at first I saw it as not important. That thought was on the Bazooka Training film showing the results of firing the weapon, it had principles that I applied to the way the tactic took place also the Warren commissions report helped in knowing the path of the bullets plus other theory reports reduce the possibilities or the odds in this case. At first I saw this Electronic theory as just that, but since it would also apply to our presidents or other leaders present and future I would have to say that the dangers would still exist to those who are not familiar with this tactic even the experts. The reason this Electronic assassin is dangerous it works soley to give an illusion which works flawlessly and to those who become familiar in exicuting the tactic it is quite easy to carry it out. The tactic can be contrlled 3 individuals to get any results they planned just by planting a rifle and tampering with limousine jump seat the harmless looking limo ^{OSIN} wouldntninnanyones eyes mind be subjected in taking part in the assassination. Geometry, Space plus timing was the ingredient in developing the EA tactic to applying it to a complex incident without witnessing the actual event. The EA tactic works the same as a math problem I tried to make this information as clear as possible to all who see this information especially to those who are not familiar with guns or bullet characteristics, the EA tactic in order to be a success needs these elements (below)

Experts would think think the miracle bullet with L.H.O.s rifle bores is the final cwide evidence as to the bullets traveled space over 70yards where in fact it only traveled 20 inches. The throwaway bullet because it had to break theroth the plastic backing of the seat would have a chance to lodge itself in the presidents neck depending on the powder strenght to have the bullet fly towards the socalled Oswald window, even if the throwaway bullet were to miss the president both technics would have been effective. The throwaway bullet had only one purpose and that was in creating the hole plus the angle showing the flight of the miracle bullet.

BY TRADITION ALWAYS WAS-THE PRESIDENT SAT ON THE RIGHT SIDE IN BACK OF THE LIMOUSINE SO THE PRESIDENT COULD NOT GIVE UP HIS SEAT UNLESS IT WAS MOVESITINGG KING OR SOMEONE ALONG THEM LINES. THAT BEING THE CASE THE TACTIC WOULD HAVE VERY LITTLE CHANCE OF FAILURE.

Innmaking the operation possible a group of men each with a job that would work like clockwork in reaching a point of efficiency from repeated training. Each mans job was very simple very little chance they would get caught, the most difficult job on the spot was the man in the grassy noll he needed the C.I.A. credential card wether it was real or not when he presented it to police officer in the parking lot we will never know. The combination of different jobs would automaticly made the tactic more complex and very difficult to solve and if it is solved it was only a matter of chance.

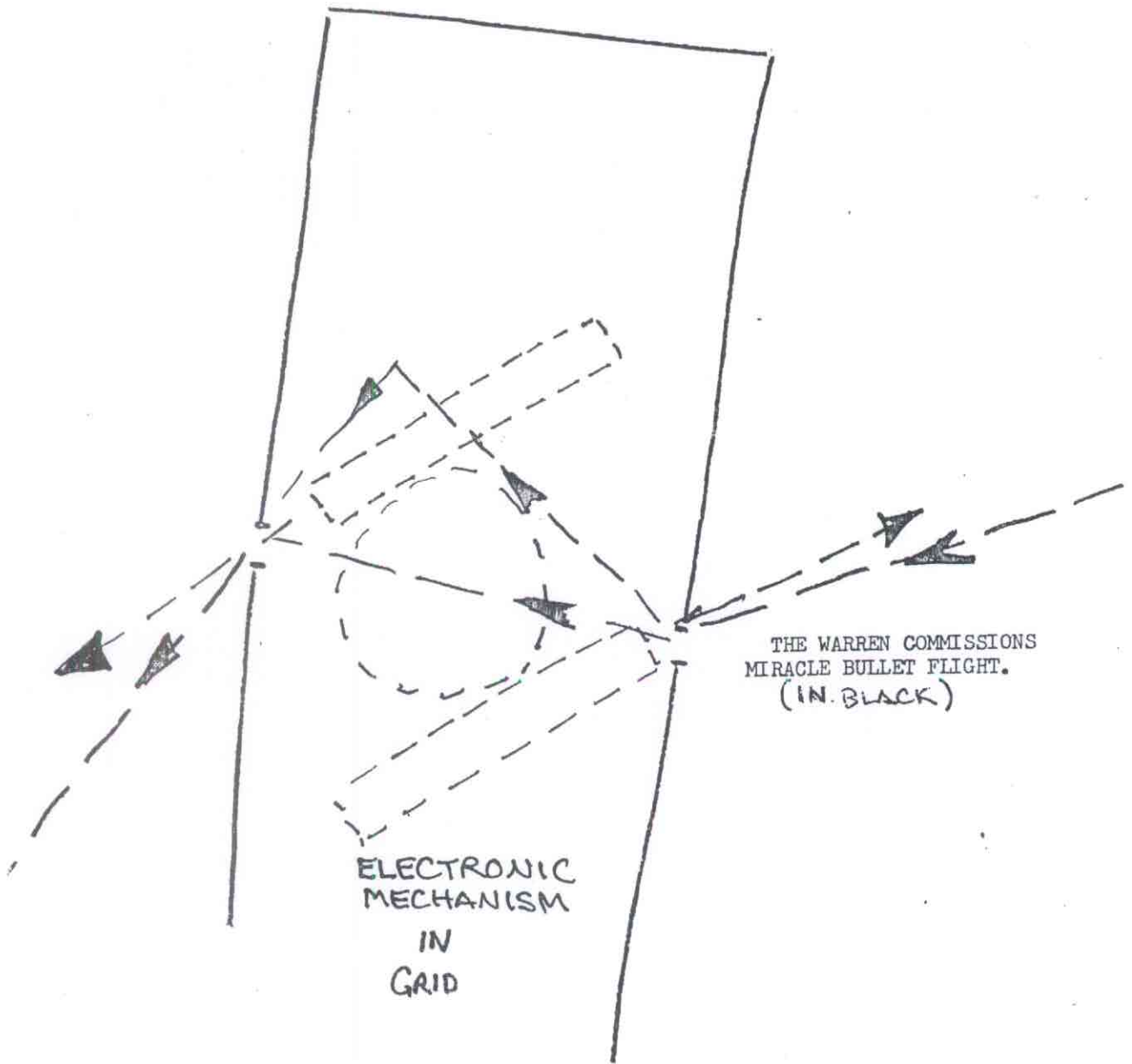

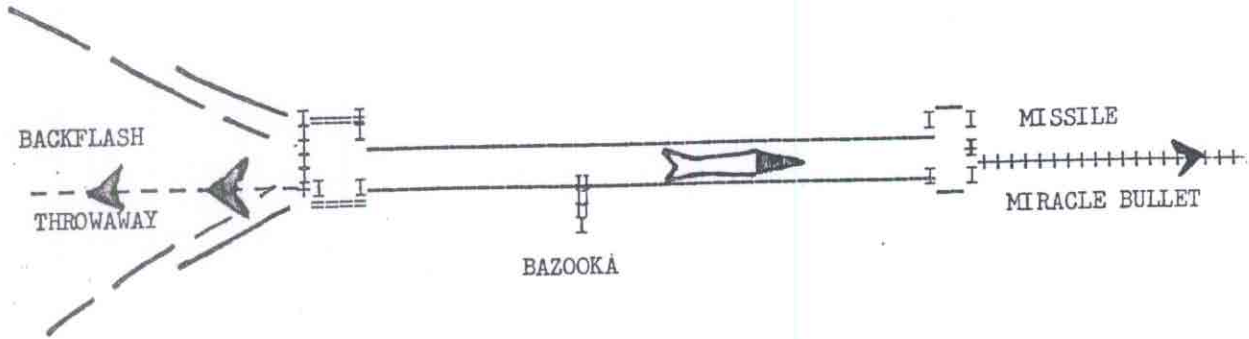

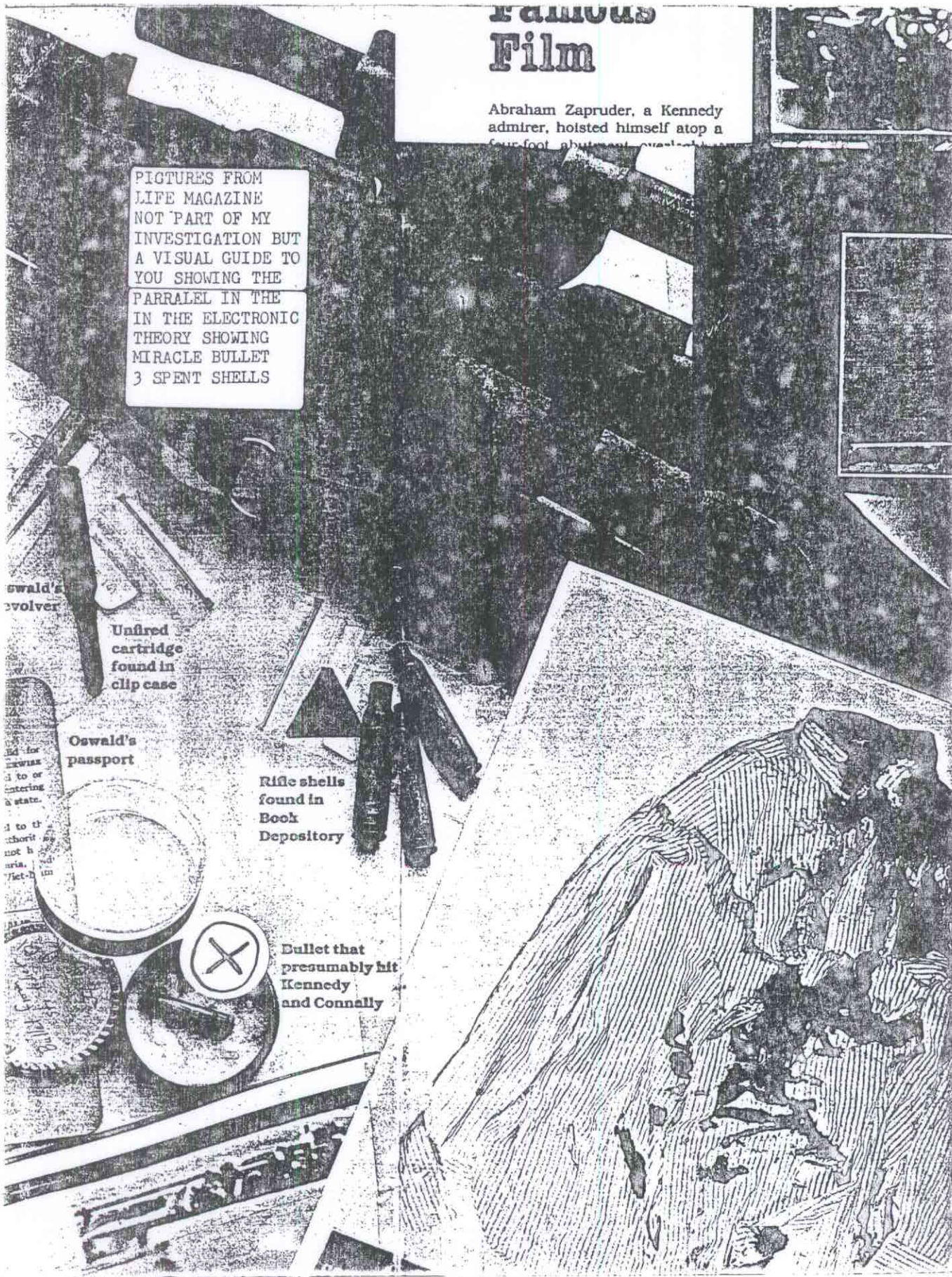

Had only two days notice, were not trained for this job, they were helpless in this situation.

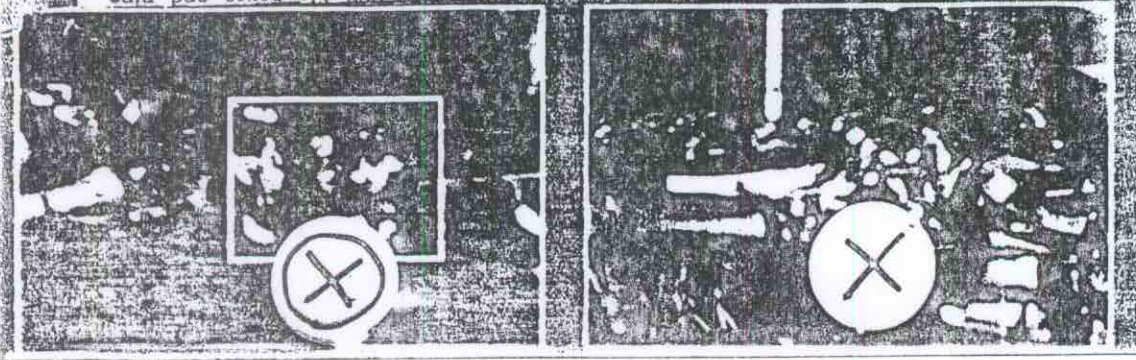
Secret Service

Did not have knowledge of what was going to happen, their job was to protect the President. The President was really dead days or hours as soon as he sat in the back seat there was no way for him to be protected.

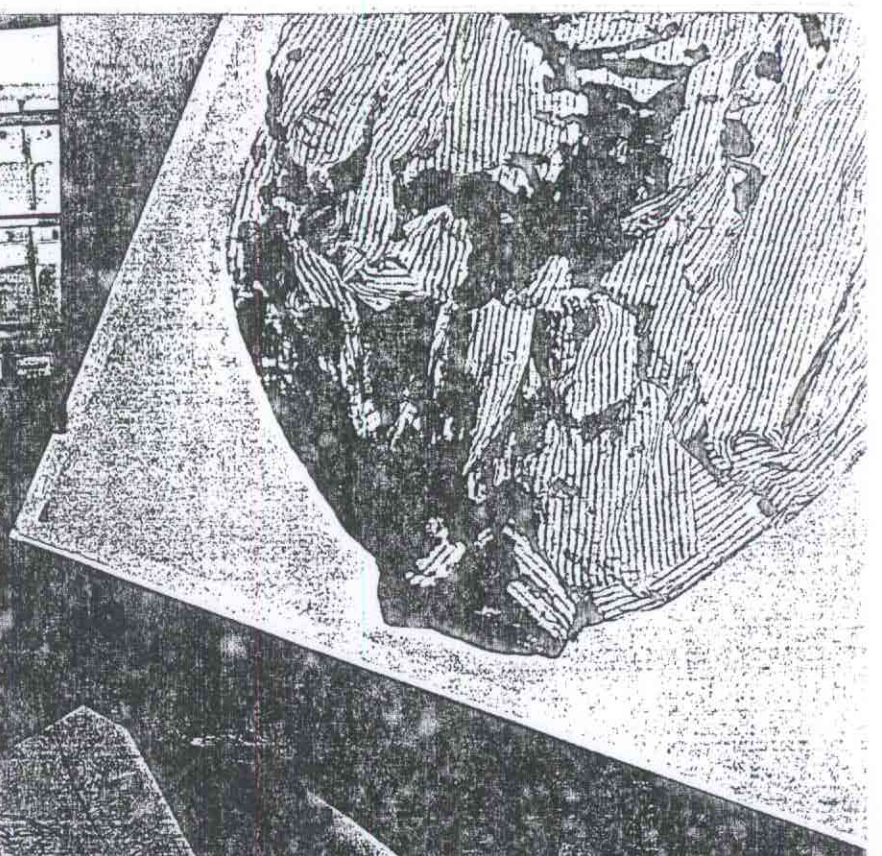
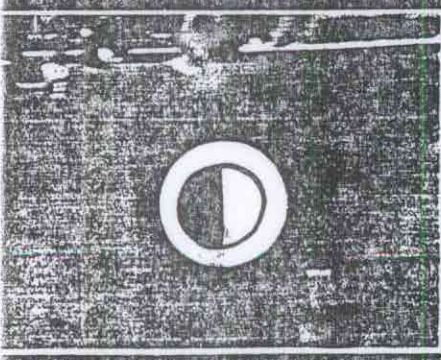

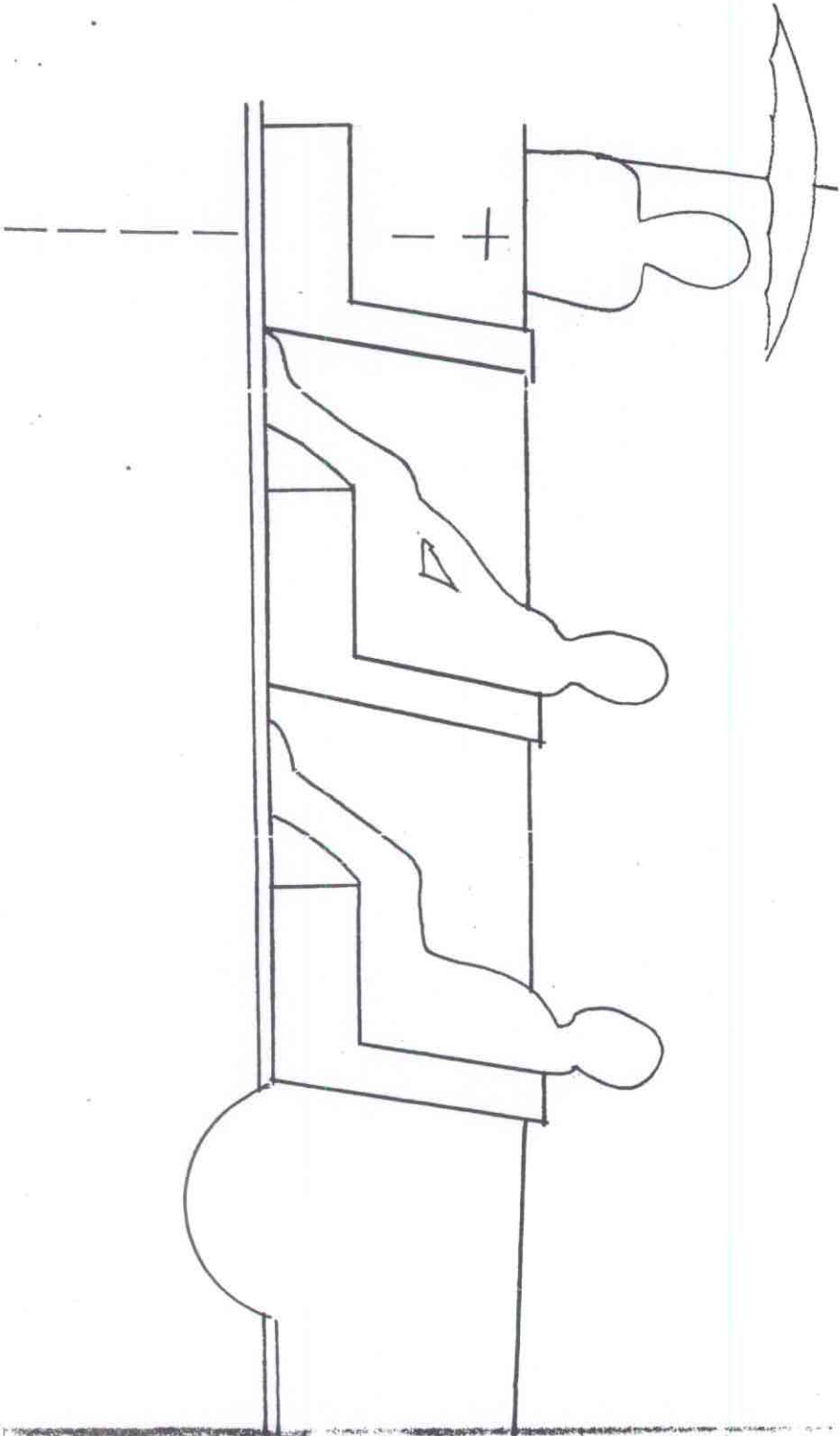

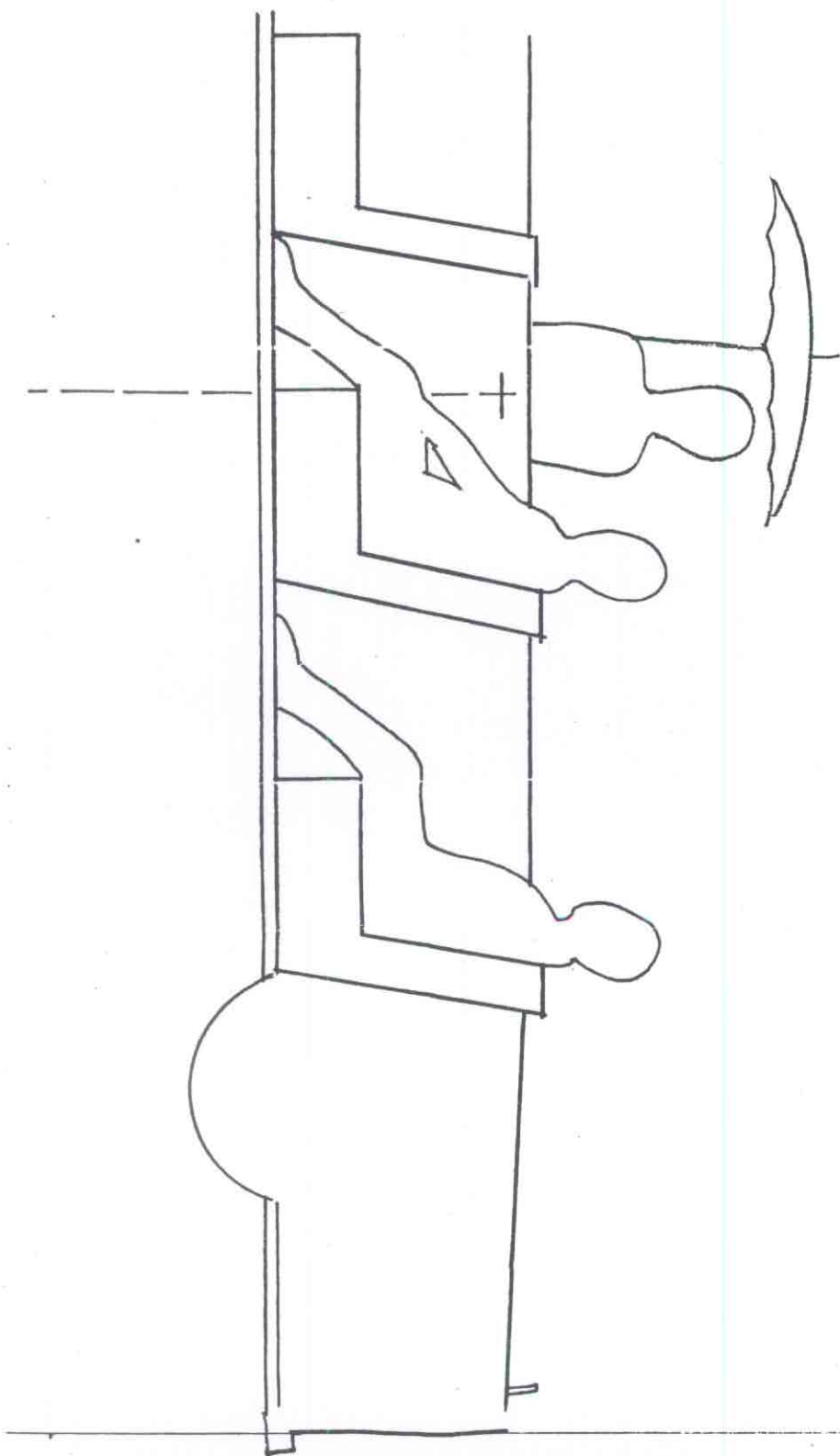
