The H.O. 5/8/77 airtel, Not Recorded, from 105-22555, also in 62-109060 and with illegible side notation for "original filed in", holds details I do not recall having read in any of the H.O. records provided in 70-0322 and other than I have ~~never~~ seen in response to my PA request. The attached LHM holds the info, and it has typical, self-serving FBI lies to cover the FBU, as on page 2, that "arles Quiroga "has in no way been affiliated with the CIA or the ~~CIA~~." In fact H.O. carried him with a T number as a temporary informant and has confirmed this in writing, identifying him voluntarily.

Throughout the LHM, prepared for distribution and thus not containing information the F.B.I. did not want distributed, there are details I do not recall from other H.O. records I've read, most likely because the underlying records were not filed in the Oswald or JFK files but were in the special "arrison files instead. (Nonetheless relevant because my request was for all records and made no mention of either the Oswald or JFK files.)

The paragraph referring to me also holds details I did not see in other H.O. versions. (It is my recollection that I did not receive this under my PA request but I'm not absolutely certain, seeing the other records, not this one.) I do not recall seeing what did not happen, that Bringuer had filed suit against Garrison and me. This also could not explain what it indicated, that "arrison would want to change his plans to lunch with Bringuer. Actually, Bringuer filed a spurious suit against ~~Scan~~ magazine and no over its reprinting of a chapter of ~~Whitewash~~. It was, as Bringuer willingly boasted to the local press, a chance for some publicity. He got a Cuban lawyer to file the case without charging him. Later he joined Dell, and then the whole thing was tossed out of court. The suit ~~he~~ was baseless, did not even allege any inaccurate reporting and there was none. There was no defamation of any kind and all came from the House Warren Commission published materials, quoted accurately. It was a typically crazy Bringuer operation. But it had no connection with "arrison. (The photos in which I was interested and had taken for me did not include the crazy Bringuer's place. It also is not true, as this LHM says, that Bringuer owned La Habana, in which I was interested, over the monumental drunk Oswald alleged threw there. Penn ~~never~~ owned La Habana, Bringuer's store was several doors toward "anal St. from it. I do not recall seeing the actual investigative reports covering the drunk incident and I know I have not seen the reports that include what Penn told the FBI about it. Nor the report to which Bringuer testified before the Commission, that he had given the FBI the license number of the car associated with the man seen with Oswald.)
