conomic Development Conference, showed his copies to the press yesterday.

Lewis was ordered transferred within three or four days of the burglary. The lock on the door of the Media FBI office was changed.

Another FBI agent said the transfer could have been worse.

## Refuses to Talk

"He could have ended up in Butte, Mont. (the traditional spot for FBI agents who have incurred official displeasure) instead of Atlanta."

Lewis stood in the door of his home yesterday when two reporters stopped by.

"I'm sorry," he said. "I can't say anything about this. I'm sure you understand."

His wife, Catherine, stood in back of him. Above the fireplace in the living room was a portrait of the entire family, partially blocked by a St. Patrick's Day card.

## Praises family

"He's a wonderful man," Mrs. Fred R. Small, the Lewis' next door neighbor, said. "You've never seen a lovelier family."

Mrs. Small watched the children — three boys and three girls — as they grew up. Two are honor students in college.

"Rearing children is such a problem today," Mrs. Small said, "yet you've never seen any children nicer than theirs."

The Lewis' bought their house in April, 1961, for \$25,500. Two stories, frame and brick, it has a tree out front and a basketball hoop on the garage out back.

## Upset by Move

"I know how upset she is about moving," another neighbor said. "It's such a shame."

At the Media office of the FBI, a dingy suite of offices on the second floor of the

County Building across from the Delaware County courthouse was Lewis' successor George Bright. He referred all questions to Joe D. Jamieson, agent in charge of the FBI offices in Philadelphia.

The door to the Media office is kept locked now, and answered only when someone knocks. A new lock secures the door.

The scratches are still around the old lock where it was presumably jimmied open by the "Citizens Commission."

## No Statement

Jamieson refused to discuss the transfer, or even acknowledge that it was being made.

"I have no statement," he said.

An FBI official in Washington also refused to comment.

"We don't discuss personnel changes," he said.

# FBI Transfers Media Agent To Atlanta

You don't normally find Tom Lewis at home on a weekday wearing a red sportshirt.

As resident agent of the Federal Bureau of Investigation office in Media, Lewis would normally be wearing a conservative suit, a white shirt, a neatly patterned tie, and be hard at work.

But Lewis, after 15 years in the FBI office here and in Chester, has been transferred to Atlanta and he's busy uprooting his wife and six children from their neat home on a tree-lined street in Springfield, Delaware County.

## Office Burglarized

Lewis was in charge of the FBI office in Media when a group calling itself the "Citizens Commission to Investigate the FBI" burglarized it on March 8.

Since the burglary the group has sent copies of the files taken from the FBI to two Congressmen and a Washington newspaper. Muhammad Kenyatta, executive director of the Black Eco-
