That is to keep a separate place in the files for records of the interests of other and to the degree possible, of what others have gone over. It will not be possible for we to go over these now. If people come to go over the records and will not have time to go over all I'll ask them to consider starting where others have stop ed and to looks notes. If possible I'll keep a separate file of copies others have taken, which might make it possible to add to whatever was perceived.

Enclosed will be a copy of each page they've taken back to Florida. They are leaving in the s.m. They liked your idea of your checking. "Il is now copying what they selected yeste day and the 'll do today's selection tonight.

They did not appeal when they lost. Now the vindictive nut may force this to become precedent, which it wasn't. While I would think samer heads might prevail and would hate for 'in and me to have the extra work entailed, I'd kind of like them to because of what it will enable me to do....We have asked for the first 40,001 on an informal level and will file suit if they done decide soon. In fact if can be part of the suit we won, I think, and already have status as before a court. Best to you all.
