Dear Larry,

When you phoned yesterday, other things were on my mind and I didn't recall something I should have told you. But I got up early this morning to post corrected typos on the master copy of the third and last part of the new book, a mechanical task which gave me time to think. It then came back to me that as of several years ago AMV Apts had had its offices in the same building as Columbia College. I had the address and phone number, but that address book was taken from my motel room in H.O. in the incident I described to you, the one that began in Apts when I think the army developed an interest in me. Or manifested it. As best I can now recall, anyway.

They may have moved for other reasons than the proximity you note. But you can establish their earlier location from old phone books and city directories.

Were it not for this coincidence, it would not have been possible for there to have been the chain of events that made it possible for Skolnick to steal and misuse those documents the originals of which you saw here.

One of the two people to whom I said I'd refer the list of names you gave me is the former reporter whose trust Skolnick abuse. (If Weintraub, by the way, wants to learn how disreputable poor Skolnick has become, he can see the entire file on this, include the exchange between this man and Skolnick after Skolnick misused that stuff, even a set of the masters Skolnick used in making up his "court" thing. Skolnick seems to have developed a need for publicity as others need air. I have a series of his most incredible appearances on radio that I once thought of using to make a talking record that would be wild, but then I realized he has developed a greater deformity than the physical and decided against ridiculing him, despite the evil he had wrought and the harm he had done me.) I do not have this man's new phone and he is not in or near Chicago.

However, there is a young woman in Chicago who I think may be able to help you. Use my name and I'm sure she'll tell you what she knows. But if there is the likelihood of any official reaction, be certain to protect her because she is not finding it easy to make out and is still recovering from a second broken marriage. She is Lite Skinder, 3209 W 45, 60632. I do not know if she has a phone, but I think she does. Try information if it is not listed, but from what you said, not from your office. When last I heard from her she had a daytime job but I don't know where.

What I didn't want to spell out on the phone and do not want to take time for now is the probability that if Dr. Cyril Wecht is given access to the autopsy pictures and X-rays it will result in a further denial of truth, the misplacing of blame for the suppressions, an enormous defamation of the Kennedy family, including the dead. Mitchell, Hoover and Nixon will come out looking like the pure and noble, Clark and Teddy will be unspeakable villains, etc. If I think the odds are against his being allowed to see them, for Marshall also had no objection to my having the pictures I was denied, I also think the potential for real hurt is quite great, depending on how shrewd this evil crew is.

There is little we will now learn from the pix and X-rays anyway, for I've learned the essence of what they hold and have the book written. Without the perspective only length that can be found in a book only, this whole thing will be horribly distorted. So few of the "critics" despite experience that would indicate otherwise, have real political maturity and understanding, and so few have done any real work on their own and of their own. But this, too, may be hard for you to believe. Anyway, thus it is that credibility is always being further undermined and truth buried deeper.
