SUBJECT: GOBH HOLDING THIRTEEN AMCITS SUSPECTED OF BEING ANTI-CASTRO GUERRILLAS

1. POLICE APPREHENDED ADDITIONAL EIGHT AMCITS ON KEY SIX MILES EAST BELIZE CITY NOON THURSDAY OCTOBER 24. GROUP WERE GUARDING CACHE OF FIELD EQUIPMENT INCLUDING AT LEAST NINE RIFLES, NINE PISTOLS AND AMMUNITION. ENTIRE THIRTEEN CHARGED TECHNICALLY WITH ILLEGAL ENTRY AND REMANDED FOR ONE WEEK.

OFFICIAL IN "ORGANIZATION EJERCITO SECRETO DE LA BRIGADA INTERNACIONAL ANTI-COMUNISTA ESTADOS UNIDOS." FIORINI ADMITTED TO IDENTIFICATION.)

4. CONSUL HAD LONG DISCUSSION WITH FIORINI IN WHICH FOLLOWING STORY EMERGED. GROUP OF FIVE DEPARTED PROGRESO OCTOBER 19 AND WERE JOINED BY EIGHT ADDITIONAL MEN (ALL U.S. CITIZENS) WHO WERE CAMPED EAST OF PROGRESO. ONE HOUR OUT OF PROGRESO CAPTAIN OF BOAT ADVISED TRUE NATURE OF MISSION AND HIS COOPERATION REQUESTED. AT ONE POINT DURING TRIP IT WAS NECESSARY TO HAND-CUFF CAPTAIN. MISSION WAS TO RENDEZVOUS DAY BREAK OCTOBER 22 (HE WAS HAZY ON DATE) WITH 63 FOOTER EAST OF TURNEFFE ISLAND. FIORINI DID NOT WISH DISCLOSE PORT OF DEPARTURE OF

OTHER BOAT BUT LEAD ME TO BELIEVE IT WAS FROM JAMAICA OR CAYMAN ISLANDS. POLICE COMMISSIONER BELIEVES MORE LOGICAL FOR SECOND BOAT TO ORIGINATE FROM HONDURAS OR OTHER CENTRAL AMERICAN PORT. DUE GROUNDING NORTHSIDE TURNEFFE ISLAND "AMIGO" FAILED MAKE RENDEZVOUS. MISSION WAS TO LAND SOUTH COAST CUBA AND HOLE UP IN MOUNTAINS. FIORINI EXPLAINED DIFFICULTIES OF LANDING NORTH COAST BECAUSE EXTENSIVE U.S. PATROL. FIORINI SAID EARLIER SERVED WITH CASTRO AND BECAME ANTI-CASTRO IN 1959. CLAIMS TO BE WELL KNOWN IN MIAMI ANTI-CUBAN CIRCLES, PARTICIPATED IN BAY OF PIGS, AND LED NUMEROUS FORAYS FROM NORMAN KEY IN BAHAMAS. STATED LEGAL NAME FRANK STURGIS BUT COMMONLY KNOWN AS FIORINI IN MIAMI ANTI-CASTRO CIRCLES. OTHER RING LEADER IS JERRY BUCHANAN RPT BUCHANAN DESCRIBED AS CONNELLE IN REF TEL.

5. FIORINI REQUESTS FLORIDA ATTORNEY RAY SANDSTROM, FORT LAUDERDALE, BE ADVISED AS WELL AS SENATOR SMATHERS.

AMERICANS WHEN ASHORE" AND THAT HE BROKE STORY BY WHISPERING IN
EAR OF BRITISH HONDURAS CUSTOMS OFFICER.

[REDACTED] FIORINI, OF COURSE, WANTS
EARLIEST RETURN TO U.S. CONSUL RECOMMENDED FIORINI AND OTHERS
PLAY STORY COMPLETELY STRAIGHT WITH GOBH AUTHORITIES IN ORDER
SOLICIT THEIR COOPERATION.

9. IN VIEW LARGE QUANTITY DOCUMENTS SEIZED IN THEIR PERSONAL
EFFECTS AND AT REQUEST POLICE COMMISSIONER, SUGGEST OFFICER
MIAMI AREA FAMILIAR EXILE GROUPS BE SENT BELIZE ASAP.
