In the harguerite Oswald tickler, Documents 32 and 33, resteet Fight directives to Dallas to establish a separate "expectite Oswald File. It thus did not require any discovery from me to locate this file and an discovery from me could have enabled it to prove that it had complied. New Evidence, I'm pretty sure the second of this nature subsequent to the case gaing up on appeal.

I enclose one page only of Document 1 from the "arina Oswald tickler, page 6. It recounts how the alleged assessin was so intent upon making his place in history he almost overselpt his rendervous with destiny.

The Marina Oswald Tech. Surv. tickler holds the news account of an Fal statement after its electronic surveillances on her were disclosed. I include it to give you an illustration of how the FMI lies sithout seeming to lie. Its own statement is that it "had conducted and electronic surveillance on Marina O a ld's residence from Peb. 29, 1964 to March 12, 1964, based upon written approval of the attorney general of the United States." The FMI did not seek or got approval for bugging her house before she moved in. It did get up rovald for the wiretapping only. Its reference to those urveillances is in the singular.



She has contacted our FBI Office in Dallas on a number of occasions to furnish information she feels is of value. We are accepting information she furnishe but are conducting no investigation of her. For filing purposes and for ready reference in the future, desirable we maintain a separate file on subject. Heretofore information concerning her has been filed in the main case file of Lee Harvey Oswald.

On Thursday, November 21, 1963, Oswald appeared unannounced at the Paine residence, at about 5:45 p.m., and asked to see Marina. He stated that he was lonesome. Oswald played with the children and watched television, then about 18:30 p.m. he went to bed.

On the morning of November 22, 1963, Marina said she awoke at 6:40 a.m. and began to feed the baby. At around 7 o'clock Marina awoke Oswald and told him he had better get up or he would be late for work. As he dressed he told Marina that he would fix his own breakfast. Marina does not believe that he did this, as she found the coffee pot to be cold when she went into the kitchen about 7:20. Marina advised that she does not know of anything that Oswald took with him from the Paine house to work on November 22, 1963.

Marina and Mrs. Paine were looking at the motorcade on television when it was announced that the President
had been shot, and that the shots had supposedly come
from the Texas School Book Depository Building. A thought
immediately entered Marina;'s mind: "Did my crazy one
do it?"

FM Didn't Report Oswald Wife Fap

The FBI tapped the telephones and bugged the living quarters used by Marina Oswald after the assascination of President Rennedy, but it failed to report either the fact of the surveillance or its product to investigators for the Warren Commission, according to a former FBI official.

The off-cit, who was closely involved with the investigation conducted by the Lureau in the wake of the assassination, said that the electronic surveillance was instituted on the Rensian-born Mrs. Oswald shortly after her husband, Lee Harvey Oswald, was identified as the principal suspect in Kannedy's nur-

The surveillance, the former articial said, continued for "some valuable" after the death of Kennedy on Nov. 22, 1963, and the killing of Oswald himself two days later by Joc's Ruby, a Dellas nightelub operator.

LIT HE SAID that, to the last of his recollection, he surveilished never proceed information that bore directly on Osweld's motives or supported suspicious held by some FBI officials that he had been involved in a conspiracy against the president's life. It was those suspicions, the former official said, that mompted the bureau to initiate its electronic "coverage" of Mrs. Oswald.

The FBI said in a statement yesterday afternoon that the agency had "conducted an electronic surveillance of Marina Oswall's residence from Feb. 29, 1984, to March 12, 1964, based upon written approval of the lattorney general of the United States."

At the time, the government contended that in "national security" cases rour permission was not required.

TIPE FPF did-net deal with its reported failure to inform the Warren Commission of the eavesdropping effort.

None of the volumes of testimony or evidence published by the Warren Commission contain any hint that commission lawyers were told by the FBI of its surveillance of Mrs. Oswald.

Key commission counsel and investigators confirmed that they could not remember having been told that her conversations had been monitored.

David W. Belin, a Des Moines lawyer who was an assistant counsel to the commission, said that if this account was accurate, "it strikes me as horrible" that the commission was left uninformed

SENTIMENTS were shared by Albert E. Jenner Jr., also a former assistant

commission counsel and note a Chicago lawyer, who said that whether the surveillance of Mrs. Oswald half come out "positive or negative," the panel should have been allowed to weigh whatever information was gleaned.

The commission, named for Earl Warren, the late chief justice who acted as its chairman, was set up by former President Lyndon R. Johnson within a week of hennedy's death, with instructions to determine the circumstances that surrounded the assassination.
