

FBIHQ 105-82555-5028 and related records "Privacy~~2~~ and medical records

This is one of a series of records relating to a poor mentally ill woman, Shirley Rose Frank, identified by name. She also is described from cited medical records as "schizophrenic" and "paranoid."

There is no withholding relating to her or her illness or diagnosis or fantasies.

But the name of the source of the medical records <sup>allegedly</sup> requires protection. That name is withheld.

At best this represents a ~~distorted~~ concern for both privacy and medical records when there is no withholding relating to the one who can be hurt and is withholding relating to one who can't be hurt.

Even the names and addresses of relatives are not withheld.

Comparing what is not withheld in this and related records with what is withheld in thousands more raises substantial questions about the withholdings of information from those thousands of records and of the quality of processing in general.

There are many such cases, particularly involving the mentally ill.

However, prior to FOIA the identifications <sup>of the sources</sup> ~~of the sources~~ of the records were not withheld.

ART STATLEY, ROUTE THREE, BELOIT, WISCONSIN; WAS VOLUNTARILY ADMITTED EASTERN STATE HOSPITAL MAY TWENTY NINETEEN SIXTY THREE; RELEASED AND TRANSFERRED MENDOTA STATE HOSPITAL, MADISON, WISCONSIN, JUNE FIVE NINETEEN SIXTY THREE WHERE SHE WAS PREVIOUS PATIENT.

RECORDS INDICATE PATIENT HALLUCINATED AND EXPRESSED PARANOID DELUSIONS. WAS UNCOOPERATIVE WHEN ASKED TO DO ANYTHING UNTIL AFTER TREATMENT. PATIENT ADVISED SHE WAS SOUTHERNER AND IS PERSECUTED BY YANKEES AND BLAMES THEM FOR DEATH OF HER MILLIONAIRE FATHER. MADE REFERENCES TO DOPE ADDICTS AND ITALIANS HOLDING GUNS ON HER.

HOSPITAL RECORDS REFLECT DIAGNOSIS SCHZOPHRENIC REACTION, PARANOID TYPE.
