Dear Mr. Gottlieb,

Thanks for your letter and its enclosure. Wish I had more time to write you more about both.

The lengthier complete version of what appeared as Case Open is not yet retyped and I regret that it will not be possible for me to provide copies. I'm 81 now and unwell. But it will be deposited for students of the future. I have no idea when they butchered it.

I believe that for the most part the Dallas doctors' statements you refer to had their meanings twisted. The Zapruder film is quite clear on the back of the head being intact.

I appreciate the time ^{you} to take to defend me and thank you for it but unless you enjoy it I think it is a waste of time. It is not possible for a mature person with ordinary common sense not to realize on reading Lifton's mistitled book that his theory is not possible. And for his integrity, compare what he says about the Sibert O'Neill report by reading the rest of that paragraph in Post Mortem, where I reproduce it in facsimile.

If what you say about Lifton now advancing a different theory that you refer to Timmermans as "the Air Force 2" hypothesis, I'd like a copy of it. Also his "changing his hypothesis amongst his friends."

Dear Mr. Weisberg,

Hoping this letter finds you and your wife feeling in the best of good health. Being one of your most avid readers/fans I wanted to write you a short letter. I wanted to let you know how much I enjoyed reading your fantastic new book CASE OPEN. It was such a great feeling to walk into my local bookstore and see your book on the shelf. Carroll & Graf Publishers, Inc. are now publishing books by The King Of All Assassination Researchers, Mr. Harold Weisberg! I was so upset when I read Posner's book because it was such a rehash of the Warren Report. It also infuriated me because even though he thanked you for permitting him to stay at your house and study your government documents, he then goes on to say that he disagrees with you on almost every aspect of the JFK case (Case Open p.504). Of course he doesn't give his readers any specific examples of his disagreement with you, but that is what I have come to expect of fraudulent assassination "writers." I knew in my heart that you would not let him get away with writing such a deceitful book, and boy oh boy, did you fix him good with CASE OPEN. I want to personally thank you for writing CASE OPEN and showing to the world that as long as you are able to, you will not allow the Establishment^o to desecrate the memory of President Kennedy by fostering lies to the world about the events in Dallas, November 22, 1963.
