I'm very sorry to hear about your father. I hope it is not accompanied by great pain. As you know, such things intrude upon my mind from time to time. I am very much aware of them from what others would not notice. Just this morning, when the large and heavy door of an auto loaned to me while mine is in the shop closed on my worse leg, just above the ankle, leaing it swollen and huring a little. For me a simple thing like that can mean troubel. So, while I can't apply it to others, I am very much aware that such times do come to us all. But I do hope it is as easy as possible on him and on all of you.

On what I think of as JAMAborie I've not even thought of an outline because none is necessary, my formula is that simple. I've got a handwritten beginning scrawled in odds and ends of moments while resting during my walking, even while being driven to ohns Hopkins yesterday. It is general and background, mostly to introduce the reader to Byzantium on the Potomac. Also a bit on something in the JAMA article that fits this and raises questions about truthfulness. I'm at the point now where I'm into the meat and I'll be carVing that all the rest of the way.

I have read the JaMa and as I said about Stone and Garrison, they have trouble telling the truth even by Scident. The overt lies are of a magnitude I/ can't beging to exaggerate. So for a working understanding please believe that with almost everything they lied and that many of the lies are simply enormous and unpardonable. If you want I'll give you some in advance.

What I have in mind is a very simple formula: going over the article almost word-by-word, braketing what it ways with documentary and often documentary proof

One of the things I mean by intellectual jude is this, their strenth to become their leakness.

The formula provides a means for as much speed as I'm capable of now. It also provides for publishing, I strongly believe in facsimile, official proofs entirely unknown except to the small number of people who have read and still remember Post Mortem. But because JAMA said these things that are so grossly false; because it became inapporpriately political; because it abandonned all the principles of pathology; because it ignored all but what it asked the prosectors of what they included in their autopsy report - which makes all they omitted relevant, for example the certificate of death, it becomes at once an exciting and authoritative, really definitive and entirely new book that with any attention at all will make it impossible for the official solution to be adhered to any more, and a mean of telling people what they did not know about the truth, the actualities, the dishonesties without even having to refer to them this way.

By following the artifice it will break into chapters. I am certain of this and all else I've said and I'd hate to have to take the time to make any real outline of it now. I want to get it on paper. It would perhaps be better if I could just dictate it if there were someone who could transcribe it. As I've thought of this, and as for the kost part

I'll do as I write, I'll indicate evidence to be picked up and inserted, the other side and the truth, the real fact.

After doing this with the article I'll be writing inserts from the news accounts of the press conference. I do hope through a friend to be getting a transcript of it, which will be much better.

For example, what I'm about to get into as soon as I can, they said that none of the doctors had said anything for 29 years. They all did. I interviewed three myself and in 1966 I prepared a Baltimore Sun reporter to interview Boswell, the No. 2 man at the autopsy. One of the things I primed him for was the single-bullet theory and the official autopsy body chart, which shows the wound on the back where it was, down on the back and not in the nesk, as they testified and illustrated to the Commission any say again in JAMA. When he realized that he'd gotten away with this with the Sun reporter somehow the AP got interested and before the Sunt story could appear the next morning it weint all around the world on the AP wire!

And how about that breezing those 29 yers of silence when he in 1966 alone had these two interviews that were published so widely?

and here is where the death certificate becomes important: it locates the back wound exactly where that chart does. And it was hidden! It was not used by the Commission, which hid it where I found it the one place nobody would ever look for it, with the copy sent to be printed! along with the remaining original holograph of the autopsy.

In this they lied and I won't go into all of that now but I will illistrate who what I piblished in Post Mortem and is unknown fits so beautifully. They said they were not told to make any changes, were not pressured at all. (I'm here skipping the other relevant and quite important new lies about this business.) In the office of the commander of the Mavy hospital, admiral Gollowsy, Humeswas told to make the changes that are visible. You am see how many the are and that they are substantive.
