This is what might be called a nonprogress report. For some of the time since the morning you phoned when I was not home I'm not been up to present snuff and did other work and pretty much the rest of the time was taken by daily/feeds, answering letters and packaging books plus more than the usual medical interruptions, appointments, etc.

On the latter I return to the "ohns Hopkins research branch of the hospital tomorrow night for another sleep test, this one with a mask or several, to determine whether there is one I can wear and thus get slightly compressed air at night to get the air past the breathing construction in the throat. This will mean a very long day and interrupted but little sleep. By the time I'm home Tuesday, another local medical appointment. Perhaps I'll not be too tired to get a little work done Tuesday afternoon before Dave Wrone comes, but that is unlikely, and the rest of the week I'll be helping him with a book he is writing. On the former, I spent the time instead reading a stack of 16 inches of records from the CEA, mostly that had been referred to the CEA for permission to disclose. That, anyway, is done. There was interesting information in all that junk.

I'd also prepared a statement to be filed with the four or five committees considering legislation to compel fisclosure of JFK assassination records. I've gotten excellent comments on it from my professor friends and a lawyer friend of my youth but not a word about it from Jim Lesar, who had promised before I began writing it and when I sent him the copies to deliver them. It relates to the CIA's promise of new openness and Director Gates' testimony to this. He gave the Senate a few pages, about 110, mostly if not entirely disclosed earlier while I got the thousands that same week from the FBI, CIA information he did not give the Senate. Aside from going into that I went into what the CIA had suppressed for all these years after I requested it, and used that to bring new information about its improper domestic activities, including against me. With a prima facie case of E. Howard Hunt's interference with publication of Whitewas in 1965 and his involvement in the campaign to impeach 'ustice bauglas, along with the CIA asset he used as a cover, the Mullen Agency. and lo! in the records i just got there is proof of one of my allegations, that fielms had committed perjury before the Watergate committee to protect the CIA when he testified that he introduced Hunt to the Mullen Agency after Hunt retired from the CIA. In fact Hunt had been working there for years. One of the FBI records includes the atatement of a public stenographer he used in 1960 to type some of his preparations for the Bay of Pigs fiasco. She is quite specifif, he then worked at Mullen, to her knowledge. More on Mullen that I developed years ago I do not take your time with, But I think you can see the relenace of what Gates did not disclose, like this information the CIA had authorized the FBI to give me, proof of Helma' perfury if not also of Hunt's, tec.

It saddens me that as #intelligent a man as Jim is he neglects what can be useful, like this, and instead is crapping around arranging for of all things a press conference

next mak week for the Dr. Crenshaw of the fake JFK assassination book, the press conference Signer, his publisher, cancelled. (The Secret Service phone logs and records of LBJ's travela that day, the day Crenshaw says LBJ phoned him to order that they get a confession from Oswald, establishes the almost certain impossibility of such a call. I have copies of these records.)

There is, however, a slight indication of possible progress. I do not now remember whether I sent you copies of my correspondence with Frank Mankiewicz, of Hill & Knowlton, Stone's door-openers.

What JAMA did was aimed at Stone. Witout any tainting of me or change in my position on anything at all?

The more obvious intellectual judo is using what Jama did against Jama, using its strength and influence against it, both as a means of bringing what refutes them to light?

Too bad I do not have time to rewrite these things I do in haste but if hankiewicz is interested he'll take a few more moments if he finds what is not as clear as it should have been. And invited him up to see some of the documentation.

I'lk finish these up before getting into the meat, the MAMA article and underlying interviews, and oh! HOW THEY ALL LIED! As I'll bracket with truth and fact, decumented. It should be exciting and so important a book that will also lend itself, as I did not tell ankiewicz, to a documentary. Best to all, where
