If it is easy to be suspicious where the is no cause for it, it is not easy not to be suspicious about commercial representation of commercial interest in assassination books. Thus this inquiry to see if several names mean anything to you. They don't to me.

Jim Lesar told me of a man in New York who was interested in all assassination books. I did nothing. Jim then gave me the manes name, office and home phones and addresses and told me the man wanted me to call collect. I did, yesterday. First I phoned his office, Jim having said the morning was better for that, I call in the morning. They didn't know if he'd be in. He was at home and accepted the call.

We talked close to a half hour. I felt I'd best let it be known what kind of nut I am and what the problems are, but he was not in any way deterred. He did not pry and was

content with generalities.

It may interest you to know that he says Lane and Freed are in LA working on a movie script, allegedly non-fiction. He has been trying without sucess to reach them. He says of the Trumbo script that it is fiction and he does not know with whom, if anyone, Trumbo as working. His chief interests seem to involve audiou-visuals, including movies.

He finally said he thought the best thing might be for him to come here. Daniel having no aversions to lion, he got an invitation and the suggestion that he permit time

for several non-assassination properties that have commercial prospect.

As I think you know, I deal openly with everyone, including those I may not trust. This way I manage to awid reflecting distrust. (In my last letter to Dione I pointed out, I think correctly, that she had no idea what conclusions I had reached. She had said I jumped to many wrong ones. I think I am right in this, that neither she nor anyone to whom she talked could have had a reasonable idea.) Besides, some time there is no choice.

What interested me is that this man seemed to have no real interest in what did have good commercial prospect. He listened but that is all. More provocative than interesting. Most go for \$55. So, I thought I'd give him some bait. I have turned over to the wife of a friend at Bantam what they think will make a movie and a beautiful book. Bantam is a fairly well-known outfit, so I told this guy he could get an appraisal of my judgement in such matters by calling the Bantam friend, whose name and phone I gave. Several hours later he had not done it, which need mean nothing, but it surely doesn't reflect excitement. He might want a better estimate of me that he deduced from WHITEWASH.

His phone could be his office. I heard another phone ringing and several times

he stopped to answer it.

As it now stands, he will call me in about 10 days to make an appointment for coming here. He is not pressed for money because rather than drive he'll fly and then rent a car. The drive is 4-5 hours and the drive in his own car will cost less than that the rental car at the airport, mush less than the one—Oway fare. Of course, aside from waiting and stacking time and baggage checking, if any, and the time to get and return the car, and getting to the airport, he can save perhaps two hours each way. In reality he'll save little time flying. That works for donwtown D.C. only. I hardly pays to use the pane to downtown Baltimore from downtown NYV with the Metroliner.

There can always be the dedicated guy. Odd I haven't met one in publishing or among agents. When I lost my first the next six wouldn't even talk. When the Sat. Eve. Post sent me to one with a deal set, that one wouldn't even talk to me. I lost my first by

mentioning the subject, etcetcetcetc..So, this one could be the exception.

Neither this man, Phil Gauldston, 3 Robbins Lane, Great Neck, L.I., nor his company, Rollins & Jaffe, 13 W 57, is in LNP. Most but not all agents are. Sp, this could mean their primary interest is not books. It could also mean more. My Mantam friend never heard of either.

Jim heard of Gauldston through Bud. He does not know how they and Bud got together. If they approached Bud, it is not encouraging. In time, I'll know. G has no special publishers in mind. However, if he is for real about visuals, and if he is for real and not for spooking, things can be possible.
