You refer to a single article by Richard Raznikov and for all the world as though it were fit for decent people to consider. If you refer to that shameful rot that appeared in Pacific Sun, you infect yourself to credit it.

I don't have time to explain to you why and how this is. Most people are happier believing that the toilet is really the kitchen and about that there is nothing I can do.

Believe me or not, that was among the sicker of the really sick stuff that is proliferating and abusing people like you.

Another example is your question, "any possibility of the Archives being opened?" They have never been closed. There is no executive order suppressing the files, either. Through the aid of one, Richard Raznikov, an author of recent renown locally for a very fine article on the J.F.K. Assassination, I came to get your mailing address.

I know you must be a tremendously busy man and a small tooth in the machinery of America as I am is really very much an optimist to hope to receive a reply to this letter but, who would have ever dreamed that Nixon could be president after running for the Governorship of California?

I read your exceptionally well written book Heritage of Stone and I have respected you since the first I heard of your efforts to bring out the truth and get matters open on the assassination.

I have read the following books on the subject in addition to the above work of yours: Who Killed Kennedy, The Second Oswald, Rush to Judgement, Whitewash, Death of a President, and a few that I cannot remember titles to. (also Legacy of Doubt)

There are a few questions that I am extremely puzzled over and I hope you will try to enlighten me.

- a) I have heard mention about a man with an umbrella at the scene of the murder but haven't seen anything in writing about the man.
- b) There are conflicting reports about the "Extra" bullets; one in the grass, one in the Stemmons Freeway Sign, one ricochet, and possible others.

- d) Was the Chippaquiddick incident really some sort of attempt on Edward Kennedy which caused his silence for so long while he fled or is that just my imagination going plot crazy?
