I've never done any work on the American Freidns of the Anti-Wolshevik Bloc of Nations but I do recall an FBI report I read of its interview with Spas Raikin and that did interest me.

I am interested in the releases you get and would like them for archival deposit, with my own records, which will be a deposit in local Hood College. Thanks for the offer of copies of them.

There is no special way to address a FOIA request to the CIA but often it takes magic to get a meaningful response. All you need do it tell them what you want and hope. In telling them what you want you identify and describes the records as best you can.

When you ask for records relating to those with whom they've had any connection, if they disclose anything, I suggest you expect rather extensive claims to exemption to withhold entire records or parts of them.

To put this another way, if you have filed FOIA requests, as you have, of other agencies and gotten response, just go about it the same way with the CIA.

What the FBI withheld as coming from other agencies they should have referred back to those agencies and you should, in time, hear more.

You refer to one page as coming from the OBS. Those records were inherited by the CIA and in time it should respond.
