VERY SORRY TO HEAR OF YOUR HEALTH NOT BEING WHAT IT SHOULD BE. FOR GOODNESS SAKE TAKE CARE OF YOURSELF AND DO NOT CONCERN YOURSELF WITH UNIMPORTANT ANSWERS TO ME.

PERHAPS THE EFFORT YOU HAVE PUT FORTH OVER THESE PAST MANY YEARS WILL SOON BEAR FRUIT, SO IT'S IMPORTANT TO CONCERN YOURSELF WITH WHAT IS STILL TO BE COMPLETED.

PLEASE NOW, AT YOUR PLEASURE AND TIME ONLY I WOULD GREATLY APPRECIATE AN ANSWER. YOU STATED IN YOUR LAST LETTER "WHATEVER HALL IS HE HAS AN AIRTIGHT ALIBI FOR 11/22/63 ..." THIS SORT OF MYSTIFIED ME I MUST CONFESS, OF COURSE YOU ARE PRIVY TO MUCH MORE CONCRETE INFORMATION THAN I, HOWEVER I AT NO TIME UNDERSTOOD HIS (HALL'S) LOCATION ON THAT DATE. LET ME EXCHANGE MY UNDERSTANDING WITH YOU ON THAT PARTICULAR DATE. UPON HALL'S INDICTMENT IN CALIF. IN LATE '67 AS A MATERIAL WITNESS FOR MR. GARRISON, HALL PREPARED A DEFENSE BUILT AROUND THE TESTIMONY OF A MR. ROBERT HUDSON. IT WAS PRELIMINARY THAT MR. HUDSON AND HALL WERE LUNCHING TOGETHER AND DISCUSSING THE SALE OF AN AUTOMOBILE. HALL AND ASSOCIATES HAD BEEN EXTREMELY ACTIVE IN CUBAN AFFAIRS (THIS ACCORDING TO ALL ACCOUNTS, YOURS, THE POLICE, CUSTOMS, AND HIS OWN ADMISSION). HALL IS ATTEMPTING TO OBTAIN MONEY FOR VARIOUS ORGANIZATIONS, ALL EFFORTS DIRECT TOWARD A PLAN OR PURPOSE SOMEONE IS DIRECTING (INDIVIDUAL GROUPS OR CIA).
