Indeed I would like copies of the INCA records relating to me! You put the word "information" in quotes and it is for the most part not information, judging from what Butler pulled on me by surprise on an old Joe Pyne show. The stuff had been leaked to him by the House UnAmerican Committee, the FBI or both.
