I'm a fireman at ~~fire~~ engine #2,  
at 4745 Main, Memphis. My service  
will be 13 years in July. I've been at  
engine #2 since Aug. 24, 1966.

Details are pulled on the basis of logged  
time working a particular piece of equipment.  
Mesome works out of engine #2 on  
Truck #5, I work on pumper #2. Normally,  
details would be rotated. On 1st of April  
I drew a detail to engine house #3.  
Normally 4 men would pull a detail  
before it would be my time again. But on  
April 3rd <sup>my next duty day</sup> I pulled a detail again  
at 10:30 <sup>pm</sup> in the middle of my shift. I  
was sent to engine house #33 and  
I've been there ever since, and normally  
I would have returned on the 5th to  
engine house #2.

I would say I work & pulled at 33.  
The company I was detailed to, rides with  
4 men, I made the 5th man. On Friday  
April 5 I understand the man who was  
detailed after me was supposed to be detailed  
to engine #3, instead he was returned to  
engine #2 so our unit would not be

would be

short handed. On April 10 I called personnel to find out where I should be detailed & they assigned me again to engine #33.

It seems like they was trying to get rid of me for some reason. ~~It seems obvious~~

On April 3<sup>rd</sup> two Negro officers were observing the ~~foraine~~ <sup>of the Negro house #2,</sup> hotel through the rear windows. They arrived somewhere in the neighborhood of 1:00 pm. Wednesday. One watched through the window of the ~~rear~~ ~~door~~ ~~near~~ ~~the~~ ~~door~~ and the other lay upon top of a row of lockers along ~~the~~ <sup>the</sup> back wall looking out the window. They were relieved sometime that night, ~~I think~~ I overheard them say they were going to Mason Temple. One said, "Hell I sure hate to go down to that temple tonight." white

Two more officers came in later, went back to the locker room and stayed 2 or 3 minutes and then left. One of the officers was Lieut Papier. The Negro officers were Estes Reddick and Officer Richardson.

I saw Richardson today. he said Officer Taylor was resigning from the force

To become a U.S. Deputy Marshall. I think he's being moved out of town <sup>unmarked</sup> ~~plan~~

On the third there were 2 cruisers on Butler St. E. of Mulberry. There was one on Mulberry in front of the hotel. At one time there were police on the motel parking lot. ↗

Man who owns equipment parking lot locks his lot at sundown and leaves key at the fire station.

I estimate I saw about 10 police around the motel on Wednesday.

The only hint I got of why I was transferred was a fireman said somebody told the ~~go~~ motel people there were policemen in the fire station. Maybe they thought I was that person.

I have never drawn more than one day detail in succession in my 13 years experience as a fireman.

Detail assignments are normally made by the company ~~chief~~ <sup>officer</sup>, Capt. Richard Johnson.

Floyd Newome complained to his deputy  
Chief Barnett that he didn't like his detail  
and asked why he was being detailed for so  
long. Barnett told him he didn't know,  
that the orders were coming from over his head.  
This would <sup>probably</sup> mean from Chief of Fire dept.  
Hamilton or from Holloman.

I listened to

The Negro officers observing from the fire dept.  
were observing the rooms people walked into.  
They were writing down the numbers of the rooms  
people walked into. I heard him say that  
room (second from Butler St. on top deck of  
Lorraine motel) must be headquarters. There's  
more of them going in and out of that room.

Over the window of the door they put newspaper.  
I gave them the necessary rope to put it up.  
They tore two holes in the newspaper to look



through. Reddick was standing in the door. He said "Well, they can see me as easily as I can see them." Then he asked me for some rope to put over the door. They had a pair of binoculars, I then used them. Reddick named off 3 or 4 names. The only one I remember was a man they called "Baby Jesus."

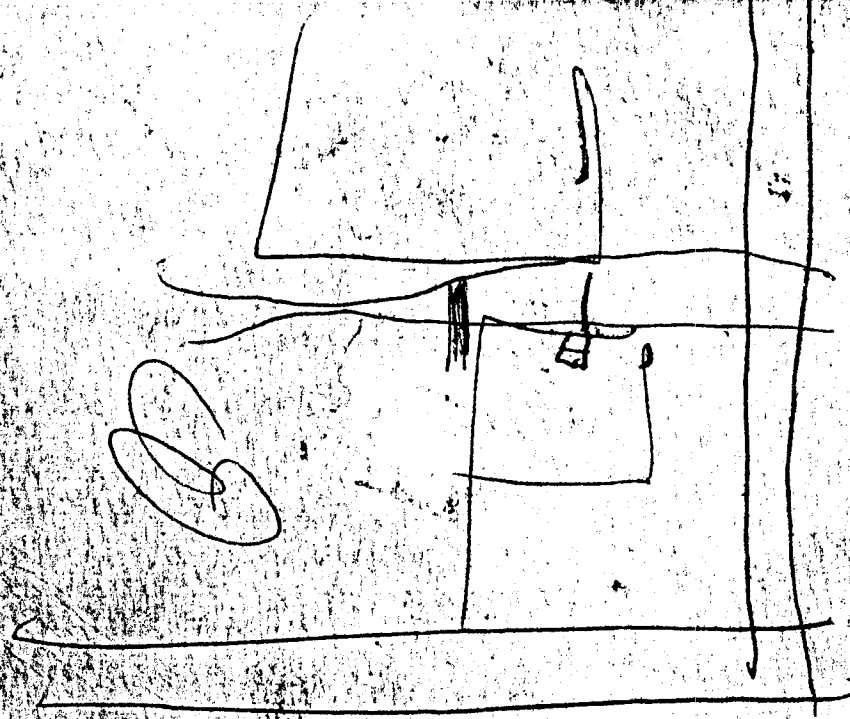
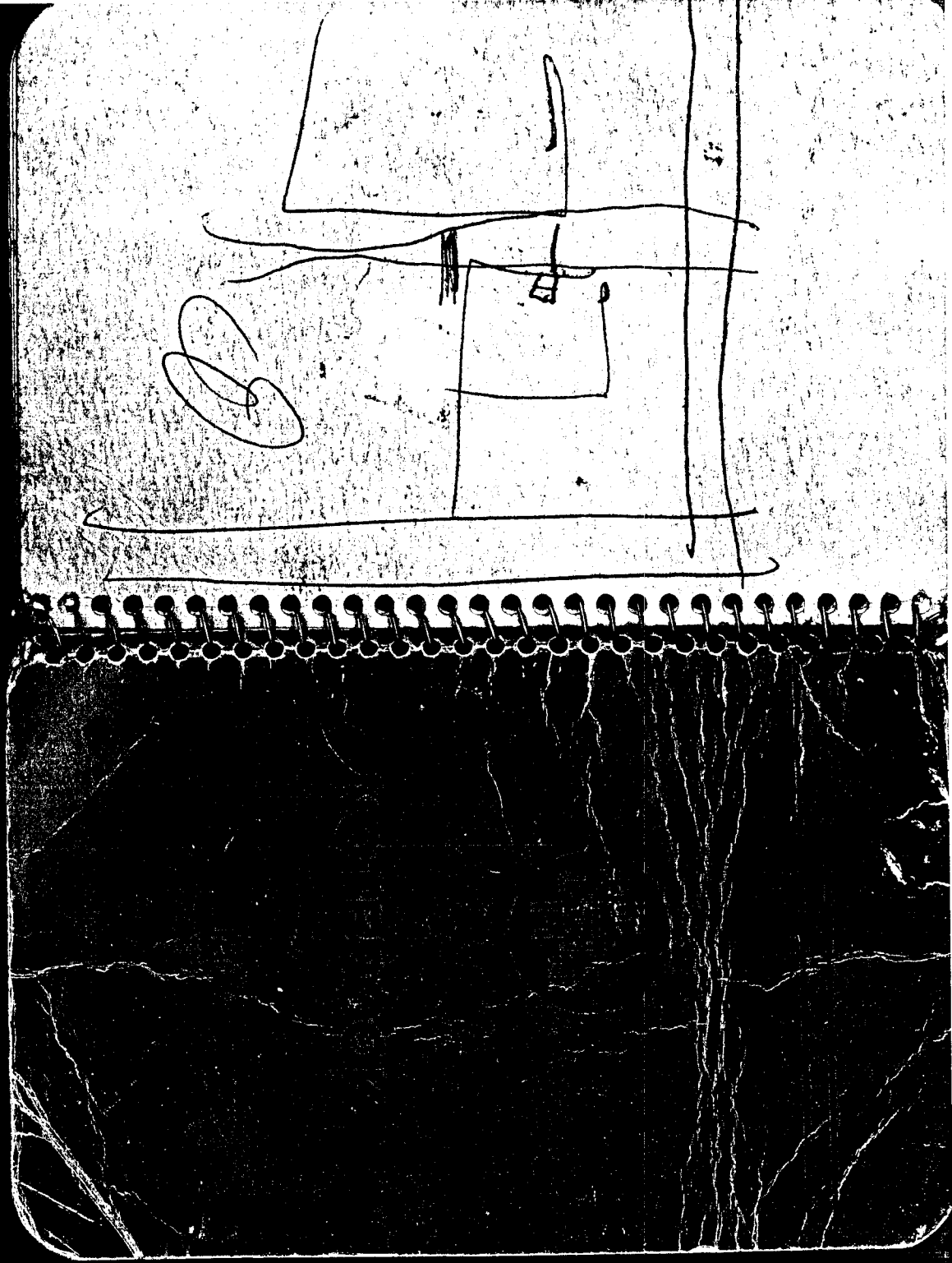
