On November 27, 1963 the undersigned officers were assigned by Chief of Detectives John O'Leary to investigate a gun which had been found in room 705 at the Terre Haute House Hotel, 7th & Wabash in this City.

At approximately 2:30 P.M. November 27th 1963 the undersigned Detective's arrived at the Terre Haute House Hotel where we talked to Mr. VanAllen manager of the Hotel, and who showed us to the room which had been occupied by one Harry L. Power, who gave an address of 127 W. University Ave. San Antonio, Texas. In our investigation of the room we found a German Mouser 7.65 P.M. torn apart lying across the arms of a chair, this gun had been cleaned and well taken care of., serial # 0-2686. Mr. VanAllen then gave these officers the registration card and the phone calls made by this subject in the two day's that he was at the Hotel. We then called for the Technician in order to try to get what finger prints that we could, however we found that the maid had already cleaned the room and everything had been wiped clean. We also called the F.B.I. office and advised them of what we had found, they in turn sent F.B.I. Agent Ken Phelps to make an investigation of this matter. On November 26, 1963 Harry L. Power made a phone call from the Hotel to Poff's Gun Shop located in Twelve Points this City, and in checking with this Gun Shop we found that Power was trying to sell this gun, and when he could not get the price that he thought that the gun was worth tried to purchase ammunition for it. On November 29, 1963 the undersigned Detective's sent a letter to the Police Department San Antonio, Texas asking them for a complete character check on Harry I. Power, which came back stating that no arrest or criminal data could be found with that Department. (A copy of this letter will be attached with this case file).

On December 7, 1963 Assistant Chief of Detective's Eugene Butts wrote a letter to Emil Peters, Inspector, San Antonio, Texas Police Department, which included a little more information concerning this case, since we had not received any word on the letter sent by the undersigned. On Dec. 10, 1963 Capt. Butts received a letter from Inspector Peters stating that Detective T. F. Penley had been assigned to the case, and would send a complete report on his findings. (These also will be attached to this case file). In the meantime investigation by the undersigned revealed that this subject had been in the Bus Terminal in this City, after receiving this information we went to the Bus Terminal where we talked to one Don Locker who stated that this subject came into the Terminal on Monday Nov. 25, 1963 and purchased a ticket to St. Louis, Mo. At 5:45 P.M. that night when Locker called out over the microphone that this bus was ready to leave this subject got up and ran out the door and down the alley. It was revealed through correspondence that Harry I. Power resided at 108 W. University Avenue, San Antonio, Texas, and worked for Acme Neon Company in that City, he was employed by that company for about one year, and left the Company on December 12, 1962, and left a forwarding address of Gen. Delivery Luftberry Menila, West Virginia. He was born 4-5-43, 5'10" 160 lbs., and has a current Iowa drivers license. We also learned that a Roger Brisch had worked with Harry Power, and knew that he owned a rifle such as was found here.

Through correspondence to the National Rifle Association we learned that they could not find anything in their files reference to the German Mauser U-8686 found in the Terre Haute House Hotel in this City on Nov. 26, 1963

This case is still under investigation by the undersigned Detective's.

Received a letter from Capt. Eugene V. Butts of the above Police Dept. to run a character check on Harry L. Power. SEE COPY OF LETTER ATTACHED. I checked with Mrs. V.W. Gamblin of 127 University PE 22437 and she stated that she has lived at this address for 50 years and that she does not rent to anyone and does not know the person I was checking on. I then checked with Retail Credit and found that a Harry L. Power gave the address 108 University and that he had many bad debts on his record. I then called Mr. Worth Seaman in Austin Tex. DPS records Chief and had him run a check on the subject. He called back and stated that they had no record on the subject but that in July of 1962 a Harry L. Power who gave the address of 108 University tried to get a drivers licence. He failed the test and did not apply again. He also gave me the following information. Power is 5'-10 180# DOB 4-5-43 and is a painter by trade. He also had a valid Iowa drivers lic. at the time he tried to get a Texas lic. He gave Acme Neon Co. 1301 W Hilderbrand San Antonio Tex as his place of employment. I checked and found that the owner is Don McNay. I talked to him about the subject and he told me that he left his company on Sept 12, 1962 and that he was a smart aleck type person and a trouble maker. He told me that Power left town owing a lot of bills. He also told me that one of his workers had told him that the subject Power carried a card with the YCL. I asked him what that was and he told me that this was THE YOUNG COMMUNIST LEAGUE. I asked him if he could remember who the party was and he said that he would try to find out. He called back and told me that the man was Roger Dresch who is a artist and worked for him but now was working for the Rollins Outdoor Adv. Co. 2323 Broadway SA Tex He said that Dresch told him today when asked about the card that it looked real and had Power's name on the front along with the name THE YOUNG COMMUNIST LEAGUE. On the back of the card was some type of oath. Mr. McNay told me that the last time he heard from Power was when Power wrote for his W2 forms from Gen. Del. Taftberry, Manila W. Va. I called Mr. J Myer Cole agent in charge of the FBI Office and gave him the information and he had Mr. Mark Childs Agent, get in touch with me. Mr. Childs will have Capt. Butts interviewed by the FBI in Indiana to see if there is any more information and asked for us to continue our investigation.

December 10, 1963: Continued investigation. Went to the address 108 University and talked to Mrs. H.J. Moore of Apt. # 2. She told me that she and her husband have lived there for about 9 months and that no one by that name lived there since they have lived there. I then went to Rollins Outdoor Adv. Co and talked to Mr. Dresch. He told me that Power was a odd sort of person. That he had a warped out look on life. That he felt the world owed him a living and that there was nothing wrong with Communist's. He spoke free about Communist's and about our type of Government. He dont remember Power saying anything about doing any harm to any Official. His out look was to go back to W. Va and take his rifle and go into the hills and stay there for the rest of his life.. HE WAS A TOP MARKSMAN going to the rifle range at least 2 or 3 times a week. The only other person that he knows he ran with is a boy named Charlie and that Charlie is Big and Fat and works for a garage some where around Five Points. The card that he carried was cream colored with dark blue or black letters. I then called Mr. Jack Cole owner of the apartment house at 108 University and asked him about the man and he did not know much about him but that he was married to a woman in the Air Force and that he was an Ex Army man and that they seemed to have a lot of family trouble and that he moved out around Sept. of last year and he has not heard from him since.
