Dear Mr. Hoover:

[redacted]
who is now residing at Littleton, New Hampshire, turned over
to Special Agent [redacted] of this office on November 14,
1961, the attached copy of a portion of a document which
appears to be a segment of a genealogical search. This reflects:

"(12,427) DURIE, (Kerr), MALCOM, (Isabel O.
Cooper, 11,304). We have no birth date. She
was born Kerr, but took the name of her step-
father. She first married Firmin Desloge, IV.
They were divorced. Durie then married F. John
Bersbach. They were divorced, and she married,
third, John F. Kennedy, son of Joseph P. Kennedy,
one time Ambassador to England. There were no
children of the second or third marriages."

[redacted] requested that his name be maintained in
strict confidence. He said he did not know the origin of
the document and he declined to identify his source of the
material.

[redacted] told Special Agent [redacted] that he does
not know anything about the authenticity of this material,
although he did state that he understands it is or may be
known to certain newspapermen in the Washington, D. C. area
and also to Mr. William Loeb, Publisher of the Manchester,
New Hampshire, Union Leader, who, according to [redacted] has asked
him to see if he could obtain this information.
