MRS. MARTHA CAMPBELL, 7803 Ferguson Road, #102, Dallas, Texas 75220, telephone 321-3393, business telephone 324-2149, was interviewed on September 4, 1975. Regarding the signed, sworn statement furnished by MRS. CAMPBELL on September 3, 1975, she stated that she was positive that NAN FENNER was present in the "coke room" when the letter allegedly left at the Dallas Office prior to November 22, 1963 was discussed. MRS. CAMPBELL stated "She was there. I just know she was there." She stated that it was her feeling that NAN FENNER was the one who told her of the letter but she is not as certain of this as she is of the fact that MRS. FENNER was present. She was unable after reviewing the Dallas Office personnel list dated November 22, 1963, to furnish the identity of any other individuals present.

MRS. CAMPBELL advised that Agent HOSTY worked with SA's W. HARLAN BROWN, WALLACE R. HEITMAN and EDWIN D. KUYKENDALL during the pertinent period (November, 1963).

I, Martha Ann Campbell, formerly Martha Ann Connally being duly sworn, hereby make the following free and voluntary statement to Assistant Director Harold N. Bassett and Inspector J. Allison Conley who have identified themselves to me as being employees of the Federal Bureau of Investigation.

With regard to my affidavit of September 3, 1975, and my knowledge of the alleged visit of Lee Harvey Oswald to the Dallas Office of the FBI prior to the assassination of President John F. Kennedy and his leaving a note for SA Hosty I have been interviewed this date. In my affidavit of September 3, 1975, on page 1, commencing with paragraph three I related my recollection concerning a conversation in the "coke" room about Oswald, the note he left and SA Hosty. After furnishing this affidavit I have given much thought to this matter and have had a feeling that there was something else concerning this matter in the back of my mind but could not recall what it was. In other words I have the feeling that prior to the "coke" room incident something had happened or occurred or been brought to my attention in some unknown manner indicating that this information was known to me earlier.

I have today been exhibited that portion of an affidavit of SA James P. Hosty, Jr. dated September 22, 1975 on page 6 wherein he stated he dictated a memo to me on November 22, 1963 entitled "Lee Harvey Oswald." I have no recollection of SA Hosty dictating to me a memorandum as set forth in his affidavit. I was on duty in the Dallas Office all day and evening on November 22, 1963 and did not go home until after midnight. SA Hosty may have dictated such a memorandum to me but at this time I simply cannot recall it. I knew SA Hosty for approximately seven years while I was employed in the Dallas Office and he impressed me as an individual who had a memory like an elephant.

I have read this statement consisting of two pages and it is true and correct to the best of my knowledge and recollection.
