LONNIE HUDKINS, reporter for The Houston Post newspaper, advised SA JAMES W. RUSSELL on 12/11/63 that in his conversations with RUTH PAINE, the socially prominent Fort Worth woman referred to had been LINDA ROSENTHAL who lives in the 4800 block Oram Street, Fort Worth. HUDKINS advised Mrs. ROSENTHAL had employed Mrs. OSWALD in September and October, 1962, and that ROSENTHAL has previously been interviewed by the FBI. HUDKINS concluded by stating he was on a "fishing expedition" and was attempting to determine if LEE HARVEY OSWALD had been "stool pigeon" for some Government agency, such as CIA or FBI.

On 1-3-64, this writer returned to Mrs. RUTH HYDE PAINE, eight pamphlets concerning the League of Women Voters of Irving, Texas, which had been inadvertently taken on 12-22-63, under the assumption it was the property of MARINA OSWALD. A receipt for this property was obtained which will be placed in the 1-A section of this file.

At this time, Mrs. PAINE volunteered the following information to this writer and SA BARDWELL D. ODUM:

LOREN HUGHINS of the Houston "Post" contacted her on Saturday, 12-20-63, at which time he stated that the FBI was foolish to deny that Agent JOSEPH HOSTI, the alleged head of the Subversive Section of the Dallas Office of the FBI, had tried to develop LEE HARVEY OSWALD as an informant. Mrs. PAINE stated she made no comment one way or the other to HUGHINS regarding this, however, she did state in the presence of both Agents that she knew SA HOSTI had not interviewed LEE HARVEY OSWALD. HUGHINS further stated, according to Mrs. PAINE, that a woman in Fort Worth had been told by Mrs. MARGUERITE OSWALD, mother of LEE OSWALD, that her son was doing secret government work. The above should be made a matter of record.
