They jazz it up with visuals. Nobody ever stops to ask if the visuals really mean and say what the lecturer attributes to them. Rarely have they any meaning or relevance. The actual films of the assassination speak for themselves but the one of these who trusts it to I've not heard of. They have to become experts and give special meanings rarely there.

Because there is no reason of which I know to take Rhodes' word for anything and because he knows how to get in touch with me I'll leave his Alice inventions entirely to him. But thanks.

A WEST COAST ORGANIZATION C.I.P.A. (COMMITTEE INVESTIGATING PRESIDENTIAL
ASSASSINATION) I ASSUME AN AUTHENTIC
ORGANIZATION. I SPOKE BRIEFLY
WITH MR. RHOADES AFTERWARDS, STATING
I KNEW YOU. HE SAID FOR YOU TO
CONTACT HIM AS HE HAD INFORMATION
"REGARDING ALICE, TEXAS." I ASSUME

NO FURTHER STATEMENTS WERE MADE. HE DOESN'T KNOW MY NAME OR HAVE ANY INSIGHT INTO YOURS OR MY RELATIONSHIP.

HIS PROGRAM WAS WELL RECEIVED AND SEVERAL HUNDRED TURNED OUT WITH A VERY MINIMUM OF ADVANCE ADVERTISING. I WAS AMAZED AT THE NUMBER OF INTELLIGENT QUESTIONS ASKED AT THE CONCLUSION, ALSO AT THE KNOWLEDGE SOME OF THE PEOPLE POSSESSED.

I'M NOT ASKING YOU TO DEVULGE ANY INFORMATION YOU FEEL IS CONFIDENTIAL, HOWEVER, I WILL GRATEFULLY ASK YOU TO SEND ANY COPIES OF STILLS, CLOSE-UPS, PARTIALS, ETC. THAT DEAL WITH THE SO-CALLED "UMBRELLA MAN."

MY STATEMENT ON THE PHONE TO YOU IS BASED ON SEVERAL SIMILARITIES BETWEEN THIS CHARACTER AND LOREN HALL. THE DRESS, POSTURE, AND WALK ARE DISTINGUISHABLE, AND WHAT PICTURES I HAVE SEEN LEAD ME TO THE BELIEF THEY ARE ONE AND THE SAME. IT WAS A SINCERE DISAPPOINTMENT THAT MR. GARRISON WAS NOT ABLE TO EXTRACT INFORMATION OF SIGNIFICANT VALUE FROM HALL — JUST REMARKABLE, IN FACT. WHEN HALL LEFT CALIFORNIA HE WAS DRAMATIC TO THE POINT — HE DIDN'T THINK HE WOULD RETURN TO CALIF. — HE TOOK

THREE

SEVERAL DAYS GETTING HIS AFFAIRS IN "ORDER" - HE REPAID SOME SMALL DEBTS - HE WAS A RESIGNED, DEFLATED INDIVIDUAL FROM ALL APPEARANCES. HE SERVED NOTICE TO LEAVE HIS JOB, DROVE 46 MILES IN ONCE INSTANCE TO REPAY A \$10.00 DEBT TO A PARTY WHO HATED HALL AND STATED "HE WAS" WORTH THE TEN." I COULDN'T, AT THAT TIME, UNDERSTAND WHY GARRISON DIDN'T INVOLVE HALL IN THE SHAW TRIAL. HALL KNEW SHAW, POSITIVE. IT REMAINS A MYSTERY TO ME, AS GARRISON NOR HIS OFFICE FELT IT WORTHWHILE TO INFORM ME OF THEIR FINDINGS ON HALL. SO BE IT.
