

FBI HQ Sanitation Workers files # 157-9146 Serials X-X16, 93 pp.

X is dated 2/16/68, 4 days after strike began. 170 of 1100 remained at work. Union negotiators identified as P.J.Ciampa and William Lucy of Washington and "Joseph Paisley, international organizer assigned to Tennessee." X is mps TT. X1 is LHM 2/16/7/68. 214 worked <sup>in</sup> streets and drains division and at its asphalt plant joined strike. Pay demands from \$1.80 hr. to \$2.35, for crew chiefs and truck drivers from \$2.10 to \$3.00 hr. P.2 has Paisley "currently " assigned to Tenn.

by 2/20,, X3, the FBI wa trying to make a Communist deal out of it beginning with reports that a Memphis State instructor and his wife, white, led a peaceful vigil.

X10, 2/26/68 LHM, one agent, Lawrence, drew information from nine obliterated sources. Reports exposure of undercover MPD policeman, at meeting but not hurt. Lawrence = Wm. H. Second volume, serials X17-X44, 153 pp. X40 last of X, followed by 1,2,3,4.

X20-Helloman went to court to get phoney jaywalking charges against two black photographers killed. Said it was a mistake and should be admitted, that they had done no wrong. X25-the two cops suspended for making phoney arrests.

X40, 3/1/68, followed in sequence by 157-9146-1, dated 4/17/68, skipping assassination, etc. They started numbered serial designations after the strike was settled.

Pt. 3, serials 5-45 200 pp.

5 is dated 4/5/68. It is an account of the violence in Memphis following the assassination. It gives no account of the property damage but lists 80 arrests and 28 injuries.

8 On April 5 about 200 black and white clergymen marched to city hall to ask Loeb to end strike. Restraining order of 4/3 against 4/8 march rescinded by Judge Bailey Brown.

9 has indications of agent or eesur on <sup>ing</sup>, quoting "extremely reliable source." Also Lt. Arkin's source, apparently McCullough.

15 For the march of 4/8 the FBI had 19 SA's observing the march, in addition to all the other protection.

22 Joe ~~Kirk~~ Paisley not mentioned as negotiator of 4/12.(p.2)

The serials are not numbered chronologically. At the end there are serials that belong earlier, before the 3/28 disturbances and of it.

47-account of his getting to Rivermont. I.e., King et al. Vicious Memphis reporting followed by dirtiness at HQ.

50= 17 numbered pp, 3/30/68.

69 dated 4/3 lists Paisley as still there.

73 quotes Lt. Arkin as placing the time of shot at 6:04.

74 lists 21 different "emphis filed for this 4/5 20pp report. 6 are new files in 157.
