8:45 PM - At 1031 No. Watkins #3 WILLIE BELL met  
SOURCE outside.

"WE THE PEOPLE" is supposed to be a four page  
publication but they only have two pages because they ran  
out of paper and ink. PEARL JONES and PEGGY VITTITOW have  
a typewriter and mimeograph machine at their house and are  
typing and printing this publication. WILLIE BELL, KELLEY  
DELANEY and TREZEVANT CARTER are doing the writing.

11:00 PM SOURCE arrived at 1031 No. Watkins #3.  
Those present were:

MOORE is running with MICHAEL STARKS but is seen  
more with JOHN C. SMITH and MAURICE LEWIS.

MAURICE stated that he had been to Nashville trying  
to close down the colleges and had just got back.

WILLIE BELL, JOHN C. SMITH, MAURICE LEWIS and TYRANT  
MOORE were smoking marijuana. MICHAEL STARKS was upstairs.

11:30 PM JOHN SMITH, MAURICE LEWIS and TYRANT MOORE  
left 1031 No. Watkins #3. WILLIE BELL, DONALD PIGFORD, TONI  
VANDERBILT and MICHAEL STARKS were still there.

VISTA

12:00 Midnight BELL and [REDACTED]  
[REDACTED] BELL said that they all know that VISTA  
is being investigation for using the government's cars while  
associating with WINE. JANE WREDE drove one of the VISTA cars  
over here (1031 No. Watkins) Monday (May 18) to pick-up WILLIE  
BELL and MICHAEL STARKS. BELL said the reason he knows this  
is because the police in Arkansas have been stopping them.

RE: FOR MAR 21, 1970

BELL said that the telephone was put in WINE's apartment by PEGGY VITTITOW's request and that she pays the bill.

BELL wanted to go to PEARL JONES and PEGGY VITTITOW's house to get some money. He was high on marijuana while there. He took PEGGY VITTITOW into the back room. BELL then had \$5.00.

PEARL JONES gave WINE his television set. She said that she might have to take it back.

BELL was on the floor rolling over and over, he was very high.

They will ask for a 10¢ donation for "WE THE PEOPLE".
