It was concluded that the hand printing appearing on Q349 was not prepared by James Earl Ray, K171, K211 and K257. Differences were noted between the handwriting appearing on Q350 and the known handwriting of Ray, but because of the distorted nature of the questioned material on Q350 a definite opinion could not be reached.
