Dear Flo,

Glad to get the mailing of literature, which I will redistribute, especially on the arms cache (an area in which I have done much work), and your notes on it. But, before responding, a protest: What kind of women's liberation is it to describe a breast as a boob (Pac-O-Lies, p.5)? Or is there something wrong with my thinking and this is not demeaning, in attitude or expression?

In your note you say "I'm sorry Bill <sup>B</sup>unstler fell through" and you explain that he is busy. Understood. But in his not ever writing to tell me he could not or would not do anything I find cause for complaint I do not make. My real complaint is that in not seeing me, in not trying to learn any of what I know, he hurt his clients, who he would have been in a better position to serve. I am aware of his principles, regard him as an honorable man, believe he upholds the best tradition of the law and all that. I am also older than he and I put in a day every day he does not, so I know also how it is to be busy. To a degree I have been able to rectify this through contact with another lawyer who apparently has intentions of using some of this material in the defense of his (similar) clients.

Dear Flo, there are none so blind as those who will not see.

Another note, "I wish I could help more". I'm sure if the means suggested themselves you would try. But may I also suggest that it is I trying to help you? You are latched to the work I described to you going on two years ago. I have done an enormous work since then. I will not try and summarize more than a third of a million words. But I believe it is a very important work for you and what you symbolize and stand for. It further has immediate importance in current struggles, and in general does an essential job on the worst enemy we all have. If you are going to Washington to the NEC conference next month, please be my guest and look at some of this. You can stay here, but an hour away. It sometimes takes longer to go from place to place in New York. I appreciate the complement in this note (and generis), but to make a bad pun, I should not be so alone. And if I understand what you mean by "Compare justice for white swans with that for Black Panthers", dear friend, this is what I have done, before it happened and while it was happening, accurately foreseeing it. If for no other reasons, on just this point, what has not happened to whites with arms and what has happened to black from these arms and because they sought to defend themselves, which is collateral, I have done a rather large and convincing job of documentation, and in what I believe is the proper context. I had it out in this book more than a year ago.

Mark Reskin suffered the same illusion about John Simon until he spoke to him. "We will not touch any aspect of this subject. Nor will RA. There is now a great pressure of time. People are being hurt now. Evil forces are getting stronger now, must be fought now. I believe an immediate private printing, which can be available two weeks after it can be paid for, is the only answer, and it seems impossible (although I think it would be profitable)...I don't know if I am now up to it, but although they have been asked, no one, no black group, has the slightest interest in hearing about black assassinations. So, all lemmings are not white. Thanks for the kind thoughts and good luck.

# Probers Seek Arms Cache Link

Investigators were attempting to determine yesterday if a link existed between an ultra-right wing group—the American Minute Men — and a cache of military weapons

and ordnance that was uncovered in a raid Thursday at a West Bridgewater home.

One federal investigator said, "We have found that most often ultra-right wing groups are the ones who have possession of these weapons."

Uncovered in the seizure, which yielded two truckloads of arms and explosives, were two anti-tank guns, five machine guns, several sub-machine guns, an M-16 rifle, land mines, hand grenades, a number of pistols and revolvers, molotov cocktails, an 81 mm mortar shell and several thousand rounds of ammunition.

**THE OCCUPANTS** of the home, Mr. and Mrs. Ralph E. Swan, of 11 Ellis Ave., were in Connecticut at the bedside of their son, Richard E., 29, who was critically injured in an automobile accident Friday night.

Federal investigators had raided Swan's apartment in Connecticut on Tuesday after local authorities had found arms in his car following the accident Friday night.

Swan is employed by the Firearms Division of Colt Industries, Inc., in Hartford.

The raid on the Swan home in Bridgewater followed a long

investigation by State Police Sgt. Paul O'Brien. He said someone had brought a hand grenade to his home and had said, "This is the type of thing being passed around down here."  
The informant also mentioned a "militant far-right wing group," O'Brien said.

**ARMED WITH** a warrant issued by U.S. Commr. Robert Popeo to search for "contraband firearms," federal agents, Sgt. O'Brien and explosive experts from the Army at Ft. Devens uncovered the arms and explosives in the cellar and an upstairs bedroom of the house.

Also found in the house was an organization membership card with the initials A.M.M., reportedly the designation for the American Minute Men group.

The detail from Ft. Devens deactivated many of the explosive devices before they were taken from the dwelling.

An unidentified woman found in the house during the raid was not arrested. However, authorities said several arrests were expected for violations of the 1968 Federal Gun Control Act.
