SYNOPSIS

Subject is not of record in criminal or civil files of FBI.

DETAILS OF INVESTIGATION

Reference: Previous memoranda, and in particular to M/R of SA Sheaks dated Los Angeles, 3/5/64.

Fingerprint chart of Josephine Patricia Kelly, signed in the name of Josephine Patricia Kennedy, was furnished 3/18/64, to the Identification Division, Federal Bureau of Investigation, with request that they furnish three copies of any record on this individual.

Subsequently, on 3/24/64, fingerprint chart of subject was returned by the Federal Bureau of Investigation, with advice that subject had no arrest record.

On 3/27/64, SAIC Geiglein requested advice as to the status of this investigation and advised that Inspector Peterson, Chief's Office, had made inquiry. When informed that FBI had no criminal record for subject, SAIC Geiglein directed that the fingerprint chart be returned to the Federal Bureau of Investigation and that it be determined whether or not subject was of record in the civil files of that agency.

The fingerprint chart of subject was returned via SA Paraschos to the Federal Bureau of Investigation, on 3/27/64, and later on the same date, Miss Louise Oakes of the Identification Division, of that agency, telephonically advised that their civil files were likewise negative with respect to subject.
